ABSTRACT

Fordiseases with more than one risk factor, the sum of probabilistic estimates of t henumberof cases attributable to each individual factor may exceed the total number of cases attributable to each individual factor may exceed the total number of cases at the total number of total numbesesobserved. especiallywhenuncertaintiesaboutexposureanddose-responseforsomeriskfact orsishigh.In thisstudyweoutlineamethodtoboundthefractionoflungcancerfatalities *not*attributedto specificwell-studiedcauses.Suchinformationservesasa"realitychec k"forattributional studiesoftheminorriskfactors, and, assuch, complements the traditional risk ana lysis.With lungcancerasourexample, weattributeportions of the observed lungcancermorta litytoknown causes(suchassmoking,residentialradon,andasbestosfibers)anddescribe theuncertainty surroundingthoseestimates. The interactions among the risk factors are al soquantified,tothe extentpossible.Wetheninferanupperboundontheresidualriskdueto"other"causes,us inga coherence constraint on the total number of deaths, the maximum uncertainty principle ,andthe mathematicsofimpreciseprobabilities.

1.INTRODUCTION

Thefamiliar"front-to-back"procedureforcalculatingdiseaseormortal ityriskfrom exposuretoenvironmentalcontaminants(whichinvolvesestimatingtoxicreleases environmentalandphysiologicaltransformations,andemployingexposuremodelsa responsefunctions)worksbestwhentherelevantscienceiswelldeveloped.Howeve r,when thereareseveralriskfactorsandtheuncertaintyaboutsomeofthemislarge,suc canleadtoestimatesforthenumbersofcasesattributabletothevariousfact orsthat,summed, exceedthetotalnumberofcasesactuallyobserved.

Morganarguedthatmethodsofboundinganalysiscouldbeusedinenvironmentalrisk analysistoavoidsuchabsurdities, because, for health endpoints with multiple exte rnalcauses, ks.⁽¹⁾Ifmost theavailableknowledgeconstrainsthemagnitudeofthepoorlycharacterizedris riskswereknownwithprecision,thiswouldbeasimplesubtractionproblem.Howeverdise ase risksfromenvironmentalcausesareoftenestimatedfrommodelsorinferredfrom studies involvinglimitednumbersofsubjectsandinconsistentnotionsofcontrolsorhaveother methodologicalproblemsthatcontributetotheuncertaintyoftheresults. It is commontosee eventhecentraltendencies of such riskes timates expressed as ranges, espe ciallywhenthereare competingplausiblemodels.Despitethisuncertainty,oftenthereisagreementi ntheliterature concerningthegeneralmagnitudeoftheimpactsofthebest-studiedcauses. How toquantifyand boundtheresidualrisk, inlight of the uncertainty surrounding the relatively wellc haracterized risks, is the subject of this paper.

Usinglungcancermortalityasacasestudy,thegoalofouranalysisis togeneratean upperboundonthemortalityattributedtothegroupofpoorlycharacterizedfactors.Lun gcancer (includingcancersofthetracheaandbronchus)isthesecondmostcommoncancerforbo thmen andwomen, interms of incidence (afterbreast cancer inwomen and prostate cance rinmen), but is the leading cause of cancer death in the United States. ⁽²⁾ Lung cancer accounts for about 30% of all male cancer deaths and 25% of all female cancer deaths (Table I).

ThedeathrateamongtheUSciviliannoninstitutionalizedresidentpopulationfrom malignantneoplasmsofthetrachea,bronchus,andlungintheyear2000isestimatedt obe56.5 per100,000(ICD-10definition),basedondeathcertificatereporting.

In2000,thecrudelungcancerdeathrate(notage-adjusted)amongmenofallagesw as 67.2per100,000,andamongwomen,46.3per100,000.NCHSestimatesthatbetterthan99.3% ofalldeathcertificatesnation-widewereincludedinthecalculationofthese rates.

SomeofthemajorenvironmentalriskfactorsforlungcancerareshowninTableI I.In ourmethod,theobservedannuallungcancermortalityisattributedstatistical lytothemajor causesoflungcancer(smoking,radonandasbestos).Inthispaperweuseliterat thismethodiswellsuitedforexpertelicitation,aswell,whichisplannedasf urtherwork. Informationabouttherisksfromunspecifiedcausesistheninferredusingacohere onthetotalnumberofdeaths,andaprinciplewetermmaximumuncertainty.

OurmethodbuildsupontheworkofWalley. ⁽⁵⁾Mathematically,thisisanapplicationof Smets'TransferableBeliefModel ⁽⁶⁾,whichoffersaconvenientmathematicalframeworkfor implementingtheShaferTheoryofEvidence ⁽⁷⁾usingmatrices.Werepresentourunderstanding oftheimpactsofafinitesetofriskfactorsforlungcancermortalitya sconstraintsonalinear programmingprobleminvolvingaconvexfamilyofprobabilities.Wetheninvokethemaxim um unspecificitycriterioninordertoestimatetheupperboundforthelesswell-st udiedmembersof theset.

2.MATHEMATICALTHEORY

Let Ndenotethemagnitudeofthehealthend-point, in this case, the total annual number of lung cancerdeaths. Let Ω denote the set of all possible causes of lung cancerdeaths. For example, $\Omega = \{ C, R, A, X \}$ where C means exposure tota baccosmoke primarily from cigarettes (we combine active, passive, and former smoking), R means indoor exposure to radon, A means as best os, and X is the group of all other more poorly understood environmental factors of interest.

WeassumethatNisreadilyobservableandthereforeknownwithprecision.Whilethisisnotstrictlytrueinthecaseoflungcancer $^{(8)}$,theassumptionisnotlimiting,sincetheresultsofthemethodcanbestatedinpercentagetermsandthenappliedtoarangeofpossiblenumericalvaluesofN.Wealsoassumeexposuretobebinary,whichisofcoursenottrue,buttheassumptionisconsistentwiththeexposuredefinitionsusedinthesupportingepidemiologicalstudies.Withthesetwoassumptions,eachdeathcanbelinkedtozeroormorepossiblecausesin Ω .Synergisticcases,inwhichmorethanonecauseisinvolved,areallowed.

Figure1showsonewaytosubdivide Nbycausesthatincludessynergisticeffects.We denote the number of deaths linked to cause sas n(s), where sisany subset of Ω . In our example we consider four possible causes in Ω , so the recould be sixteen (2^{-4}) possible s, but to simplify the analysis and to be consistent with the lung cancer literature, we will consistent with the unger cancer literature. Toadoptamorepreciseand cautious definition, n(s) is the number of cases not exposed topollutants not in s. This implies that causes not in lung cancer. 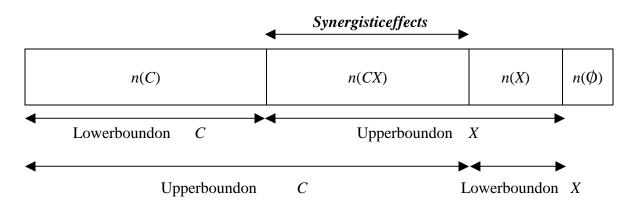

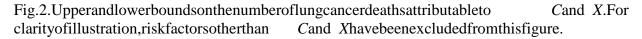
Onthe right, the full set $n(\Omega)$ (as hort notation for n(CRAX)) corresponds to the situation when no cause of lung cancer has been excluded because either all risk factors have been observed to be present, or the reisnoin formation about risk factor exposure.

The basic statistic *n* can be used to bound the number of cases a stributable to smoking *C* as follows, where $\overline{n}(C)$ and $\underline{n}(C)$ denote the upper and lower bound son n(C), respectively:

Inepidemiologists'terms, the attributable fraction of cause C, for example, is the proportion of all cases that could be avoided if exposure to C were eliminated, denoted af(C). The model suggests the following bounds for smoking attributable fraction:

where r_0 is the background rate of lung cancer mortality. This background rate is the number of lung cancer deaths in the unexposed population divided by the unexposed population. The lower

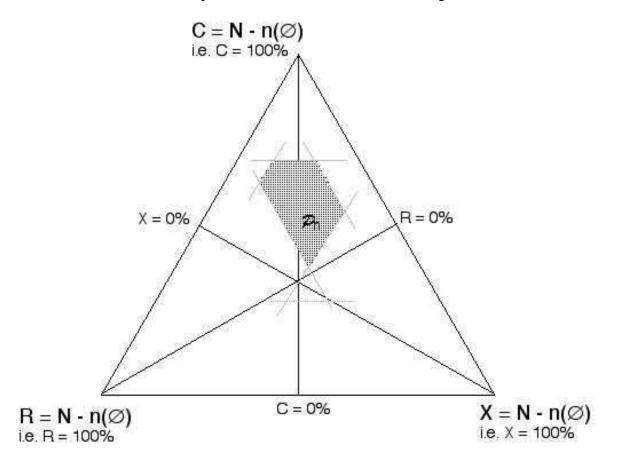


Fig.3.Graphical representation of the set of all interaction-free π compatible with a specific, n defined on C, R, and X.

Considernow the bounds on death sattributed to multiple synergistic causes. Denote these causes as s, a subset of Ω , for example s = CR. For the lower bound on the number of death sattributable to these causes acting jointly, we continue to adopt the number of cases exposed only to these causes, that is:

This \overline{n} corresponds to the commonality function in the Transferable Belief Model ⁽⁹⁾. Boundson the attributable fraction can be computed as in Equation 1.

Onemeasureoftheinformationcontainedin *n*isitsunspecificity.Considerthesetwo(ofthe three)extremecases:

- If each death we reattributed to exactly one cause, then there would be no uncertai and allower bounds would coincide with their upper counterpart. We would have $n(R) + n(A) + n(X) = N n(\emptyset)$. Note that since n is a positive function that sums up to N, this implies that n(s) = 0 for all the subsets with 20 rm or evelopments.
- If noinformation ause of cancer we reavailable, each death would be attributed to the synergy of all factors. Mathematically, this is $n(\Omega) = N$. Note that this constitutes a proper uninformative distribution: it is not the Bayesian uniform prior probability distribution Ω . Rather, it is the family of all probability distributions that can be defined on Ω .

Unspecificity is a numeric indicator that equals one in the first case, and in the second case equals the number of elements of Ω . It is the expected value of the number of elements of swith respect to the probability distribution $m(s) = \frac{n(s)}{N}$, that is:

In this paper unspecificity is a kind of generalized cardinality that specifies esthenumber of alternatives. The reason for using this word is that when a death is attributed to the synergy of k factors, it can be said that the unspecificity of this information is k. See Rocha (1997) for an extensive discussion of this concept (10).

Alowerunspecificitymeasurecorrespondstobetterinformation, soathirdextr emecase needsdiscussion: unspecificity is zerowhen and onlywhen $n(\phi) = N$. In this case, all non-spontaneous causes of Ω have been positively excluded. It means that all the substances in Ω are actually safe (with respect to lung cancer). This is the highest level of information achievable, to the point that it makes Ω irrelevant.

Notehowthis interpretation hinges on the idea of counting missing data with is an application of a general principle of maximum uncertainty, also known as La principle of "raison in suffisante". The principle states that one should select the themostum specific, compatible with existing information. This is the principle that is twe use in the next section to estimate the bound son the unknown cause, given information about all others.

Quantitativeorcomparativestatements regardingthelikelymagnitudeof n(s) can be interpretedaslinear constraints on n. These constraints determineaset B of basic statistics. The most unspecific n in B is chosen according to the maximum uncertainty principle. This amounts to solving a linear program in a space with 2 $|_{\Omega}$ dimensions, for which we impose these additional constraints:

- All *n*(*s*)arenon-negative, summingupto *N*.
- Three-way interactions and high erare not allowed. That is, n(s)=0 if shas 3 or more elements.

Toensurethatasolutionexists, we impose the condition of coherence on the *apriori* attribution:

If exposure probabilities are known or assumed, it is possible to also bound there lativerisk of s, rr(s). The definition of the relativerisk of dying of lung cancer from smoking cigarettesrr(C), for example, is the lung cancer rate associated with exposure to to baccosmoked ivided bythe lung cancer rate among non-smokers. Given exposure probabilities in the general population,we will assess the bound son the relativerisk for the various pollutant susing the following

where p_s is the exposure to causes. The same relationshipholds for the lower bound.

Thispaper'snumerical simulations were performed using a Mathematican otebook ¹. The code directly implements matrix calculus for belief functions as outlined in Sme ts(2001) ⁽⁶⁾. This is the most straightforward method given that Ω remains small, but it would not scale well to tenso f carcinogens, since it involves square matrices with 2 ^{2|\Omega|} elements. For example, 10 pollutant simplies storing in memory arrays with 10 ⁶ numbers.

3. APRIORI ATTRIBUTIONOFLUNGCANCERRISK

Inourillustration Ω , these to fpossible causes of lung cancer, consists of *C*, active and passive smoking; *R*, domestic exposure to radon; *A*, occupational exposure to inhale dasbestos; and *X*, the group of all other environmental risk factors.

Thattobaccosmokingisthesinglemostimportantcauseoflungcancer,hasbeen understoodformorethan60years ⁽¹¹⁾.Forexample,a1983surveyconductedbytheWorld HealthOrganizationof160activemembersoftheInternationalAssociationfor theStudyof LungCancerfoundthat97% oftherespondentsagreedthatatleast80% ofalllungcan cercases werecausedbytobacco. ⁽¹²⁾About98% ofEuropeanandU.S.malelungcancerpatientswere "ever-smokers" (personswhohadsmokedmorethan100cigarettesintheirlifeti me)aswere 70% to90% ofthewomenlungcancerpatients. ⁽¹³⁾Lungcancermortalityratesareabout23 timeshigherforcurrentmalesmokersand12timeshigherforcurrentfemale smokersthanfor neversmokers. ⁽²⁾Forpeoplehavingsmokedmorethan100cigarettesintheirlifetimes,the relativeriskofdyingoflungcanceris10to15.

Thesmokingattributablefraction(SAF)ofcancersofthelung,trachea,andbron chus (ICD-9code162)averagedovertheyears1995-1999wascalculatedbytheCDCusingt heir SAMMECsoftware ⁽¹⁴⁾.TheseestimateswerederivedfromrelativerisksfromtheAmerican CancerSociety'sCancerPreventionStudyII,CPS-II:1982-1988 ⁽¹⁵⁾andcurrentandformer cigarettesmokingprevalence ⁽¹⁶⁾fortwoagecohorts:personsaged35to64yearsandthoseaged 65years,accordingtothisformula:

where p_0 is the percentage of persons who have never smoked 100 or more cigarettes, p_1 is the percentage of persons who haves moked 100 or more cigarettes and smoke every day or some days, and p_2 is the percentage of persons who haves moked more than 100 cigarettes but have stopped smoking. TheCDCnotedthatthesefigureshavesomelimitations.

- SAMfigureswerederivedfromsmokingratesin1999whentheactualsmoking attributabledeathsweretheresultofsmokinginpreviousdecades,whensmokingrat es werehigher.Duringperiodswheresmokingprevalenceisdeclining,theattr ibutable fractionmethodologywilltendtounderstatethenumberofdeathscausedbysmoking .
 Smokingiscurrentlydecliningbyabout1% ayearandbetween1993and1999,smoking prevalenceamongadultsdeclinedby25%.
- RelativeRiskswereadjustedfortheeffectsofagebutnotforotherpotential confounders.Thismaynotbealargeproblem,asCPS-IIdatashowedthateducatio n, alcohol,andotherconfoundershadnegligibleadditionalimpactonSAMestimatesfor lungcancer ^(19,20).
- Deathsattributabletocigarandpipesmokingandsmokelesstobaccousewerenot included.
- Although the CPS-II cohort includes over 1.2 million men and women, it is somewhat more white and middle class than the U.S. population as a whole.

Givenboththeoverwhelmingevidenceoftheimportanceofthisriskfactorandthepot ential forunderestimationbiasinthecalculationofitscontributiontooverallrisk,forthisc alculation weassumethelowerboundonattributableriskduetosmokingtobe70% and the upperbound, 95%.

ProbablythesecondmostimportantriskfactorforlungcancerintheU.S.isradon, whichisagasemittedfromthesoil,fromwaterandfrombuildingmaterials,tha tcanbecome concentratedinhomes.Onceinhaledintohumanlungs,radioactivedecayofradonandits radioactivedaughtersresultsintheexposureoflungcellstoalphaparticles,w hichcandamage DNAbyionization.Onthebasisofstudiesofhealtheffectsinuraniumandotherundergro und minerswhoworkedinradon-richenvironments,andbacked-upbyanimalexposureandhuman epidemiologicalstudies,radioactiveradonprogenyhavebeenidentifiedasaca useoflung cancerinhumans.

The annual number of lung cancers in the U.S. caused by residential radon exposure was a structure of the structure of theS estimatedintheBIERVIstudy(BiologicalEffectsofIonizingRadiation) conductedbythe NationalResearchCouncil ⁽²¹⁾.Thiscommitteechosetousemathematicalmodels(ratherthan populationstudies), because epidemiological case-control studies of lung cancerdue to residentialradonhavenotproducedclearresults. This failure was attributed t oanumberof reasons.Theriskappearstobeverysmall,andtheexposuresencounteredinmosthomesare low.Itisdifficulttoestimateradonexposuresthatpeoplehavereceivedoverthei rlifetimes. Also, manymorelung cancers are caused by smoking than by radon and there is strong evidence forasynergisticinteractionbetweensmokingandradon.

TheNRCcommitteeconstructedtwopreferredmodels, bothbasedoninformation fro m 11 majorstudies of lung cancer in under ground miners together involving 68,000 men with 2,700lungcancerfatalities. ⁽²²⁾Sinceradonlevelsinthemineswereingeneralmanytimesthe levelsfoundinmosthomes, the assumption was made that risk decreases linearly wit hexposure and there is not hreshold. There we reother problems with this approach, as well. Almost allof theminersweremen, they inhaled dust and other pollutants in themines, and most were smokers.

TheNRCcommitteeassumedasubmultiplicativeinteraction(morethanadditiv ebutless thanmultiplicative)betweencigarettesmokingandradonexposure,consistentwi thdatafrom theminerstudies. Another important modeling assumption was that the physical and bio logic differencesbetweenthecircumstancesofexposuresofmaleminersworki ngundergroundandof men, women, and children in their homes lead to the same doses at the same exposures. The committeeusedlungcancermortalitydatafrom1985-1989andsmokingprevalence(everand neversmoked)estimatesfor1993.BasedontheNationalResidentialRadonSurvey,alo gnormal $^{-3}(0.67 \text{pCiL}^{-1})$ and a distribution for residential radon concentration with a median of 24.3 Bqm ⁽²³⁾. The attributable risk was calculated for the geometricstandarddeviationof3.1wasassumed entireUSpopulationandformalesandfemalesandever-smokersandnever-smoke rs(TableIV) as10%to15%ofthetotallungcancermortality(theircentralestimates)wi tha95% confidence intervalof2% to21%. The authors of BIER VI could not find are a sont oprefereither the Exposure-Age-ConcentrationModelortheExposure-Age-DurationModeloftheeffect sof residentialexposuretoradononlungcancersotheypresentedtheresultsofbothmodels. Consistent with their preference, we adopt the upper and lower bound of the Constant Relat ive RiskModel.

Inourjudgment, the third most important cause of lung cancerisin haled as best os fibe rs. Asbestosreferstoagroupof6naturallyoccurringfibroussilicateminerals ,chrysotile,amosite, crocidolite,tremoliteasbestos,anthophylliteasbestos,andactinoliteasbes tos.Thesemineralsare

Occupational exposure to chrysotile, amosite, anthophyllite, and mixtures containing crocidolite has resulted in elevated incidence of lung carcinomas. M esotheliomas have been associated with occupational exposure to crocidolite, amosite, and chrysotil e. (25,26) As best os-related medical conditions can occur 15 to 40 years after exposure.$

Before the 1970s, an estimated 27 million American workers in high-risk occupations were exposed to a sbest os and an unknown number of workers were exposed in other occupations. The U.S. Department of Laborestimates that currently 1.3 million employyees could be exposed to a sbest os on the job ⁽²⁷⁾. Workers in the construction industry face the biggest risk of exposure, particularly in the removal of as best os during renovation or demolit ion of old buildings and there pair of ships. Employees can also be exposed to fibers during the manufacture of as best os products (such as textiles, friction products, insulation, and ot her building materials) and during automotive brake and clutch repair work.

WiththepassageoftheOccupationalSafetyandHealthActin1970,increasingly strict asbestosexposureregulationswereadopted.TheEPAproposedabanonallusesofasbesto sin 1986,buttheproposedbanwasoverturnedonappeal ⁽²⁸⁾.However,someasbestoscontaining materialsweresuccessfullybanned,andnonewusesinproductsthathadnothistorical ly containedasbestosareallowed.Acombinationoflegislation,largeclass-act ionsuits,andstrong publicoppositiontoasbestosresultedinthereductionofasbestosconsumptionfromitspeaka t 803,000metrictonsin1973to13,100metrictonsin2001 ^(29,30).Asbestosuseispresentlylimited primarilytoroofingproducts(61%),gaskets(19%),andautomobileclutch,breakand transmissioncomponents(13%) ⁽³¹⁾.

In 1982 Nicholson et al. estimated that in the year 2000 there would be 9,700 work place as best os related lung cancer deaths per year (about 6% of all lung cancer s), based on occupational as best os exposures from 1940-1979 ⁽³²⁾. This is not directly verifiable, because statistics on as best os-related lung cancer are not collected. However, the Ce nters for Disease Control and Prevention collect death certificated at a conther as best os related di seases ⁽³⁾ (as best os is and malignant mesothelioma – the latter condition is 70 to 90% associat ed with as best os exposure). In 1999 there were 2,343 reported mesothelioma deaths, and in 2000, 2,384 These figures, combined with the ratio of mesotheliom at olung cancer mortality in as best os exposed populations, can be used to estimate the number of as best os-related lung cancers.

Inareviewofasbestos-relatedlawsuitsfrom1991through2000,representingover 600,000individualclaimants²,theRANDInstituteforCivilJusticefoundthat3%ofthese claimsconcernedmesothelioma,7%lungcancerand89%nonmalignantdisease⁽³³⁾suggesting thattheratiobetweenlungcancerandmesotheliomainasbestosworkersis7to3(2.33to⁽¹⁾)if

allaffectedpartiessued ³.Someofthemesotheliomaswerenotcausedbyasbestos,somethe lungcancerswereprobablyduetofactorssuchassmoking,andtherewasprobablysome diagnosiserror.However,weusethisratiotocalculatethattherewere<5,560oc cupational asbestosrelatedlungcancersin2000,representing<3.5% of the 159,000 lungcancer deaths of 2000.

Thisiscompatible with otherestimates that attributes 5to 25% of lung cancerm ortality to the effects of alloc cupational carcinogenic exposures combined, coupled with estimat to 20% of occupational lung cancers are due as best osex posure (which would attribute 1 to 5% of total lung cancer to as best os). ⁽³⁵⁻⁴⁰⁾ It is also compatible with the year 2000 population attributable lung cancer plus mesotheliomarisk for as best os of 5% calculated f or Denmark, Finland, Iceland, Norway, and Sweden ⁽³⁸⁾.

Summarizing3studiespublishedbetween1968and1982,KooandHoreportedthatthe lungcancerrateamongnon-smokingU.S.femalesaged40-74was5.8to7.5per100,000 ⁽¹³⁾. Theseratesarenotcorrectedforpassivesmoking.

Some of the deaths in the secohorts presumably occurred spontaneously (without exposure to radon or environmental to baccosmoke) so we can claim that the serates resent the impact of background occurrence*plus*radon and perhaps other carcinogenex posures.

If there were no other lung cancerrisks than rad on exposure in the sepopulations and the relativerisk for rad on exposure were 1.2 to 1.5, the background "rad on free" rate of lung cancer from an observed mortality of 4 per 100,000, would be 3.3 to 3.6 lung cancer death sper 100,000.⁽²¹⁾

This result attributes between 0% and 3% of lung cancer deaths to X, the group of unknown environmental pollutants. Theyestimatedthatdieselwillbe responsiblefor 125, 110 cancers for all metropolitan and non-metropolitan areasofthe U.S . (over 70 year lifetimes) for an annual rate of 1, 787 cancers. This figure is bel ow 3% (4, 716 deaths) of the projected 2003 lung cancer mortality rate of 157, 200 ⁽²⁾, even without adjusting for the non-lung cancer mortality in herent in their risk estimate, and therefore, to fi rstorder, would passour plausibility test.

6.CONCLUSION

Inthispaperwehaveapplied the Smets' Transferable Belief Model to estim ateanupper boundonthefractionoflungcancerscausedannuallybythegroupofcausesforwhich comprehensivelongitudinalstudiesarelacking.Sucharesultisinterestingfrom arisk managementperspective.Forexampleitmightbeusedtoinferthelevelofcont roleffortthese pollutantsdeserve. Theboundingwasaccomplishedbyattributingaportionoftheobservedcancerstothre e knowncauses, smoking, radon, and as best os, and then deducing information about the residual iedtoboundrisk usingmaximumunspecificity. The procedure illustrated here can be readily appl factors for a variety of other health impacts and environmental pollutants. The criticalaspectsof thisprocedureare: 1. Uncertaintyintheknowncausesisexplicitlystated, using statementsonupper andlower bounds. 2. Synergisticeffectsintheknowncausesarepartoftheframework. 3. Consistencybetweenknowncausesandpoorlyunderstoodagentsisrequired.

Theboundingmethodologypresented in this paper is a menable both philosophically and mathematically to coupling with expertelicitation of *apriori* risk attributions ⁽⁴⁶⁾, as et of such elicitations is planned for the next phase of this research. We also plant of urther develop the mathematical treatment to remove the constraint on the number of the interaction terms.
