Industrial activities and primary schooling in early nineteenth-century France

Abstract

This article investigates the relation between industrial activities and the expansion of primary instruction in early nineteenth-century France. To do so, I use a newly constituted database on the location and characteristics of primary schools at the level of municipalities. This database is extracted from the Guizot Survey conducted in 1833, before the implementation of the first national law making the opening of a school mandatory in any municipality more than 500 inhabitants. By using mineral deposits as an instrument, I first show that the presence of industrial activities and the level of industrial production in a given municipality were positively influencing the presence of primary schools. Second, I show that this was due to an income effect thanks to which municipalities were capable of attracting teachers and of more frequently paying them on a regular basis. Other economic factors, as the agricultural resources of districts, and geographical or demographical factors as population dispersion were also important in explaining the location of primary schools. Finally, I show that this came at a price in terms of children enrolment in schools. The same economic factors were contributing to a diversion of children from schools, either because of a relative impoverishment of workers or because of an increased opportunity cost of schooling.

1 Introduction

There exists a long-lasting debate in economic history about the effects of economic activities, and especially industry, on literacy. It is argued, in the British case, for example, that early industrialisation and the progressive introduction of large-scale factories using steam-power were mainly skill-saving. They favoured the development of low-skilled jobs, or the fall in semi-skilled blue-collar jobs such as weavers, shoemakers or tailors [de Pleijt and Weisdorf, 2014], possibly diminishing the demand for instruction and literacy rate in England too [de Pleijt, 2018]. This comes under the name of the "deskilling hypothesis" [Sanderson, 1972], [Nicholas and Nicholas, 1992]. The same observation is made on the level and growth of secondary instruction in the United States [Goldin and Katz, 1997]. This negative effect of industrial activities on literacy rates is also identified in the French case. In the Nord department, for example, industrial districts are found to be characterized by relatively low literacy rates compared to more agricultural ones between 1831 and 1843 [Leblond, 1970]. By the same token, the presence of a developed textile sector is correlated with less literacy in the diocese of Rouen at the end of the 18th century [Furet and Ozouf, 1977b].

This idea is greatly debated as industrialisation and technical change may also have led to a rise in the demand for some medium and high-skilled workers [Feldman and van der Beek, 2015], [de Pleijt et al., 2016], especially during its second phase [Mokyr, 2008] and therefore have had a positive impact on education¹. Moreover, in the English or French cases, it is not obvious to show that industrialisation was the very cause of a fall in literacy rate [Schofield, 1973], [Corbin, 1975], all the more since a sharp increase in this rate took place at the beginning of the nineteenth century, precisely at the time when industrial activities surged [Laqueur, 1974]. Therefore, some authors argue that large-scale factories contributed to a rise in literacy and that the counter-examples usually put forward in the literature, as Lancashire where the towns of Liverpool and Manchester were located, could be explained taking into account Irish immigration that affected negatively literacy rates [West, 1978]. To them, it seems that, even if industrialisation may have led to a proletarianisation of England's workforce, a lower bound in literacy was already attained at that time. Therefore, the demand for low-skill workers may not have greatly affected literacy as it didn't induce people previously sending their children to school to stop doing so.

In the case of France, there seems to have been a complementarity between technology and human capital. Franck and Galor, 2017, find that the number of steam engines at the department level in 1839-1847 had a strong impact on human capital in the early phase of industrialisation. A larger number of steam engines had a significant impact on the number of teachers later in the century, on the share of apprentices in the population, on the share of literate conscripts, on the number of schoolhouses and on the number of pupils enrolled in primary schools relative to the number of inhabitants. Similarly, Diebolt et al., 2017 found that the number of steam engines within departments was positively associated with literacy rates and primary schools' presence in the first part of the nineteenth century. The association became non-significant

in its second part but a positive relation emerged with adult education and superior primary schools, the level of education subsequent to primary schooling strictly speaking².

In this article, I adopt a more micro-historical approach in order to evaluate how industrial activities influenced primary schooling in early nineteenth-century France, that is to say at the beginning of French industrial area. I do so by testing the effect of the presence of industrial factories on the location of primary schools and on enrolment rates at the level of municipalities. I focus on manufactures and not on proto-industrial activities. This level of disaggregation will help to understand in concrete terms both the relationship between the two phenomena and its transmission channels. I also control for the effect of the agricultural characteristics of departmental districts³, trying both to take into account agricultural wealth and its production organization. The main objective is to have a quite exhaustive measure of the potential economic resources of towns and villages in order to see how these resources interacted with the spread and maintaining of primary schools.

I use a newly constituted database on education at the level of municipalities to answer these questions. This database is extracted from a national survey launched by French Minister of Education François Guizot in 1833, the very year he made mandatory for any municipality over 500 inhabitants to open and maintain a primary school for boys. This legislation was the first legally-binding measure on primary schooling that was nationally implemented in France. The survey, conducted in every primary school of every French municipality, provides very precise information on the characteristics of schools, teachers and municipal investment in education. Its aim was to provide reliable information on the state of primary schooling at the beginning of the century in order to evaluate which areas would have to do the major adjustments to abide by the new law. I collected the data at the municipal level for 22 departments, which amounts to 8 129 towns and villages, a primary school being located in 59.5% of them.

I test the influence of industrial activities on primary schooling first using a simple OLS framework. Indeed, the onset of industrialisation in France has been shown to be linked to uppertailed knowledge influencing positively the adoption of modern technology, this knowledge being uncorrelated with basic indicators of literacy [Squicciarini and Voigtländer, 2015]. However, at the municipal level, things could have been more complex. Manufacturers could have looked for a more docile workforce used to discipline within primary schools [Rosanvallon, 1985], [Johnson, 1970], [Mitch, 1993] or, on the contrary, could have avoided towns with schools where child labour was less abundant. Therefore, I use data on the location of ore to instrument the presence of industrial manufactures. This location was linked to mining activities which depended by definition directly on mineral deposits. Moreover, these activities could have also attracted other industrial sectors, as the production of metal objects and tools or the production of clothes, interested in benefiting from the outlet constituted by the presence of mines.

First, I show that the presence of industrial manufactures was positively and significantly correlated with the location of primary schools, both with the OLS and the IV estimations. The latter appears to be higher in magnitude than the former. This effect is, as expected, greatly due to mining activities when using the instrumental variable technique. It is also greater in magnitude for larger manufactures, namely those more than 20 workers. I secondly show that this is due to the fact that industrial activities were providing municipalities with additional economic resources. Indeed, there is a positive correlation between the presence of larger manufactures, industrial production value, industrial workers wages and the provision of a fixed salary (and the salary amount) to teachers by municipal authorities. This means that, at a time when the decision to invest in primary schooling was not yet mandatory for each municipality, the presence of industrial activities was contributing to improving both the demand for education by increasing the purchasing power of families and the supply by providing municipalities with economic resources. However, I thirdly show that this came at a cost in terms of enrolment rates. Indeed, I find a negative correlation between enrolment rates and the presence of industrial manufactures, industrial sectors whose workforce was constituted by more than 10% of children and industrial production value. This indicates that the opportunity cost of schooling was increased by the presence of factories, especially in sectors where child labour was usual. Wages were also lower in these sectors, meaning that families, who were most of the times budget constrained in early nineteenth-century France, had also to rely more on child labour.

Therefore, industrialisation didn't influence negatively the presence of primary schools and was even contributing to their maintaining within municipalities. However, there is evidence of a diversion of children from schools in towns where industrial activities were present, all the more if they were belonging to sectors employing children massively. This analysis adds to the debate about the influence of early industrialisation in two ways. First, it focuses on France, a country less studied than England for what regards the effect of industrialisation on schools. Second, thanks to data collected at the municipal level, it is possible to study very precisely the relation between primary schooling and economic activities, without having to aggregate information at the districts or departments levels.

This also adds to the understanding of the determinants of primary schools spread before the Guizot Law of 1833 in France. Apart from the presence of industrial manufactures, other economic, geographical and demographical factors also influenced primary schooling. Population dispersion was a pregnant determinant playing against the spread of primary schools, average altitude was so too but to a lesser extent. The relative number of share-croppers to self-employed farmers and the number of animals per inhabitants were also negatively correlated with educational outcomes. This is interpreted as due to an impoverishment of agricultural workers within the share-cropping production organisation and to the intensive use of children as shepherds in areas with a high number of animals. The total population was positively influencing primary schooling, along with agricultural resources measured by the market value of land.

The next section presents some historical facts about primary schooling and industrial activities from the Revolution to the Guizot Law of 1833 and helps to contextualise and to specify the study. Section 3 is a description of the data I use while Section 4 presents the research methodology adopted. Econometric results are presented in Section 5 for what regards the presence of primary schools and transmission channels are studied in Section 6. In Section 7, the influence of economic activities on enrolment rates is presented. Section 8 concludes.

2 A Differentiated Development of Primary Schooling and Industrial Activities

The Guizot Law was passed on the 28th of June 1833, making it compulsory for any municipality over 500 inhabitants to open and maintain a primary school for boys. Teachers were also to be paid on a regular basis and not less than 200 francs a year. This law is the first major step towards universal schooling undertaken in nineteenth-century France. Before 1833 the decision to open a primary school and its functioning (paying the teacher on a fixed basis or not, how much, buying books, blackboards and other pieces of furniture, providing the teacher with an accommodation or a classroom,...) was mainly made at the level of municipalities⁴. Local authorities thus played an important role, along with parents that were in most cases (except when they were on indigent lists or when the school was totally free, which was extremely rare at that time) paying schooling fees in order to make their children attend school. At the end of the day, schools could be totally funded through schooling fees, through fees and municipal grants based on taxation or totally by municipalities and therefore free of charge for parents, this latter case being the less common⁵

At the state level, many reforms took place during the French Revolution, the aim of which was to legislate on primary schooling ⁶. The major orientations of the reforms were to separate instruction from religious influences, to organise a distinct teaching for boys and for girls and to grant people with free and universal education. However, the effect of the revolutionary period on education remained small, mainly due to a lack of financial means and to the difficulty to reform instruction in an unstable political context [Mayeur, 2004]. This evolved under the Restoration as attention towards primary instruction increased. From the 29th of February 1816, a written certification of morality was made mandatory in order to be able to teach, this certification being delivered by the mayor and the parish priest. The capacities of teachers were also to be checked and a certificate composed of three different degrees, the third one

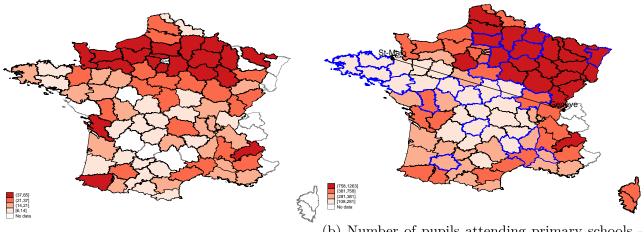

being the lowest on the hierarchy, was needed in order to teach. However, this was also rarely fully applied⁷. Indeed, examinations often took place after the nomination of teachers. If they were unable to pass the tests, authorities should have refused them the certificate and close the school, a measure which was unlikely to be implemented [Prost, 1968].

In this context, primary schooling developed differentially between regions of France. From the early work of the Dupin baron, an opposition between a well-educated France above the Saint-Malo/Geneva line and a less-educated one below this very line has been exhibited [Dupin, 1826]⁸. For example, the enrolment per 100 children six to thirteen years of age was higher above this line (a mean of 94 compared to 53), the coefficient of variation between departments being also lower above than below (30% compared to 48%). This means that enrolment was higher and more concentrated around its mean above than below the line. This was also true for the schooling of girls [Grew and Harrigan, 1991]. In Figure 1, one can see this clear distinction between French departments and its stability over time. Indeed, taking the men marriage signature rate as a proxy for literacy indicates that the geographical spread pattern of primary schooling didn't evolve much from the end of the 17^{th} century to 1833 [Allain, 1881]. Controlling by the age structure doesn't change much the results⁹. Therefore, before the Guizot Law, primary schools and high enrolment rates were mostly concentrated in the north-east part of France, even if some other regions as the Rhône Valley and the area around Bordeaux (the Gironde) were also characterized by rather good schooling levels.

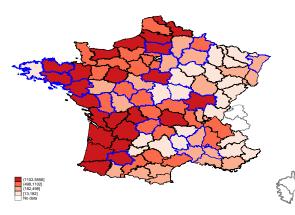

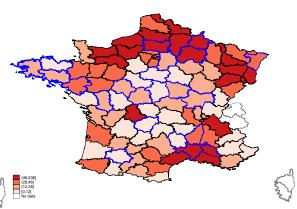

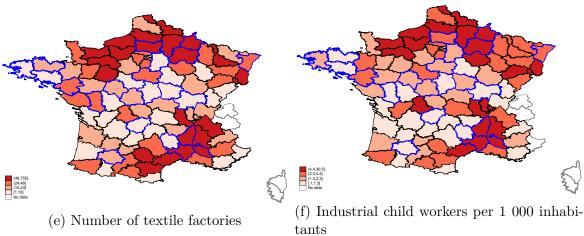


Figure 2: Industrial activities in France, 1839-1847

As reported in Figure 2, the spread and geographical distribution of industrial activities in 1839-1847 differed from the one of primary schooling. Manufactures were mostly concentrated in the north-west and western departments close to the Atlantic Ocean. This is linked to the volume of commercial activities of Atlantic ports like Le Havre, La Rochelle or Nantes which was attracting many industrial sectors to their vicinity [Asselain, 1984]. Manufactures more than 50 workers, the number of steam engines and the number of industrial workers were more concentrated in the north and north-eastern parts of France, along with the Rhône Valley. This testifies of the progressive surge of mining and metallurgic sectors in France at that time, in particular of the exploitation of coal and iron. Deposits were indeed highly concentrated in the Nord-Pas-de-Calais, Lorraine, Auvergne, Loire, Dauphiné, Provence and Cévennes areas in France. In some regions as Normandie or the Dauphiné, the concomitant presence of rivers, forests and deposits explains the ancient presence of metallurgic sectors [Léon, 1948], [Richard, 1962], [Kellenbenz, 1963]. Textile activities also followed closely this geographical pattern [Dunham, 1953].

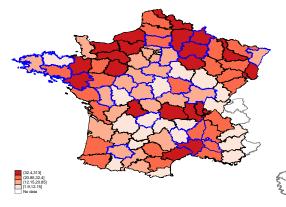
The early nineteenth century is the time period of the first industrialisation in France. Industrial production growth rates began to surge at that time, being superior to 3% for the best years from 1815 onwards [Lévy-Leboyer, 1968], the highest rates being attained at the end of the July Monarchy and under the Second Empire [Crouzet, 1970]. This growth remained however quite gradual all over the century which led some authors to deny the idea of a real industrial take-off in France [Mendels, 1972]¹⁰.

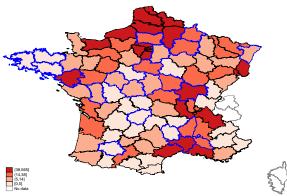


(a) Number of manufactures

(d) Number of steam engines

3 Data

3.1 Data on education

In 1833, when the Guizot Law was passed, a survey at the national level was conducted in order to evaluate the state of primary schooling in France, under the supervision of Guizot¹¹. 490 inspectors were sent throughout France in autumn 1833. The survey was conducted during September, October and November months in order to be sure that students and teachers would be present at school. All primary schools, both public and private, were to be examined. However, primary schools to which only girls were attending were excluded from the scope of the survey as the Guizot law didn't apply to them. All departments were to be inspected, except Corsica. The data are lost for three departments: Allier, Ille-et-Vilaine and the Nord. The aim of this survey was to know precisely the state of instruction in order to implement the law just passed as efficiently as possible, depending on the previous presence of primary schools¹².

Data coming from the Guizot Survey of 1833 was published for all French districts in a *Report* to the King [Guizot, 1834]. Only some of the questions asked in the initial survey, those deemed of major interest, were aggregated in this report. From the initial individual (at the level of each primary school) forms, the data was collected for 22 departments and 8 129 municipalities¹³. At least one primary school was present in 4 836 of them (59.5%). This project has been initiated by the *Service d'Histoire de l'Education* of the I.N.R.P, which collected data for the academies of Nantes, Bourges and Nîmes. Other departments were then added to this initial database. In Figure 1, one can see that these departments belong to areas with very different levels of enrolment. Collection of data was indeed conducted with the aim of catching all the determinants that underpinned primary schools spreading. This, added to the focus at the municipal level, should helps avoiding some of the criticisms that were pronounced against the reliance of aggregated data on primary schools¹⁴. Other data on education is coming from the *Statistique générale de la France*¹⁵.

The departments selected are quite representative of France for what regards primary education and industrial characteristics which will be under scrutiny in this analysis. Taking average values at the level of districts in order to compare this "municipal level sample" to the entire country thanks to the *Report to the King*¹⁶ shows that the sample differs significantly only in the percentage of municipalities with factories (21.6% against 17.2% for France) when consid-

ering industrial factors. The number of workers, their average wages, the amount of industrial production or the presence of big-size factories (more than 20 workers) didn't differ significantly. The same is true for the investment of municipalities in primary education (provision of a fixed salary or an accommodation to teachers) and for the number of primary schools. However, enrolment rates and the percentage of municipalities with schools (60.8% against 71.5% for France) are lower in the sample, which means that the departments at stake were less well-endowed in primary schools than the average national level. This is why several agricultural wealth controls and department fixed effects will be introduced in the estimations to reduce potential biases linked to department-specific factors.

3.2 Data on Industrial Activities and Economic Resources

The economic data are coming from two surveys: the industrial survey of 1839-1847 and the agricultural survey of 1852¹⁷. The agricultural survey is used in order to measure the agricultural resources of districts. It can be held as relatively representative of the state of French agriculture in the middle of the nineteenth century. Indeed, compared to other years, harvests have been deemed "normal" by contemporary analysts, a statement that is today considered to be quite accurate [Demonet, 1990]. The major issue with these data is the 20 years time-lapse that separates them from the Guizot survey. However, since agricultural characteristics were quite stable over time, they should still constitute a good approximation of the agricultural resources at the beginning of the nineteenth-century and serve as good controls for agricultural resources of districts.

Data on the location of factories as well as their characteristics are drawn from the industrial survey. These data are available at the level of municipalities, which makes it possible to match them with those on primary schools. Thanks to it, I can know exactly in which municipalities primary schools and/or industrial factories were present. The factories reported in the survey are composed of more than 10 workers in order not to be mingled with craftsmanship. Because of the interruptions and difficulties linked to the gathering of data, the industrial survey suffers some flaws. Moreau de Jonnès himself, the coordinator of the survey with the minister Laurent Cunin-Gridaine, acknowledged the poor quality of information for what regards the South-West part of France. But other areas, like the Seine-et-Marne, are also characterized by these issues. On top of that, Paris is not included in the data. Lyon is imperfectly described as there is no information on silk industry [Chanut et al., 2000]. In spite of this, the data coming from this survey seem to be quite reliable. For example, in the case of average daily wages, they are in compliance with those reported by Villermé, 1971, 1840 and comparable to those coming from other sources like the Statistique générale de la France. A comparison with the Statistique de l'industrie minérale also reinforces this reliability [Chanut et al., 2000]. In any case, there seems to be no major concern about data quality for the departments under scrutiny in this study.

3.3 Demographical Data on Municipalities

Data on the population of municipalities is taken from the *Statistique générale de la France* for the year 1836. Population dispersion is taken from the Postal Survey of 1847 along with the surface area of municipalities which have disappeared or merged since 1833¹⁸. Since this survey is posterior to the Guizot one, I have to assume that population remained stable over the fourteen years separating them, which seems to be a quite reasonable assumption. The *Institut national de l'information géographique et forestière*, a public organism in charge of the diffusion of geographic information in France, provides surface data for the other municipalities. The altitude of municipalities is also taken from this organism.

3.4 Descriptive statistics

Primary schools were located in 59% of the municipalities in the data. This shows that for many of them and many parents, education was either not a major concern or too high a financial burden. This idea is reinforced by the fact that not more than 39% of municipalities were paying teachers a fixed annual salary. Therefore, many of these teachers were actually depending highly on schooling fees to earn their living, all the more since municipal salaries were often low, an average of 97 francs annually, compared to the minimum level of 200 francs fixed by the Guizot Law.

Industrial factories were present in 12% of the municipalities, those more than 20 workers in 6% of them. The majority of manufactures, 72.6%, were less than 20 workers (1 545 factories over the 4 128). The average wage of industrial male workers was of 2 frances per day while those of female and child workers were around 96 and 72 cents of frances respectively.

The average population of the municipalities in the data is around 990 inhabitants, but 50% of them were less than 631 inhabitants and 90% less than 2 000. Their average area was 1 726 hectares, with an altitude of 208 meters. Population dispersion could be high within municipalities as the average scattering is around 47%, with a median value close to 50%. This means that for half of them, more than half of their population was dispersed and not concentrated in the main village $(bourg)^{19}$.

4 Research Methodology

4.1 Economic Activities Influencing Primary Schooling Through an Income Effect

The core hypothesis in this article is that agricultural, industrial and more generally economic resources have influenced primary schools' spreading. First, because of low economic resources, municipalities may not have been able to favour the creation of these schools. Grew and Harrigan, 1991, tried to evaluate correlations between social, economic factors and the level

of enrolment rate at the department level in nineteenth-century France. They identified a positive correlation between resources and enrolment, meaning that richer departments tended to be characterised by a higher enrolment ratio. This correlation becomes negligible from the 1880 years onwards, which is interpreted by the authors as illustrating the major steps towards education equality undertaken after Ferry laws. Furet and Ozouf, 1977b, focusing at the level of departments or dioceses, identified for the same period a positive link between agricultural resources and the degree of literacy. In rural areas, financial capacities of municipalities were increased by the presence of common goods owned by them, especially common woods that constituted a great source of wealth. In the department of Vienne, for example, the areas exhibiting higher rates of literacy are often those characterised by the presence of chestnut groves. The same idea is also present in [Guizot, 1834].

Another economic barrier was constituted by the level of schooling fees. As presented in [Furet and Ozouf, 1977a], these fees were paid by parents to the teacher each month. They constituted one of the major parts of teachers' treatment in areas where they were provided with no fixed salary. Parents paid in proportion to the time spent at school and to the number of subjects their children were learning²⁰. Therefore, parents could pay the minimum fees so that their children were only learning to read while others could pay high fees to study additional subjects as history or linear drawing²¹.

Therefore, ideally, one would like to be able to distinguish between the wealth of municipalities and the purchasing power of families. Indeed, the first one could have contributed to increase the instruction supply of municipalities while the second one could have influenced positively the demand for instruction expressed by families by alleviating the relative cost of schooling. I will try to distinguish between the two by using data on industrial workers wages and taxes on industrial activities collected by municipalities. Both these transmission channels can be gathered into an "income effect" induced by economic activities.

Municipalities and families could also invest more in primary instruction because they anticipated high returns from economic activities²², because of morality concerns, because they intrinsically valued instruction²³, ... The imitation of nearby municipalities investing more in education could have also played a role. Distinguishing between these motivations will not be part of this analysis as it is difficult to know precisely the motivations of local authorities and families. One sure thing is that the opinion towards instruction evolved positively from the Revolution period onwards. This certainly contributed to favour primary schools spreading by

making education more accepted and valued among $people^{24}$.

4.2 Econometric Model

In this study, I will focus on the beginning of the nineteenth century for three reasons. First, after 1833, the relation between industrial activities and education could be biased by the impact of the Guizot reform. Second, no data at the municipal level are available further back in time. Thirdly, since industrialisation began in the early nineteenth century in France, it would make less sense to study its interaction with primary schooling before this time period. This could be seen as an issue as schools may have been created before economic activities developed. However, even if it were the case, one must remember that teachers were highly dependent on fees paid by families and on the potential financial help delivered by municipalities. Thus, if these municipalities were not able to support them or parents not able to afford to pay fees, teachers could be forced to move in another area 25 . This was entailing the disappearance of the school. Therefore, at some point, a sufficient amount of wealth was needed either to create a primary school or to maintain it. The estimations will capture both effects: either the direct effect of economic resources on the creation of schools or the indirect one on their maintaining. As seen before, the pattern of education was quite stable over time and differed from the one of industrial activities at the level of French departments. Therefore, there is a priori no strong reason to believe that primary schools were influencing manufactures location at the beginning of the nineteenth century. This location was more dependent on the proximity of deposits, commercial networks, and canals, royal roads, ... Moreover, early industrialisation was shown to have been more dependent on upper-tail knowledge in the case of France than on the average literacy, especially for what regards the implementation of modern sectors Squicciarini and Voigtländer, 2015]. This gives credit to the reliability of the impact evaluation of industrial activities on primary schooling through OLS estimations²⁶. However, since several studies have found a positive correlation between literacy, the height of conscripts (which can be taken as an anthropometric approximation for economic resources) [Aron et al., 1972], [Ladurie et al., 1976], [Ladurie and Demonet, 1980], taxes [D'Angeville, 1836], agricultural and commercial resources [Lepetit, 1986], one cannot totally reject the reverse causality issue.

Therefore, I will instrument industrial activities by the presence of iron, coal and copper deposits. These latter constituted the three main types of ore that were exploited at the beginning

of the nineteenth century. Indeed, at the municipal level, the concern for reverse causality is even higher. It is likely that industrial factories were created in towns and villages with schools because manufacturers were looking for an instructed labour-force or because the presence of a school was contributing to fixing workers, which made them more easily handled. On the other hand, one can also imagine that manufacturers were reluctant to implement their factories in municipalities with schools as an educated workforce would have claimed for higher wages or because this would have reduced the availability of child labour.

The agricultural variables at the district level are not instrumented as it is unlikely that the presence of a primary school in a given municipality influenced greatly the agricultural characteristics of a district. On the other hand, it is true that if primary schooling was well-developed in a district, it may have positively influenced the adoption of new techniques making agricultural activities more profitable. However, as mechanization was very low at that time [Demonet, 1990], this issue is of little concern here. Therefore, agricultural characteristics corresponded above all to the intrinsic suitability of land that was unlikely to be greatly influenced by the spreading of instruction.

At the end of the day, the second-stage estimation equation is :

where $School_{m,d}$ is a dummy variable which equals one is a primary school is present in a given municipality m within a department d. α_d captures fixed effects at the level of departments. I will introduce them in order to improve estimations by controlling for un-observables at the department level. For example, the fact of being close to the sea or to the frontier could entail a higher wealth for municipalities trough trade activities. *Industry* is a dummy variable which equals one is a factory is present in municipality m, Demo is a set of demographics and geographical variables defined at the municipal level. Aqr is a set of agricultural variables defined at the level of districts. Standard errors are indexed by arr because they are clustered at the district level. This is done in order to account for spatial correlation within them. Indeed, as the agricultural variables are defined at a more aggregated level than municipalities, not doing so could cause the standard errors to be seriously biased downward and lead to spurious findings. This may happen for example if the micro units (the municipalities) share some unobservable characteristics in a given group (district) when the estimation is done by OLS [Moulton, 1986], [Moulton, 1990]. This is also true when the estimation is done with instrumental variables techniques [Shore-Sheppard, 1996], [Hoxby and Paserman, 1998]²⁷. For example, the long-term effect of Protestant settlement and the use of a patois are identified in the literature as having influenced schooling spread²⁸. Therefore, standard errors are very

likely to be correlated within districts as they could share some unobservable characteristics influencing primary schooling. Contrary to department fixed effects, this will not influence the magnitude of coefficients estimated.

The estimation framework of the first stage is the same as in (1):

where $Instr_{m,d}$ is a dummy variable taking the value "1" if a deposit is present in the municipality m, this deposit being exploited or not. These data are coming from the *Bureau de Recherche Géologiques et Minières*. This estimation will be done using a standard two-stage least squares technique. As *Industry* is a dummy variable, one might have wanted to use a non-linear estimation, as Probit or Logit. However, as presented in [Angrist and Pischke, 2008], this kind of regression is technically off-limits.

4.3 Choice of dependent variables and expected effects

For what regards demographic and geographic variables, I control by the average altitude of municipalities, their surface area, their total population and by the share of their population that is considered to be scattered. This last measure is coming from the postal survey and based on a simple contiguity criterion. Houses not contiguous to others were considered as remote and their inhabitants as part of the dispersed settlement²⁹. If a high proportion of them were scattered, this could have made the creation and maintaining of a primary school more difficult as children had to cover long distances to attend school³⁰. If this contributed to reducing the fees teachers were receiving from parents by decreasing the number of pupils, it then should have been financially harsher for teachers to establish in this locality. Moreover, scattered settlement can have led to a lower valuation of schooling by inhabitants, which could be due to financial difficulties or a cultural distance to primary schools by reducing attendance and teachers' earnings. Descriptive statistics tend to reinforce this logic as the population of municipalities with primary schools was more often characterized by a low dispersion than those with no

the strong presence of a patois was identified by social observers as a barrier to the spread of instruction. schools 31 .

The altitude of municipalities may have played the same negative role. Indeed, a mountainous land was associated with less good-quality roads and a less fertile soil, which was certainly diminishing the economic resources of municipalities and their ability to trade with others. Therefore, I expect these municipalities to have invested less in instruction. Moreover, it was certainly harder for children to cover long distances to attend school in this kind of land. However, isolation and long winter months in mountainous areas could give people more time to learn and make teaching activities economically valuable compared to hard agricultural tasks. This seems to be what prompted so many people from the Hautes-Alpes department to become teachers and what explains its very high literacy rate [Sandre and Ozouf, 1979]. The effect of the surface area is *a priori* unclear as it could have favoured population dispersion but also increased the possibility to develop agricultural activities, to exploit forests, to build manufactures, ...

Population effect should be clearer since it entailed a potentially higher number of pupils. On top of that, bigger towns are often economically more active and richer than smaller ones. For example, in the department of Seine-et-Marne, the literacy rate was of 70% and 76% for males under 25 years old and over 30 years old in urban areas while they were of 55.5% and 62% respectively in rural ones. The same pattern was true for women (69.6% and 50% in urban towns against 35% and 9% in rural regions). All these effects are confirmed at the descriptive level since towns with primary schools were more populous and localised at a lower average altitude while their surface area was on average not significantly different from the one of towns without schools 32 .

Agricultural variables are used mainly as district-level wealth controls. It is necessary to introduce them in the estimations as many municipalities have developed primary schooling without any link with industrial activities. There are indeed 933 cases of municipalities with at least one industrial factory over 8 129. 79% of the municipalities with a factory were also characterized by the presence of a school while it was the case for 57% of the municipalities with no industry. However, at the same time, there were 4 098 cases of towns with a primary school and no industry over the 4 836 cases with schools³³. Therefore, I use agricultural variables to have a more exhaustive measure of the economic resources of municipalities³⁴. I try to capture both the effect of agricultural resources and of the production organisation.

Agricultural resources will be proxied by the average agricultural land value and by the percentage of day-workers family spendings dedicated to food consumption³⁵. High land prices should

have been linked to higher economic resources of municipalities, through property taxes, and then potentially contributing to a higher investment in primary schooling. Food consumption should reveal the capacity of families to invest in primary instruction. Indeed, at that time, the ratio of earnings dedicated to food could be close to 80% for the poorest families³⁶. This was leaving not much room for schooling investment. Therefore, this variable measures the purchasing power of agricultural workers and the economic constraint hanging over them and is expected to have influenced negatively primary schooling.

The production organization is measured by the number of day-workers, of tenant-farmers and of share-croppers respectively to one-hundred self-employed³⁷. I use these data to control for inequalities potentially affecting schooling investment. Indeed, if agricultural workers were abundant compared to landowners, this could have entailed very low means of pressure to demand high wages or a low compensation in order to work the land, implying a lower financial capacity to invest in primary schooling. Following this logic, a high concentration of share-croppers and day-workers has been found to be closely linked to relative impoverishment in the literature Furet and Ozouf, 1977b³⁸.

5 A Positive Influence of Economic Activities on Primary Schools

5.1 OLS Estimations

In Table 1, I regress the presence of primary schools on economic, demographic and geographic variables without using any instruments. This regression exhibits some effects that will be verified all along this study. First, for what regards demographic and geographic characteristics of municipalities, one can see that the average altitude along with population dispersion were negatively influencing the probability of primary schools presence. One standard deviation in each of these variables was contributing respectively to a 4 and 8 percentage points decrease of this probability. On the contrary, total population had a strong and positive impact on it, of around 12 percentage points.

The effect of agricultural variables is also quite in compliance with what was expected. Indeed, the relative number of share-croppers and tenant-farmers is negatively linked to the presence of primary schools. This is in line with recent studies on the American development [Galor et al., 2009] or analysis in development economics [Deininger and Squire, 1998]. Total agricultural area and the number of animals per inhabitant had also a negative impact. This seems coherent with the fact that schools developed more in urban areas. Moreover, as looking after cattle was a task historically dedicated to young children, it seems logical that primary schooling was less

measured by the purchasing power of workers.

likely to develop greatly in districts were more children were working at young ages.

The effect of industrial variables is always positive and significant. The presence of at least one factory was increasing the probability to have at least one primary school in the same municipality by 8.4 percentage points. A one unit increase in the total number of factories was leading to a 2 percentage point increase of the same probability. Finally, the presence of a factory with more than 20 workers (the 37% biggest ones) was increasing this probability by 7.3 percentage points. This shows that industrial activities were linked to a higher spreading of primary schools and that this effect was greatly due to the presence of large factories. Indeed 319 industrial workers were on average employed in municipalities with factories more than 20 workers, with a median value of 104 workers. All these estimations suggest a positive link between agricultural, industrial, economic activities and the presence of primary schools. In the section dedicated to transmission channels, I will show why this can be due to an income effect, valid both for municipalities and families³⁹.

5.2 Instruments' Validity

As presented in (2), I use the location of coal, iron and copper deposits to instrument the presence of industrial factories. These deposits are present in 237 municipalities. Over these 237 cases, a factory is located in the same municipality in 81 cases. The idea here is that factories could have been present in the same municipalities as they were exploiting directly these deposits (55 cases over 81). Another reason explaining this correspondence would be that mining activities attracted other industrial factories (as clothing, food industry, ...) because, by fixing the labour-force, they were creating some outlets for these other sectors. Then, these activities may have continued to exist, even if the deposit was depleted and mining factories closed. It is also possible to imagine that some industries were randomly present in municipalities where deposits were localised. This could be true in the case of non-exploited deposits. Following [Murray, 2006], I check the validity and the strength of this instrument.

First, for what regards the validity, I regress the presence of primary schools on that of deposits⁴⁰. The effect is always positive, around 6%, and significant at a ten-percent level. This illustrates the link between deposits and schools that is expected to be due to the presence of industrial factories. The exclusion restriction will be satisfied only if deposits didn't influence directly the creation of schools⁴¹. It seems difficult to argue so, except if one thinks that schools needed ores for their functioning, which is unlikely. However, the presence of deposits could be linked to geographical characteristics that were influencing the presence of schools. For example, if they were located in more mountainous and difficult-to-access lands, this could have deterred municipalities or teachers to open a school. This could have been the case as the population was significantly more scattered (55% against 47%) and average altitude significantly higher (250 against 206 meters) in municipalities with ore^{42} . These two characteristics were found in Table 1 to be negatively correlated with the presence of primary schools. However, at the same time, the total population was significantly higher in the municipalities with ore, which was found to be positively linked to the location of schools. Therefore, it is hard to believe that the presence of deposits influenced greatly, significantly, and in a clear direction the presence of schools. Moreover, since schools were localised in the same municipalities as deposits in 164 cases over 237 and as I found a positive and significant link between them in the previous regression, this issue shouldn't be too high.

Still, one could argue that manufacturers were looking for both a primary school and a deposit, since exploiting ores could require a more skilled workforce than, for example, food or clothing sectors. This idea can be directly tested by regressing the presence of industry on an interaction term composed of the location of schools and deposits. This is what is done in Table 2. The effect of the interaction term is never significant. On the contrary, the presence of a deposit is always strongly significant and positive, increasing the probability for a factory to be present in the same municipality by around 15 percentage points. Therefore, the exclusion restriction

seems to be valid here, which makes the use of deposits as an instrument reliable.

5.3 A Stronger Effect with IV Estimations

In Table 3, I regress the presence of primary schools on that of industrial factories and agricultural characteristics using the instrumental variable strategy presented. In all the cases, the presence of ore is significantly linked to that of industries in the first stage. The Sanderson-Windmeijer *F-stat* is superior to ten in the two last cases⁴³ which tends to exclude the issue of weak instrument. This also prevents the estimations to be greatly biased if the presence of deposits is even slightly directly correlated with the localisation of primary schools [Bound et al., 1995]. The *Regression based p-value*⁴⁴ is inferior or close to 10% which means that I can reject the exogeneity hypothesis of the *Industry* variable.

The influence of the presence of industrial factories is always positive and significant at a tenpercent level, with a magnitude between 35 and 39 percentage points, which is much higher than the effect estimated by OLS. As 56.95% of the municipalities without industry had a primary

school, this means that if industrial factories were to be present in each of these municipalities, primary schools would be located in almost every one of them too. I interpret this as being due to the fact that factories were localised in municipalities where economic activities were more developed compared to others. Therefore, the economic resources of these towns were sufficient to open and maintain a primary school. This idea is reinforced by the fact that 90% of the municipalities in the data were less than 2 000 inhabitants while it was the case for 70% of them when at least one industrial factory was present⁴⁵. As robustness checks, I tested the same specification but taking into account the absolute number of agricultural workers, the number of agricultural machines and decomposing land value between its different components. This doesn't lead to significantly different outcomes⁴⁶.

When interpreting the effect of factories' presence, it is interesting to look at its magnitude on the stock of primary schools. As the formers were located in 11.48% of the municipalities, and that this increased the primary schools' presence probability by 38.9 percentage points, this means that the effect of manufactures on the stock of schools is of (11.48*38.9) 4.5 percentage points. This implies that over the 59.5% of municipalities in which at least one primary school was present, 4.5 percentage points of them could be explained by the dynamism of economic activities measured by the presence of factories. This amounts to around 370 municipalities over the 4 836 in which a school was present.

In order to specify this effect, one can look at the influence of mining activities on schools. Indeed, as the instrument used here is the presence of deposits, it is strongly correlated with the localisation of these activities⁴⁷. From a descriptive point of view, there is a clear link between mining activities and primary schools as nearly 80% of the municipalities in which mines were present were also characterized by the presence of a primary school. Therefore, there were only a few towns with mining activities but no schools. In Table 4, I use the same specification to measure this relation⁴⁸. A significant and positive effect is found, the presence of mining activities increasing by around 30 percentage points the probability for a primary school to be found in the same municipality. This reinforces the idea of a positive effect of industrial activities on the development of primary schooling⁴⁹. This effect is therefore greatly due to the mining sector, which is logical given the nature of the instrument used. Moreover, this helps to understand the high magnitude of the IV coefficients. Indeed, 11.5 factories were on average present in municipalities with mining activities against 3.6 in those with industrial

activities but belonging to other sectors⁵⁰. This implies a potentially high amount of resources transferred to these municipalities through taxation.

In the same table, I also report estimation coefficients of the relation between the presence of large factories with more than 20 workers, and the location of primary schools. Descriptively, there is a positive relation between the two since 81.6% of the municipalities with a big-size factory were characterized by the presence of a primary school. Even if the effect is not significant in the second specification, the presence of these factories was entailing an increase of around 42 percentage points of the primary schools' presence probability when department fixed effects are introduced. This higher effect is coherent with what was expected since large factories were more likely to attract, be attracted by and to develop along with other activities. Therefore, the income effect potentially induced by industrial production was likely to be higher when manufacturers were employing more people.

So far, I have shown that industrial activities where influencing positively the presence and maintaining of primary schools. The influence of geographic and demographic characteristics of municipalities was also far from being negligible. Several transmission channels can be thought of in order to explain this relation : cultural proximity with education, higher expected returns from families and local authorities, direct investment of businessmen into schooling, a higher demand for an educated workforce where activities were dynamic, an income effect through taxes and a higher purchasing power of workers, ...

Among them, the last one seems to be the most relevant economically. Indeed, if a high demand for skills in economic activities entailing both a greater investment of businessmen into schooling and higher education returns for families existed historically, it seems that it characterized rather the second phase of the industrialisation process⁵¹. The first phase, at the beginning of the nineteenth century, was rather characterized by an accumulation of physical capital, with a low complementarity with human capital [Mitch, 1993]. The increase of this complementarity in the second phase, beginning rather in the 1860s-70s in the case of France, is considered as explaining the rise in industrial wages along with the fall in rental value and inequalities [Allen, 2009], [Galor and Moav, 2006]. Therefore, it seems unlikely that primary schools developed along with economic activities following the logic of complementarity and of demand for skills.

6 Transmission Channels : the Income Effect

In order to study the income effect of industrial activities, I will distinguish between economic resources of municipalities and the purchasing power of families. If this effect is verified, each of them should be linked to a higher investment in primary schooling. One should also note that both were surely working at the same time since the cost of education was lower if both families and municipalities were investing in it. For example, families could certainly invest more in education if local authorities were paying teachers regularly, contributing to the decrease of schooling fees.

6.1 Economic resources of municipalities

To study the income effect, one can look at the level of investment in primary schooling made by municipalities. They should have been able to afford to pay teachers on a regular basis, providing them with an accommodation more often, paying them a higher salary ... when they were richer⁵². From a descriptive point a view, municipalities with factories were more often

paying teachers on a regular basis (53% of them against 37% when no industry was present), providing them more often with an accommodation (40% against 27%) and a classroom (45.2% against 37%)⁵³. It is also worth noting that, on average, municipalities with a school but no industry were providing teachers with a low annual fixed salary of 147 francs, compared to the minimum level of 200 francs subsequently implemented by the Guizot Law. This level was on the contrary already attained and surpassed in towns with schools and factories, with an average salary amount of 262 francs. The same is true for agricultural resources since municipalities where a fixed salary and an accommodation were granted to teachers belonged to districts in which day-workers' remuneration and land value were higher, the agricultural area smaller but more equally divided between self-employed⁵⁴.

In order to check the causality of this effect, I regress in Table 5 the probability for a teacher to have a fixed salary on the presence of industrial factories. I keep all the observations here and not only the cases of municipalities with a primary school. Therefore, I capture two effects at the same time. First, compared to municipalities with no schools, the influence of industrial activities on the opening of a school with a teacher paid on a regular basis. Second, compared to municipalities with schools but no regular salary, the influence of these activities on the probability to pay teachers regularly. I am forced to do so since the instrument becomes too weak when focusing only on municipalities with schools.

The effects are in compliance with what was found previously. The impact of industrial factories presence is of around 40 percentage points. As teachers paid on a regular basis were present in 37% of the municipalities without industry (2 665 over 7 196), this means that the generalization of industrial production would have theoretically entailed a globally shared financial capacity to pay teachers. In stock terms, as paid teachers were present in 38.92% of the municipalities, this means that (45.3*11.48) 5.2 percentage points of them can be explained by the presence of factories. This figure is higher than the stock contribution of factories to primary schools. This is coherent with the idea that paying teachers regularly was financially more demanding than simply creating a primary school. Consequently, the explanatory power of the income effect is higher here. The influence of economic activities was therefore not limited to the creation of schools, influencing also their organization and their functioning. The effect is also verified taking into account large factories or mining activities, with a slightly higher magnitude in the former case⁵⁵.

If these municipalities were more capable to invest in instruction, it is because economic activities were directly contributing to municipal resources through the taxes collected on these activities, the *patente*⁵⁶. The basis of this tax was incomes coming from trade and industrial activities. However, it is only by means of rental value that these resources were taxed⁵⁷. If the income effect put forward is verified, then municipalities collecting more taxes on economic activities should also be those investing greatly in primary schooling. Descriptively, this is indeed the case as both production value and taxes on this production were higher in towns with schools, where a fixed salary or an accommodation were provided to teachers ⁵⁸. For example, these taxes amounted on average to 123 frances per year in municipalities paying teachers regularly against 60 frances in those which didn't. The figures for what regards accommodation

are respectively 167 and 51 francs. Therefore, the municipalities that were investing more in education were also those whose economic resources coming from industrial activities were the highest. These municipalities were also more likely to collect a large amount of taxes on other economic activities.

The use of simple OLS shows that taxes on industrial activities were linked to a higher investment in primary schooling. In Table 6, one can see that municipalities with schools were more likely to pay teachers on a regular basis and were paying them more if industrial taxes collected were high⁵⁹. One standard deviation increase in the amount of taxes collected was increasing the probability to pay teachers regularly by 6 percentage points, while it increased their salary by an amount between 25 and 30 francs. This positive effect of taxes explains also why the presence of large factories was influencing highly primary schooling. Indeed, production value and taxes collected on manufactures were about ten times higher in municipalities with large factories than in municipalities with factories but less than 20 workers⁶⁰. However, I find no significant effect of taxes on primary schooling using the same instrumental variable strategy used previously. The corresponding coefficient is always close to being significant at a ten-percent level but still remains non-significant.

6.2 Purchasing Power of Workers

As pointed out before, the purchasing power of families is complementary to municipal resources in explaining primary schools presence. Thanks to industrial data, I can check if this purchasing

power was higher in areas with more active economic activities. If this were the case, it would mean that families could invest more easily in instruction, making at the same time the investment of municipalities easier as a larger part of schooling costs would be borne by families. This demand-side argument shouldn't be underestimated since schooling fees could represent a high cost for families. Indeed, on average, paying the monthly fees for one child was equivalent to the daily wage of an industrial female worker, between 50% and 71% of an industrial male daily wage and between 69% and 86% of the wage of an agricultural male day-worker⁶¹.

Therefore, first, in Table 7, I regress industrial workers salaries on the level of industrial taxes in order to see if the purchasing power of families was increased when industrial activities were producing more and when more resources were transferred to municipalities⁶². A standard deviation in the level of industrial taxes entailed an increase of around 27 cents of franc in the daily male industrial salary. This increase is of about 6 cents for what regards child salary, while the effect is positive but not significant for female salaries. When adding department fixed effects, this latter becomes slightly significant. However, the fact that child wages were higher could also have prompted parents into sending their children to work instead of sending them to schools, as the opportunity cost of schooling was increased. Thus, economic activities may have been detrimental to enrolment. The effect could also have been more complex as the employment of one child can have provided families with enough additional resources to pay for the schooling of the remaining ones. I will show in the next section that this issue can be partly explored with these data.

T-tests on wages tend to confirm the idea that municipal investment in primary schooling was linked to a higher purchasing power of people⁶³. Indeed, the daily wages of industrial workers were higher when schooling investment was high. This was particularly the case for men, whose wages were around 2.2 francs when a fixed salary, an accommodation or a classroom were provided to teachers, compared to 2 francs when no such municipal grants were provided. For women, wages were around one franc and 90 cents of francs in the two cases respectively.

Even if these variations in the purchasing power of families are valid descriptively, I don't find any econometrically significant effect of workers' wages on the presence of schools or on schooling investment. This is due to the fact that I can only approximate purchasing power by looking at industrial wages. However, as factories were present in 933 municipalities over 8 129, this measure is restricted to 11.5% of the municipalities. Therefore, I can only evaluate if, in municipalities with manufactures, the level of industrial wages influenced significantly schooling investment, which seems not to be the case. This is coherent with the fact that municipalities with industrial activities were investing more in education than the others. Therefore, regressing schooling investment on wages in a subset of towns where this investment was globally high is unlikely to give significant results. To conclude that the purchasing power of families didn't influence this investment at all, it would be necessary to have data on wages for all the municipalities. Here, I can simply state that municipalities with industry investing more in education were also those in which industrial workers were on average paid more. This indicates a concordance between municipal and families' resources.

7 Economic Activities and Child Work : a Diversion from Schools ?

So far, I have shown that industrial activities and resources contributed to the spread and maintaining of primary schooling, focusing on the presence of schools. However, the development of economic activities could have also led to a diversion of children from these schools, especially if families were financially dependent on child work. Historically, the early nineteenth century was marked by the beginning of the industrialisation in many countries, which has been associated in the existing literature with a potential greater reliance on this very child work. Indeed, the study of British household accounts and of a large body of biographies reveals an upsurge in child labour and a fall in the age at which children were starting to work, especially between 1790 and 1850, for both traditional and modern sectors (agriculture, small-scale manufacturing and services) [Humphries, 2012], [Humphries, 2010]⁶⁴. The same kind of phenomenon was identified in the American cotton and wool industries between 1820 and 1850 [Goldin and Sokoloff,

1982]. In the case of French textile industry⁶⁵, the high reliance on child work was described as linked to the development of mechanisation and a more acute division of labour, contributing to make children more productive and their work complementary to that of adult workers. The impoverishment of families was also associated with this phenomenon, especially in cotton industry as social observers of that time already noted [Villermé, 1971, 1840] [Heywood, 1988]⁶⁶. The study of household accounts shows that subsistence for low-paid workers was only attained if they had no early age children or another person at charge. When children were present, no savings could easily be made, which prompted parents into making them work in factories in order to compensate for the burden they represented on family spendings. Even when both parents and a child were working, Villermé noted that almost 90% of the budget was dedicated to buying food and accommodation, the remaining resources being mostly dedicated to linen and to the maintenance of factory tools⁶⁷.

Therefore, in the historical and economic literature, early industrialisation, roughly between the 1790s and the 1850s, has often been evaluated as detrimental to instruction, even if the relevance of this statement is debated. One central point in this debate is to know whether industrial activities worsened the situation of children with respect to the labour market, especially compared to agricultural activities in which most of them were employed⁶⁸. All in all, economic activities are mainly presented as potentially diverting children from schools by reducing the need for skills or by increasing the dependence of families over child work through a relative impoverishment. Consequently, even if economic activities have entailed a greater investment in primary schooling, it is not obvious that it benefited to the whole population.

7.1 A Stronger Effect in Small Municipalities ...

To evaluate the effect of industrial activities on enrolment rates, I compute t-tests on this enrolment, depending on the presence of factories and high-size factories (more than 20 workers) in municipalities⁶⁹. As no data are available at that time on the age structure of the population, I take the number of pupils per 100 inhabitants as an approximation for enrolment rates⁷⁰. First,

taking all municipalities into account, both in winter and summer (or if one takes the average value between the two), enrolment was significantly lower in municipalities with factories and large manufactures. The average winter enrolment was of nearly 10 pupils per 100 inhabitants when no industrial activities were located in the town and around 7 in the other case⁷¹.

To diminish the issue of age structure, I also compute these t-tests separating municipalities into two categories, less or more than 2 000 inhabitants, 90.6% of them being present in the first one. I make the assumption that the age structure is likely to be close in each category, which seems reasonable as there is no strong reason to think that municipalities less than 2 000 inhabitants differed greatly. Moreover, there are only 5% of the municipalities in the second category that are more than 8 000 inhabitants, which makes this group quite homogeneous too. Enrolment rates were significantly higher in bigger municipalities with industrial activities (an average of around 10.5 against 8.5), while they were significantly lower in smaller ones with industry (an average of 4 against 5)⁷². This asymmetrical effect may reveal a greater diversion from schools caused by industrial activities in these smaller towns. One could imagine that families were more dependent on child work in these places, which entailed this greater attraction of industrial sectors. Therefore, the negative effect of industrial factories on primary schooling may have been rather concentrated in small towns and villages where economic resources were essential to create and maintain schools, but where purchasing power and the financial capacities to send children to school were lower.

In Table 8, I regress the number of pupils per 100 inhabitants attending schools in winter on industrial variables⁷³. To reduce biases linked to age structure and migration flows, I divide estimations by population bounds, estimating the effects on municipalities less than 2 000 inhabitants and on those more than 631, which is the median population level. I don't report the coefficients on municipalities below this level as the effect is close to the one on those less than 2 000 inhabitants, which reinforces the idea that municipalities less than this threshold are quite homogeneous. These estimations and the followings are done with standard OLS. There could exist an issue of endogeneity here as manufacturers may have avoided municipalities with a high enrolment. Indeed, it would have been difficult for them to employ children in areas where sending them to school was a deeply-rooted habit. In this case, low enrolment rates would not have been caused by industrial factories' activity but would have constituted a characteristic prior to their implementation. Therefore, the estimations on enrolment rates can only be interpreted as correlations and not as causal relations. However, they remain instructive. Indeed, if factories were created in towns with low enrolment rates, they can have accentuated this phenomenon by diverting even more children from schools, which is likely to

be the case as children were employed in manufactures in 503 municipalities over the 933 in which industrial activities were located, with an average number of 47 children employed per municipality.

The effect found is negative, reducing the number of pupils per 100 inhabitants by around 0.8 for the towns below 2 000 inhabitants and by 0.7 for the towns above median population. One additional factory reduces this number by 0.17 for the first category of municipalities, the effect on the second one being negative but non-significant⁷⁴. This tends to confirm the intuition that industrial and economic activities can have diverted some children from schools as enrolment rates were higher in cities without such activities. This could be due to a relative impoverishment and a greater reliance on child work of families working in factories. Without any negative effect on purchasing power, the presence of more dynamic economic activities may also have prompted children to enter the workforce simply because they were (perceived as) linked to better career perspectives than primary schooling⁷⁵.

Not finding any significant effect following the IV strategy may come as a surprise but is, in fact, coherent with the structure of child employment between industrial sectors. Indeed, the instrument restricts greatly the analysis to the mining sector which employed relatively few children at that time. 5.2% of its workforce was composed of children less than 16 years old according to the Industrial survey while they represented 10.5% of total industrial workforce⁷⁶. Moreover, seven sectors over the sixteen reported in this survey did employ more then 10.5% of children and nine more than 6%. Also, the average number of children employed in manufactures is around 26 in municipalities with industrial activities other than the mining sector and 20 in municipalities with mines. Therefore, it is unlikely to find a strong impact of industrial activities on enrolment rates using the location of deposits as an instrument. This is why I stick to OLS estimations in this section.

7.2 ... And in Industrial Sectors Employing More Children

To specify this effect, one can look at the influence of industrial sectors on enrolment rates. Some of them were clearly employing more children than others, as the furniture, textile, luxury, ceramics, building, science and metal objects sectors whose workforce was composed of more than 10% of children⁷⁷. These percentages are computed for France and are not restricted to the 22 departments in my database. The geographical distribution of textile factories, for example, was really close to the one of child workers at that time (see Figure 2). This is coherent with what was said in the existing literature about this sector. Food, chemistry, lightning and leather sectors were, on the contrary, employing a very little share of children (less than 4% of the workforce). Using this data, I split sectors into two groups: a first one in which more than 10% of total industrial workers. This amounts to selecting the seven sectors employing more children over the sixteen reported in the industrial data. The idea here is to see if sectors employing children more intensively were linked to a lower level of enrolment rate.

This is what is estimated in Table 9. These sectors were linked to a fall in enrolment rates of around 1.7% for the whole sample and 1% in municipalities less than 2 000 inhabitants or less than median population. This effect is of 0.76% in towns more than this median level, which

reinforces the idea of an asymmetrical effect depending on municipal population. Another way of measuring the influence of sectors is to regress directly enrolment rates on their presence⁷⁸. I find a negative effect of textile, building and ceramics sectors, which were among the ones employing children intensively⁷⁹. The magnitude of the effect is close for textile and building sectors, diminishing enrolment rates by more than 1.7 children per 100 inhabitants. This is quite consistent with previous literature in historical economics that emphasized the importance of child work in factories [Pierrard, 1987], [Julia, 1970], [Cunningham and Viazzo, 1996], either due to the impoverishment of workers or to the complementarity between child and adult work in these sectors.

Note: In these estimations, all dependent variables are dummies which equal 1 if industrial activities are located in a given municipality. The effect of the sectors in which the average percentage of child workers among industrial workers was superior to ten at the national level is measured, both gathering them into a dummy variable or taking them separately. This corresponds to furniture, textile, luxury, ceramics, building, science-letters and arts and metal objects sectors. The presence of these sectors is related to a fall in enrolment of around 1.7 children per 100 inhabitants when all observations are taken into account.

The negative effect of these sectors on enrolment rates can also be explained by the fact that they are characterised by lower industrial wages. Descriptively, at the national level, this is especially true for textile and building sectors. In these two, daily industrial male wages were far below the average level of 1.98 francs, namely 1.78 and 1.82 francs respectively.⁸⁰. This is confirmed by regressing the presence of sectors using child work intensively and the location of textile factories on daily industrial male wages. The effect is negative and significant, with a magnitude of around 15 cents of francs for both. This means that sectors employing more children relative

to the total number of workers were also those paying less their male workers⁸¹. This illustrates the fact that when many children were employed in industrial factories, the purchasing power of workers was also reduced. Indeed the same negative effect can be found for female wages. This reinforces the relative impoverishment assumption, meaning that manufactures diverting children from schools were mainly doing so because of the greater reliance of families on child work in the municipalities at stake.

8 Conclusion

By adopting a micro-historical approach and by using a new historical database on primary schooling, this article has investigated the causal link between industrial activities, economic resources and primary schooling in early nineteenth-century France. Before the implementation of the Guizot Law passed in 1833, municipalities could freely choose to open a primary school or not. Schools could also be totally private and only funded by the fees paid by parents. Primary schools were more likely to emerge and to be maintained in municipalities in which industrial activities were located too. The effect is found to have been particularly large for what regards the mining sector and stronger in municipalities with big-size factories.

The positive impact of industrial activities was due to an income effect for both parents and local authorities who benefited from the presence of large manufactures associated with a higher amount of taxes collected and higher industrial wages. Municipalities were, therefore, more often investing in primary schooling when industrial activities were dynamic, by paying teachers on a regular annual basis and providing them with a higher salary.

However, industrial production was also contributing to divert children from schools. This was due to an increasing opportunity cost of primary schooling when these activities were more dynamic. Another reason is that some industrial sectors, as textile or building ones, were contributing to a relative impoverishment of workers which was making families more reliant on child work. This effect was stronger in small municipalities, diverting more children from the primary schooling system.

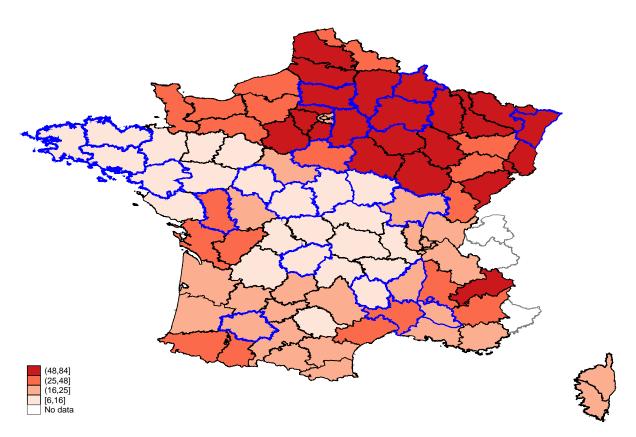


Figure 3: Percentage of children from 5 to 13 years old going to school - winter 1833

Description of data

Guizot Survey

School is an indicator variable taking value one if at least one primary school is present in the municipality of reference.

Fixed salary is an indicator variable taking value one if at least one teacher is paid on an annual fixed basis the municipality at stake. The salary amount if therefore given in frances per year.

Accommodation is an indicator variable taking value one if at least one teacher is provided with an accommodation or an accommodation allowance by the municipality.

Industrial Survey

Industry is an indicator variable referring to the presence of at least one industrial factory in a given municipality. An industrial factory is reported only is it exceeded ten workers in order not to be mingled with craftsmanship.

Factory > 20 workers is an indicator variable taking value one it at least one industrial factory with more than 20 workers is present in the municipality under scrutiny.

Industrial production value and taxes : they are both defined annually and in francs. Taxes on production are called the *patente* and are based on the rental value of manufactures.

Industrial wages : daily wages of male, female and child industrial workers in cents of francs.

Bureau de Recherches Géologiques et Minières

Location of deposits : copper, iron and coal. Deposits exploited and not-exploited.

Agricultural Survey

In this survey, all the data are available at the district level.

Number of tenant farmers and share-croppers : both are employed by a landowner to work on his fields and pay him in return. The different is that share-croppers' payment is in kind (a part of harvests) while tenant farmers pay landowners directly in cash.

Number of day-workers : following [Demonet, 1990], taken as the sum of "aides agricoles" (agricultural assistant) in the survey. They amount to 3.7 millions over all French territory.

Number of self-employed : are gathered in this category all the agricultural workers that could live from their work in the fields, that is to say all the people that own land and work on it directly plus those that own land and make other people work on it. Landowners who

worked on their land but also on someone else's property are not counted. This measure is more restricted as the one made in [Demonet, 1990] who also includes farmers and share-croppers in this category.

Land Value : measured as the mean, in franc by hectare, of four land values considered relevant to describe agricultural land. Namely, ploughable land, vineyards, pastures and forests. In the original data, these lands are decomposed in three quality classes whose repartition in the total land is unknown. Each value is taken as an average value over these three classes.

Agricultural area : in hectares, taking the same four types of land that are used to measure land value.

Food percentage in day-workers spendings : for a day-worker family of five members, food spendings (bread, vegetables, meat, milk, wine, cider, beer and salt) as a percentage of all spendings (food plus accommodation, clothing, heating, taxes and diverse spendings).

Number of animals : taken as the sum of wool animals (rams, sheep, ewes, lambs), pigs, billy goats, goats, young goats and horn animals (bulls, ox, cows, bull-calves, steers, heifers). Horses are excluded from this category as they were mainly bred in the wealthy north-est part of France.

Geographical data from the Institut Géographique National

Average altitude : in meters.

Surface area of municipalities : in hectares.

Postal Survey

Population dispersion : taken as the share of the total population that doesn't match the contiguity criterion. See [Roncayolo, 1987] on this point.

Total population : taken from this survey if missing in the Guizot Survey.

Statistique générale de la France

Number of children : 5-15 years old children, taken from the 1851 French Census.

Literacy 1686-1690 : evaluated as the marriage signature rate for men.
