**1 ABSTRACT**

2 In light of the fast pace of innovations linked to AV technology, the question arises as to the role  
3 academic research can play in the overall innovation ecosystem surrounding autonomous vehicles.  
4 To explore this question, the authors examined a body of 298 papers presented at the last 5 editions  
5 of TRB Annual Meetings (2014 to 2018), and selected using a list of queries related to AV  
6 technology (road vehicles only). The review examined the context of the research as well as its  
7 contents (including typologies for building blocks of knowledge and for technology readiness  
8 levels) and the nature of partnerships involved in the production of knowledge.

9 Main findings are that American contributors are prominent, followed by contributors  
10 from the Netherlands and China. The five more active institutions are four US universities and one  
11 Dutch university. As expected, the most productive authors belonged to the most active institutions.  
12 Very few contributions from the private sector were identified.

13 Research on the vehicle and on operations still dominate, in most cases involving  
14 technologies at the stage of proof of concept. Research on demand is growing but still involves  
15 technologies with low levels of maturity. Governance is growing as a research focus (especially as  
16 real-life experiments develop) and involves technologies from low and high levels of maturity.  
17 National and regional agencies are the major funding partners of AV research.

18 Academic research plays a supporting role in the AV innovation ecosystem, especially with  
19 regards to technological and operational developments. More research is needed on demand and  
20 governance.

## 1 INTRODUCTION

2 Since the debuts of the Google Car in 2010, the autonomous vehicle (AV) technology has  
3 undergone significant developments. Competition has been fierce in the automotive industry and  
4 with transportation platforms and other service providers. Despite highly vocal criticism  
5 following such events as the Tesla Autopilot crash in May 2016 or the Uber driverless car crash  
6 in March 2018, it is becoming increasingly accepted that self-driving cars could be on the roads  
7 in the next decade. Faced with rapid technological change and industrial upheaval, governments  
8 have started to regulate the nascent industry and to set appropriate frameworks (including  
9 roadmaps, taxonomies, etc.) to guide the technology development. In the United States, the  
10 National Highway Traffic Safety Administration (NHTSA) after developing a first classification  
11 for vehicle automation levels as early as 2013 later adopted classification J3016 by the Society of  
12 Automotive Engineers (SAE) (1) in 2016 (2). SAE classification J3016 lists and defines 5  
13 automation levels. Level 0 means no automation, whereas level 1 implies driver assistance and  
14 level 2, partial automation. Levels 0–2 refer to lower-level automated vehicles (LAVs), whereas  
15 levels 3–5 refer to highly automated vehicles (HAVs). Level 3 is known as conditional  
16 automation, whereby a driver must be in the vehicle but is not required to monitor the  
17 environment at all times. Level 4 refers to high automation (i.e. full automation on designated  
18 use cases), and level 5 to full automation. European countries modified the Geneva Convention  
19 on Road Traffic and the Vienna Convention on Road Traffic in 2016 to accommodate the new  
20 technology and make real-life experimentations possible.

21 Parallel to such technological and political developments, academic research on  
22 autonomous vehicles has been growing rapidly (3; 4) covering a wide range of domains from  
23 robotics, computer science and engineering (3) to political or societal domains (4). It has also  
24 been rapidly evolving. In the first half of the decade, a large majority of studies focused on the  
25 technological aspects of vehicle automation (4; 5). Progressively, more and more research papers  
26 have taken into account social impacts and policy formulation (4; 6), while research on AV  
27 technological aspects made further progress.

28 In light of the fast pace of innovations linked to AV technology, what can be the place of  
29 academic research in the overall innovation ecosystem surrounding autonomous vehicles?

30 As a preliminary exploration of the question, the authors propose to examine all papers  
31 discussing AVs that were presented at one of the five most recent editions of the Transportation  
32 Research Board (TRB) Annual Meeting (2014 to 2018). TRB Annual Meetings are a privileged  
33 arena for sharing information on transportation practice and policy among researchers and  
34 practitioners but also for stimulating the emergence of new research. These meetings contribute  
35 to the main mission of the TRB, an institution under the aegis of the US National Academy of  
36 Sciences, which is to promote innovation and progress in transportation through research. As far  
37 as AV technology is concerned, the title of Session 334 of the 2016 TRB Annual Meeting  
38 effectively sum up the question raised in this paper: “Can We Keep Up? Accelerating Research  
39 Processes to Keep Pace”.

40 The concept of innovation ecosystem refers to the collaborative effort of a diverse set of  
41 actors from both the production (supply) side and the use (demand) side, towards innovation (7;  
42 8). Ecosystems encompass communities of organizations, institutions, and individuals that  
43 influence the fate of a local firm (7) or a dedicated technology such as AV. Innovation  
44 ecosystems are dynamic. They emerge, expand and consolidate, and then die or renew  
45 themselves (8). Although value creation usually predominates over value capture in innovation  
46 ecosystems (as opposed to business ecosystems) (9), relationships among actors in the ecosystem  
47 could be unstable, possibly moving from cooperation to competition and vice-versa, especially in

1 the presence of a radical innovation (9). In such a context, what can be the role and position of  
2 academic research? Is it a supporting role or a leading role involving direct value creation, or yet  
3 an entrepreneurial role (8)? Has the role of academic research evolved with the increasing level  
4 of maturity of the AV technology (10) and the expansion and complexification of the innovation  
5 ecosystem?

6 The AV innovation ecosystem considered in this paper focuses on surface transportation  
7 solutions using road vehicles. Automated or autonomous as well as self-driving or driverless  
8 road vehicles are in the scope, but the authors did not consider guideway transportation (e.g.  
9 personal rapid transit).

10 The paper is organized as follows. The next section describes the process for selecting  
11 papers and the analytical framework (accounting for, inter alia, considerations of technology  
12 maturity). A second section presents descriptive statistics regarding the main contributors  
13 (countries, institutions and authors). A third section focuses on the content of research (including  
14 focuses on the building blocks of knowledge and on the maturity of technology considered) and  
15 the forms of partnerships involved in research production. A final section discusses the role of  
16 academic research in the innovation ecosystem and draws out perspectives for future research.

## 17 **METHODOLOGY**

### 18 **A Body of 298 Papers**

19  
20 Being the largest annual conference on transportation research globally, the TRB Annual  
21 Meeting offers a broad perspective on ongoing research on a wide range of topics, from  
22 infrastructure to safety including travel behaviors, etc. Besides, due to a very efficient selection  
23 process of papers (5 months from initial submission to presentation in the conference, including  
24 a single-blind reviewing process and the resulting revision of the paper), research presented at  
25 TRB usually covers the hottest topics of research in pace with, if not in anticipation of,  
26 publications in scientific journals. The authors therefore considered that the compendium of  
27 papers of TRB would provide a relevant baseline for developing and testing on a limited  
28 selection a methodology for the meta-analysis of the literature dedicated to autonomous vehicles.

29  
30 Autonomous vehicles being a recent, very dynamic topic in transportation research, they  
31 have been the focus of a growing number of papers presented at TRB over recent years. They  
32 even became the focus of dedicated sessions (including lectern, poster, workshop and panel  
33 sessions) starting in 2012 with a lectern session labeled “Ready for automated mobility” (session  
34 181), several years after the first sessions dedicated to “vehicle-highway automation” started.  
35 Papers included in this review were selected from the compendiums of papers of TRB Annual  
36 Meetings from the last 5 years (2014 to 2018) using a list of queries which treated as synonyms  
37 the words “automated”, “autonomous”, “driverless”, “self-driving”, in combination with the  
38 words “vehicle”, “car”, “bus”, “taxi”, or “shuttle”. The phrases “robo-taxi” and “vehicle  
39 automation” were also included in the list of queries. Authors used the search engine of TRB’s  
40 compendium website to proceed the queries. Altogether, these queries led to a selection of 298  
41 papers over 5 years, with a significant acceleration from 2016. 13 papers were presented in 2014,  
42 which amounted to 1% of total papers in the 2014 compendium, 15 papers in 2015 (1% of total),  
43 49 in 2016 (2% of total), 75 papers in 2017 (3% of total), and 146 papers in 2018 (4% of total).  
44 Thus, 25% of the corpus was retrieved from the 2017 compendium and almost half of all the  
45 papers from the 2018 compendium. The yearly number of papers focusing on AVs increased  
46 more than tenfold over a 5-year period. The authors noticed a similar acceleration regarding the  
47 ratio of the number of TRB sessions explicitly dedicated to AVs to the total number of sessions

1 at a given TRB Annual Meeting. Indeed, the 10 sessions that were focused on AVs at the 2014  
 2 Annual Meeting and the 31 sessions focused on AVs at the 2018 Annual Meeting respectively  
 3 amounted to 1% of all TRB sessions in 2014 and 4% of all TRB sessions in 2018.  
 4

### 5 **Analytical framework**

6 A systematic approach was used for the collection of a wide range of information from each  
 7 paper, from authors' names and affiliations to methods used, also including the types of data, the  
 8 thematic focuses, the level of automation considered, etc. In order to explore the place of  
 9 academic research in the overall innovation ecosystem surrounding autonomous vehicles, the  
 10 present paper reviews the selected papers from four main analytical perspectives covering the  
 11 context of the research as well as its content.

12 First, the review examines where academic research emanates from, with specific  
 13 focuses on the most actively contributing countries (where institutions are based), institutions,  
 14 and authors.

15 Second, the review analyzes on which building block(s) of knowledge academic  
 16 research is focused, be it: a) the vehicle and its components (hardware and software innovations,  
 17 technological options, etc.); b) operations (operational optimization, business models of services,  
 18 etc.); c) demand (market segments, diffusion process, customer acceptance, willingness-to-pay,  
 19 travel behaviors, social acceptance, etc.); or d) governance and regulation.

20 Third, the review considers the level of maturity of the objects on which academic  
 21 research is carried out, using the US Federal Highway Administration (FHWA)'s 9-level  
 22 Technology Readiness Level (TRL) scale (10) as a reference (Table 1). The TRL scale is  
 23 designed to evaluate how complete was the technology when it was tested and how  
 24 representative the test environment was (10). The papers were classified according to a list of  
 25 questions Cuddy et al. (10) consolidated for each of the 9 TRLs. As an illustration, to achieve a  
 26 TRL rating of 3 that characterizes the "proof of concept", the technology considered should yield  
 27 positive answers to the following questions: "Are system performance metrics established? Is  
 28 system feasibility fully established? Do experiments or modeling and simulation validate  
 29 performance predictions of system capability? Does the technology address a need or introduce  
 30 an innovation in the field of transportation?" (10).

31 Fourth, the review analyzes the nature of partnerships disclosed by academic research  
 32 with other stakeholders in the process of research production, e.g. on funding, data sharing, etc.

### 36 **Scope and limits** 37

1 Although the TRB Annual Meeting is an open conference, the reach of which is intended to be  
2 global, the authors acknowledge there is a geographical bias to the selected body of research, if  
3 for no other reason than for the additional costs incurred by researchers from outside the US to  
4 attend the conference. Language could also be a barrier. Given that the reviewing process  
5 specifically asks about clarity of writing, writers who are not native speakers or do not have  
6 access to efficient editing can be disadvantaged. The results of the review regarding where  
7 academic research emanates from, might therefore not be representative of the research on  
8 autonomous vehicles published in scientific journals or in the grey literature. Plus, fierce  
9 competitive climate refrains manufacturers and operators to contribute to such publications.

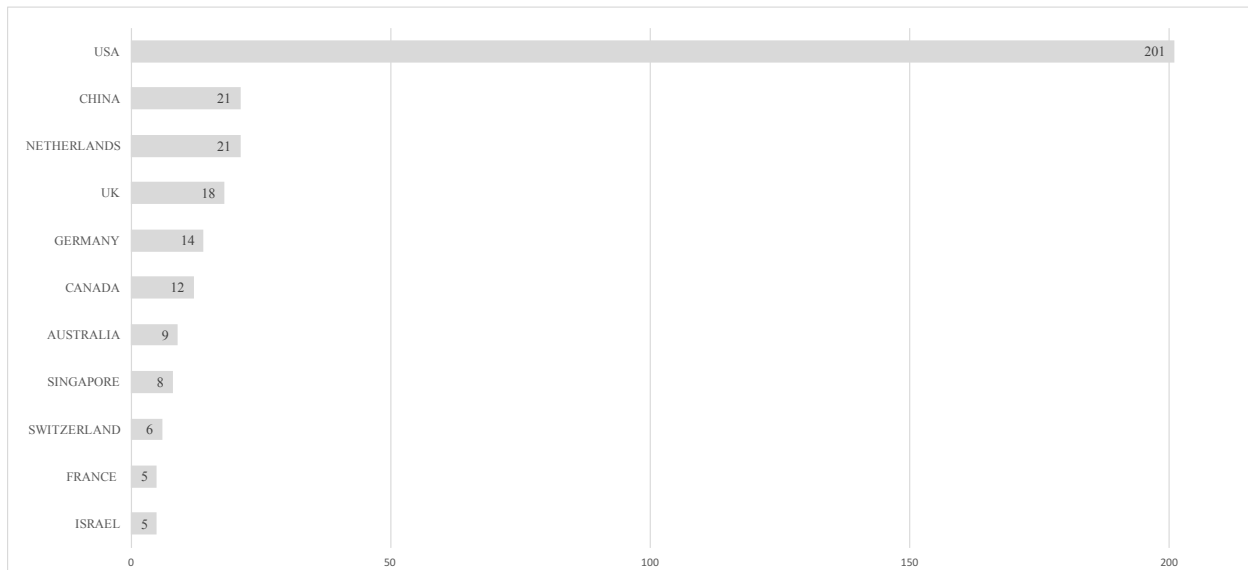
10 Besides, for the purposes of this meta-analysis, the authors chose not to discriminate  
11 among the papers based on the level of automation of the technology considered. Such an  
12 inclusive approach was made possible by the limited size of the selected corpus of papers. All  
13 levels of automation rated 1 (driver assistance) to 5 (full automation) on SAE scale J3016 (*I*)  
14 were therefore included in the scope of the review. It should however be noted that 165 out of  
15 the selected 298 papers made no explicit mention of the level of automation considered, which  
16 would limit the accuracy of (future) analyses based on this entry.

## 17 **WHO CONTRIBUTED THE MOST TO AV RESEARCH AT TRB?**

### 18 **Home Countries of the Contributing Institutions**

19 Authors of the selected papers were classified according to the institution to which they belonged  
20 and the country where this institution was based. 96% of the papers were co-authored by two or  
21 more authors and 81% by three or more authors. 44% of the papers were affiliated to two or more  
22 contributing institutions.

23 Contributing institutions were based in 28 different countries. 11 countries were most  
24 active as they hosted institutions contributed to 5 or more papers over the period 2014-2018.  
25 American institutions largely dominated the AV research with contributions in 201 papers on the  
26 subject (Figure 1). They were followed by institutions from the Netherlands (21 papers) and China  
27 (20 papers). Papers from the US represented two thirds of the body, which is ten times more than  
28 the Netherlands in second position. As already mentioned, this gap could partly be explained by  
29 the fact that, despite its international dimension, the TRB meeting takes place every year in  
30 Washington, DC and therefore remains strongly focused on North America. Institutions based in  
31 European countries (including the UK and Switzerland) contributed to 80 papers and East Asia to  
32 36 papers. It is interesting to notice that China's first TRB contributions on the subject occurred in  
33 2016. Chinese institutions contributed to three papers in cooperation with American institutions  
34 that year and continued a tight cooperation with the US as 12 of their 20 papers were authored in  
35 cooperation with the US. Altogether, 10% of American paper contributions resulted from a  
36 collaboration with one or more foreign countries.

### Institutions

Universities and national research centers are in majority among the contributors (Table 2). Private companies, governments at local, regional and national scales, and associations were also among the contributors to AV research.

Academia accounted for 84% of the contributions and 76% of the institutions that published on the subject. Almost half of the academic institutions involved in AV research presented at TRB were American. They accounted for 59% of the academic contributions. On the opposite, private companies accounted for 15% of the institutions but less than 10% of the papers.

The 5 institutions most represented were universities. Four were from the US: Came first the University of Texas at Austin with 23 papers, then the University of California at Berkeley with 14 papers, the MIT with 12 papers, and Texas A&M with 11 papers. It is interesting to notice that Delft University of Technology from the Netherlands ranked second with 19 articles.

### Authors

The most productive author among the 760 different authors was the Dutch scientist Bart van Arem, director of the TU Delft Transport Institute and head of the Department of Transport & Planning at the Delft University of Technology in the Netherlands. The transportation modeling professor was the (co)author of 16 papers over the 5-year period. He was followed by Professor



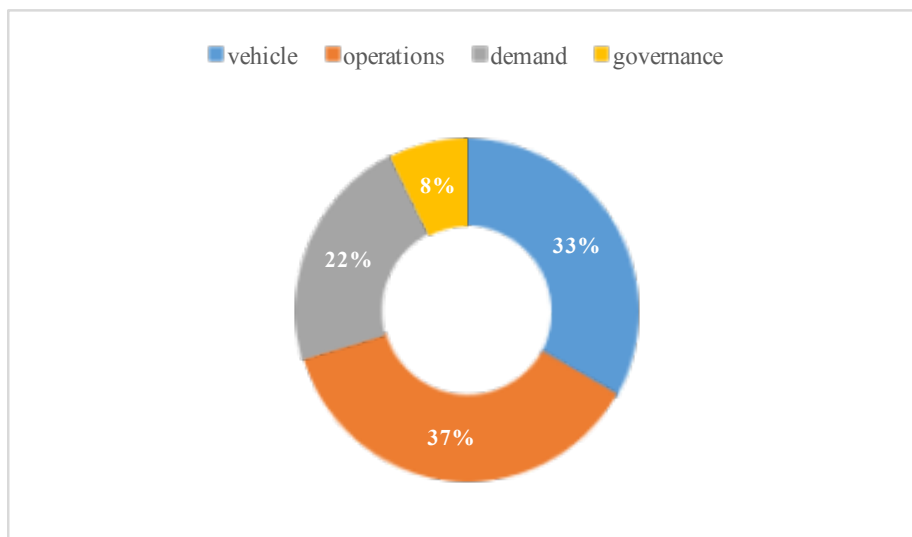
1 Kara Kockelman (transportation engineering and planning) from the University of Texas at  
 2 Austin (13 papers). The next most active authors with 7 papers each were the American scientists  
 3 Steven E. Shladover from the University of California at Berkeley (automation and control),  
 4 Hani S. Mahmassani from Northwestern University (transportation modeling) and Jiaqi Ma from  
 5 University of Cincinnati (advanced computing applications in transportation). Bart Van Arem  
 6 and Steven E. Shladover were very active in 2018 as each of them made contributions to 5  
 7 articles in the corpus. As expected, the most productive authors belonged to the most active  
 8 institutions.

## 10 ON WHAT AND HOW WAS THE RESEARCH DONE?

### 12 The Building Blocks of Knowledge

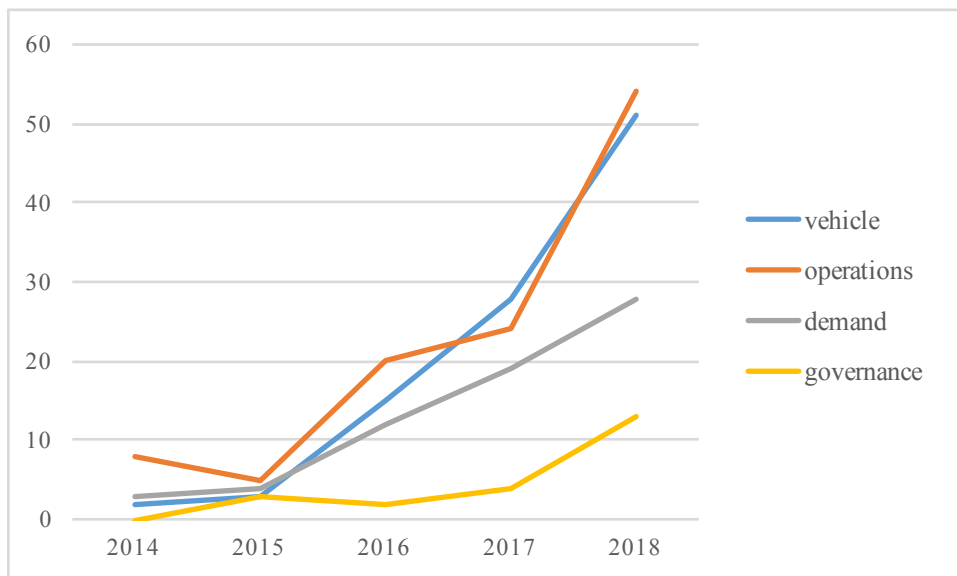
13 The 298 papers were classified according to the main building block of knowledge (one of four)  
 14 addressed by the research, i.e. a) the vehicle and its components (hardware and software  
 15 innovations, technological options, etc.); b) operations (operational optimization, business  
 16 models of services, etc.); c) demand (market segments, diffusion process, customer acceptance,  
 17 willingness-to-pay, travel behaviors, social acceptance, etc.); or d) governance and regulation.  
 18 The classification focused on the single dominant block for each paper, and secondary blocks  
 19 were not considered in the interests of simplification.

20 The two blocks most represented in the selection of papers were the vehicle and  
 21 operations blocks, followed by the demand block and last by the governance block (Figure 2).

 27 Distribution between the 4 knowledge building blocks remained more or less similar over the 5-  
 28 year period. The authors observed a general increase of papers for each block over the years

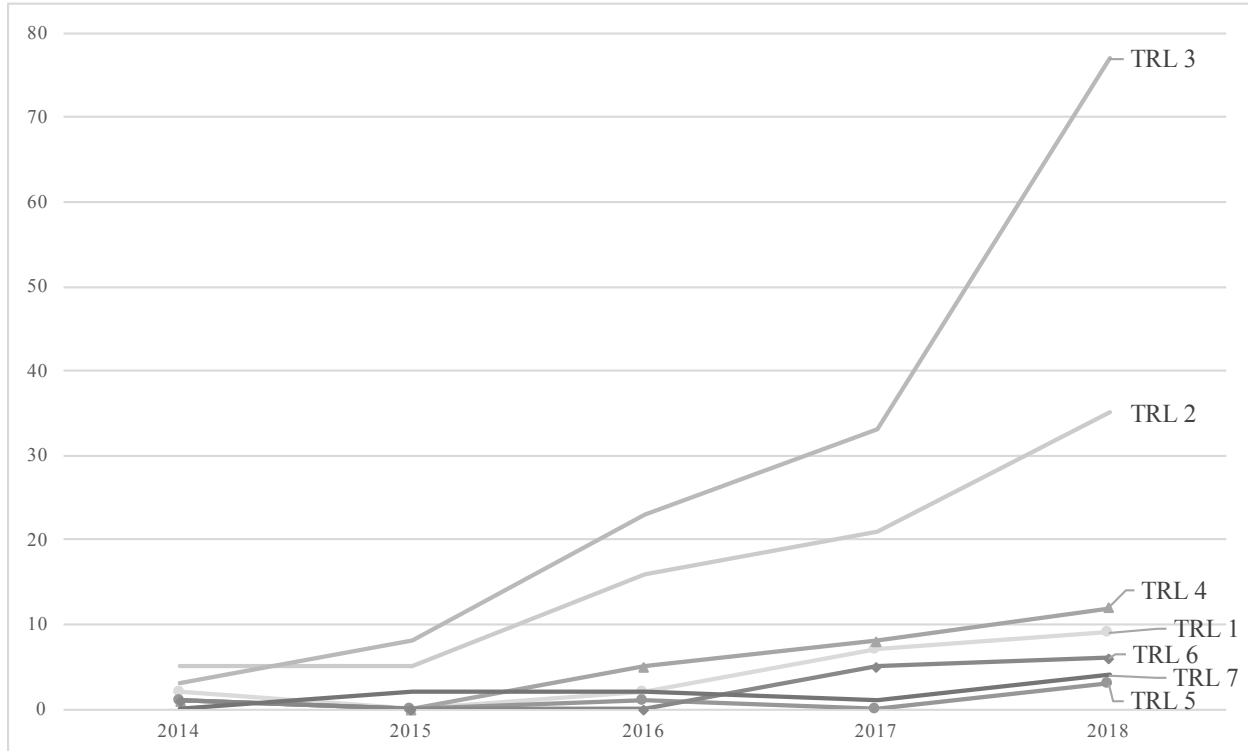
**FIGURE 3 Evolution of the distribution of papers according to the 4 building blocks of knowledge (n=298)**

 29 (Figure 3). Research focused on the supply side, which would include both the vehicle block and  
 30 the operations block, has increased rapidly since 2015. The demand block took off in 2016 and  
 31 the governance block in 2017.

### Technology Maturity

The authors further classified all the papers according to the 9-level TRL scale (Table 1), through a systematic rating of the maturity level of the innovation considered in each paper at the time the research was produced. The criteria associated with the 9-level scale enabled the straightforward classification of around 90% of the papers in the first round of examination. The remaining 10% of papers required further discussion among researchers to reach a conclusion as to their appropriate classification on the TRL scale, mostly for lack of an accurate description of the technology in said papers. As expected, the AV technology was still in early stages of development at the time the papers were written (Figure 4). No single paper met the criteria for a TRL of 9 which characterizes a “technology refined and adopted”, or yet for a TRL of 8 characterizing a “technology proven in operational environment”. TRL-6 and TRL-7 which characterize, respectively, a “prototype demonstrated in relevant environment” or a “prototype demonstrated in operational environment” were identified more frequently in papers from the 2017 and 2018 Annual Meetings than in papers from previous years. This finding partly reflects an increase in the number of real-life experiments of AV technology as it became ready to be tested in operational environments.

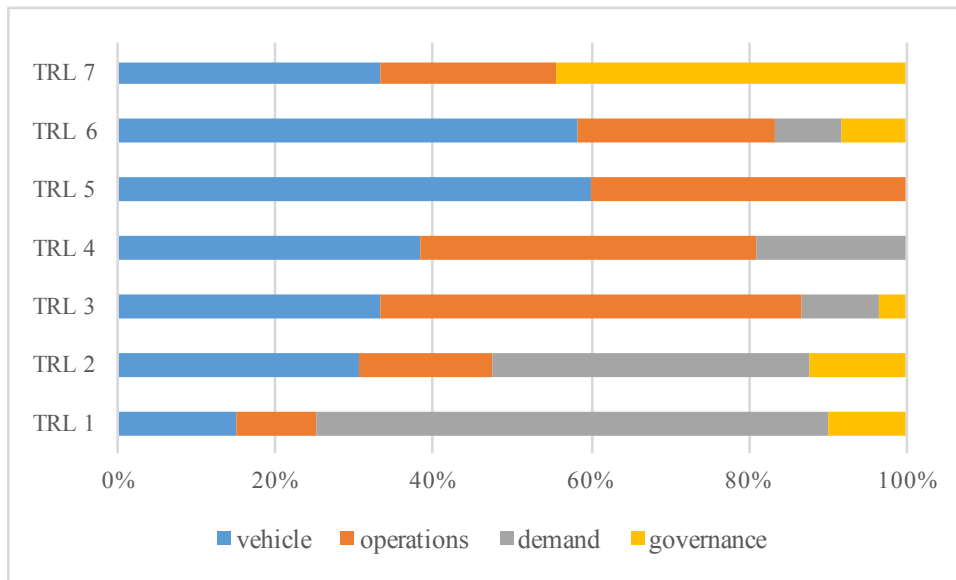
It is worth noting that half of the papers (144 papers) related to TRL-3. This level characterizes a “proof of concept” and mainly corresponded to modeling or simulation research papers (10). Proofs of concept altogether dominated over the 5-year period and represented around 50% of the papers from 2015 to 2018. TRL-2 ranked second for the number of papers. Characterizing an “application formulated”, this level was associated with all papers in which “potential system applications were identified; system components and the user interface were at least partly described; and preliminary analyses or experiments confirmed that the application met the user need” (10). The authors noticed an increase in the number of papers with a TRL of 1 over the period. TRL-1 focuses on “basic principles and research”. The authors also found an increase in the number of papers with TRLs of 4 or 5. These papers mostly presented laboratory experiments. Such simultaneous increase in the representation of different TRLs highlighted a process of progressive technology maturation. It also revealed an acceleration in said process as

1 prototypes were already on the roads while some basic principles were still being explored,  
 2 especially regarding demand and governance.

 9 70% of papers that focused on operations and 50% of papers that focused on vehicle considered  
 10 technologies with a TRL of 3, which means that operational and technological aspects of  
 11 autonomous vehicles were still under simulation. At the same time, real-life experiments (TRL-5  
 12 to TRL-7) mainly related to papers on vehicle and operations. The demand block remained  
 13 probably the least advanced of all knowledge building blocks as virtually no paper with this  
 14 focus considered a technology beyond TRL-4. On the other hand, papers focused on the  
 15 governance block varied widely between application formulations (TRL-1 and TRL-2) and  
 16 demonstrations (TRL-7) (Figure 5).

## The Role of Partnerships in Producing AV Research

### *Partnering for Data*

Half of the papers relied on open data to realize the research. The ratio of papers based on open data sources was similar over the period. Restricted data (including industrial proprietary sources) accounted for 11% of the papers whereas academic data (mainly based on literature reviews) accounted for another 8%. Data directly produced by the research, e.g. through modeling (e.g. simulated or synthetic data), accounted for 30% of papers in the corpus.

As most papers focus on vehicle and operations, it comes as no surprise that they have the highest representation in most data types. Among the 150 papers based on open data, 108 are on vehicle and operations blocks. Simulated or synthetic data were only found in papers dedicated to vehicle and operations. These papers mainly presented modeling results. Similarly, restricted data concerned in majority these two blocks. 36 among the 69 papers that produced their own data were papers from the demand block. In most cases, these papers showed the results of user surveys.

Among the 150 papers based on open data, 82 referred to proofs of concept (TRL-3) and 44 to TRL-2. The higher the TRL, the more probable it was that the researchers would produce their own data.

### *Funding partnerships*

Only half of the corpus (148 papers) explicitly mentioned specific (external) funding contributions to the research. The US institutions dominated not only the process of research production but also the funding of research. The US Department of Transportation was the most prominent funder with funding contributions to 37 papers over the 5-year period. The Department reaffirmed its effort to support research on AV technology in its Strategic Plan for 2018-2022 (11). It was followed by the US National Science Foundation (26 papers funded) and the US FHWA (11 papers funded). The specific role played by the FHWA in promoting AVs is worth noticing. The other key funders were the California State Transportation Agency (11 papers funded) and the Texas

1 Department of Transportation (10 papers funded). A clear relationship was established between  
2 Departments of Transportation of California and Texas and the research they funded in the state-  
3 owned Universities of California at Berkeley and of Texas at Austin.

4 With 9 papers funded, the National Natural Science Foundation of China was among the  
5 top 5 funders. This institution along with other Chinese institutions (like the Ministries of  
6 Transport and Science and Technology or the Fundamental Research Funds for the Central  
7 Universities) illustrated the support of the Chinese national government to research on AV  
8 technology. Like in the case of the US, research on AV technology in China was also supported  
9 by state governments such as the Sichuan and Jiangsu provinces.

10 The role of national governments and institutions as the main funders of AV research was  
11 also verified in other countries like Japan, South Korea, Qatar or European countries. However,  
12 European countries remained quite specific. Their research was not only funded by governments or  
13 agencies at national and regional scales but also by the European Union and to a lesser extent by  
14 the automotive sector.

15 In general, the private sector was lagging behind the public sector in terms of funding  
16 contributions to TRB papers on AV technology. Only 5% of the funders belonged to the private  
17 sector. It should be noted that the authors could not trace the amounts of funding involved and  
18 therefore do not presume which category of funding partners had the greatest financial  
19 contribution. Companies from the digital economy, such as Google or Uber, were not mentioned  
20 among the funders of the 298 papers. Moreover, they were not frequently mentioned in the corpus  
21 as for example the Google Car and Uber were mentioned in only 4 papers each and Tesla in 6  
22 papers.

23 A last finding was that some cities like Toronto in Canada or Tsukuba in Japan financially  
24 supported research on AV technology, although in most cases cities were acknowledged for  
25 contributions in kind.

## 26 **DISCUSSION AND PERSPECTIVES**

27 If early research on autonomous vehicles dates back to before 2010 (4; 5), a turning point occurred  
28 around the middle of the decade. Since that time, research on AV has rapidly expanded and  
29 evolved. The pace especially accelerated in the last 2 years, as illustrated by the portion of papers  
30 examined here that were dated 2017 (25%) or 2018 (49%). This trend will very likely continue in  
31 the coming years.

32 This trend has implications regarding the production of research on AVs. More  
33 institutions belonging to different countries have started to contribute. The increase in research  
34 production comes along with a diversification of contributors. Although the United States still  
35 have center stage, other countries such as the Netherlands or China are becoming increasingly  
36 prominent, at least on the TRB stage. Scientific fields have become more diverse. Beside  
37 traditional disciplines like robotics, computer science or engineering, domains related to policy  
38 and society have been better represented lately, underlining an AV ecosystem in construction.

39 So far, scholarly efforts have been mainly concentrated on the building blocks of  
40 knowledge regarding the vehicle and its components or operations. Technological aspects of  
41 vehicle automation still represent a major part of the knowledge building effort of research, as  
42 noticed by prior research (4, 5). Proofs of concept (i.e. early stages of technology maturity)  
43 dominate in recent research. The implications of autonomous vehicles in terms of demand and  
44 governance are still under-researched. One assumption is that with more advanced TRLs (based  
45 on real-life experiments), more studies on governance and demand will be needed. For now,  
46 most of demand-oriented research consists in surveys and models based on situations that  
47

1 respondents have not yet experienced. Another assumption is that, on the topic of governance  
2 particularly, there has been a growth in grey literature on planning and regulation options for  
3 AVs. yet, because much of such projections and analyses are still speculative, fewer papers on  
4 such topics are likely to be presented at TRB Annual Meetings (if written at all). Governance-  
5 oriented research already involves technologies at a more advanced stage of maturity, which may  
6 reflect the regulator's need to adopt explicit positions to guide AV deployment.

7 Not a single paper was found to involve a TRL-8 or a TRL-9 technology, and very few  
8 involved technologies rated beyond TRL-3 ("proof of concept"). One reason could be the pace of  
9 research production, which could generate delays between actual advances in technology and  
10 their reflection in research. Another reason could stem from car manufacturers (and other AV  
11 players from the IT industry) being reluctant to partner for research production as AV-related  
12 innovations become increasingly sensitive (strategically and commercially) as they make  
13 progress on the TRL scale (3).

14 Academic research appears to play a supporting role (8) in the AV innovation  
15 ecosystem, involving direct value creation especially in fundamental research. Public funds at  
16 national and regional levels, especially in the US and in China, appear to play an important part  
17 in the production of academic research on AVs. AV investments in the US range from federal  
18 programs to local collaborations (12), whereas in Europe, funding from the European Union or  
19 car manufacturers is more common. The role of research could change in the near future, as a go-  
20 between actor between regulators and innovators, between the general interest and private  
21 interests, will be increasingly needed along the process of AV deployment.

22 This paper presents some limitations. As mentioned in the methodology section, the  
23 corpus has a geographical and language bias. It will be necessary to update and enlarge this  
24 selected body of papers to achieve better representation of research published on AVs around the  
25 world. A first step will be to include papers from additional academic journals. In parallel,  
26 analyses based on grey literature such as transportation plans (13) and on news articles should be  
27 considered at they could help to fill the gap between academic research and local policies and  
28 between academic research and the private sector. The categorization process developed for this  
29 research could be applied to such different kinds of documents in order to better understand and  
30 characterize the AV ecosystem that is currently under construction.

31 Research on AVs is now at a turning point as real-life experiments undergo rapid  
32 expansion. Users and more generally citizens appear to remain out of the scope of most of the  
33 innovation and research effort for now. Will academic research help them take center stage?  
34 Research might be ready to address a wide range of issues raised by automated mobility. But will  
35 it manage to keep pace? The authors hope this review can provide useful insights for TRB  
36 standing committees as to the categories of research that should be encouraged in future years.  
37 Especially, as far as governance research is concerned, a dedicated call for papers could be  
38 considered advisable.
