Abstract

On the example of a pure exchange financial economy with two periods, incomplete markets and differential information of the adverse selection's type, Cornet-De Boisdeffre (2002) introduced refined concepts of price, arbitrage and so-called "no-arbitrage equilibria", which extended to the asymmetric information setting the classical concepts of symmetric information. In this paper, we prove that a no-arbitrage equilibrium exists under the same standard conditions with symmetric and asymmetric information.

## 1 Introduction

An enlarged arbitrage theory with differential information, a refined concept of no-arbitrage price and a corresponding notion of "no-arbitrage" equilibrium were introduced in Cornet-De Boisdeffre (2002), on the example of a two-period pure exchange financial economy, with incomplete nominal-asset markets and asymmetric information of the adverse selection's type. In our setting, agents could infer information from prices without having rational expectations, that is, a model of how equilibrium prices are determined. Our concepts of price and equilibrium were shown to coincide with the classical notions under symmetric information and to extend them to the asymmetric information case.

In this paper, we study the properties of the no-arbitrage equilibrium and show its existence is guaranteed, for any structure of information, which yields no agent an arbitrage, under the same standard conditions, whether agents have symmetric or asymmetric information. This result departs from the classical generic existence property of rational expectations equilibrium models with asymmetric information.

Section 2 presents the main characteristics and definitions of the model: information structures and refinements, markets, consumers' behavior and the concept of "no-arbitrage equilibrium". Applying the Gale-Mas-Colell fixed point-like theorem, Section 3 proves that a no-arbitrage equilibrium exists under standard conditions.

## 2 The basic model

We consider a pure-exchange economy $\mathcal{E}$ with two periods $(t=0$ and $t=1)$. At the first period $(t=0)$, there is an a priory uncertainty about which state $s$ of a finite space $S$ will prevail at the second period $(t=1)$. There are finitely many agents $i \in I:=\{1, \ldots, m\}$, exchanging $L$ commodities $l \in\{1, \ldots, L\}$ and $J$ nominal assets $j \in\{1, \ldots, J\}$, paying off at the second period. For convenience, we let $s=0$ denote the non-random state at $t=0$ and $\Sigma^{\prime}:=\{0\} \cup \Sigma$, for every (nonempty) subset $\Sigma \subset S$.

This Section recalls the specification of risk and information, markets, consumers' behavior, arbitrage properties of the model and our concept of equilibrium with differential information, based on the no-arbitrage condition.

### 2.1 Information structures and refinements

During the first period, every agent $i \in I$ receives a private signal in the form of a subset $S_{i}$ of $S$, called an "information set", which informs the agent
that an arbitrary state $s \in S_{i}$ will prevail at $t=1$. Whenever possible, agents will seek to further reduce their information sets by inferring information from observing market prices. If agents' information is correct, as always assumed in the model, their information sets contain the so-called "true" state, which will be disclosed at $t=1$, and, hence, these sets have a non-empty intersection. This yields the following definitions of information structures and refinements.

Definition $1 A$ collection $\left(\Sigma_{i}\right)$ of $m$ subsets $\Sigma_{i} \subset S$ is said to define an information structure (or structure) if $\cap_{i=1}^{m} \Sigma_{i} \neq \emptyset$. A structure $\left(\Sigma_{i}\right)$ is said to be symmetric if all the $\Sigma_{i}$ are equal. Given two information structures $\left(\Sigma_{i}^{1}\right)$ and $\left(\Sigma_{i}^{2}\right)$, we say that $\left(\Sigma_{i}^{2}\right)$ is coarser than $\left(\Sigma_{i}^{1}\right)$, or that $\left(\Sigma_{i}^{1}\right)$ is finer than (or "refines", or "a refinement of") ( $\Sigma_{i}^{2}$ ), if $\Sigma_{i}^{1} \subset \Sigma_{i}^{2}$, for every $i \in I$, and we denote it by $\left(\Sigma_{i}^{1}\right) \leq\left(\Sigma_{i}^{2}\right)$. The pooled refinement of a given structure $\left(\Sigma_{i}\right)$ is the symmetric structure $\left(\underline{\boldsymbol{\Sigma}}_{i}\right)$ defined by $\underline{\boldsymbol{\Sigma}}_{i}:=\cap_{j=1}^{m} \Sigma_{j}$ for every $i \in I$. A refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$ is said to be self-attainable if it is coarser than the pooled refinement $\left(\underline{\mathbf{S}}_{i}\right)$, that is, if $\cap_{i=1}^{m} S_{i}=\cap_{i=1}^{m} \Sigma_{j}$. We shall denote by $\Gamma$ the set of all information structures. Given $\left(\Sigma_{i}\right) \in \Gamma$ and a payoff matrix $V$, the couple [ $\left.V,\left(\Sigma_{i}\right)\right]$ will also be called a (payoff and information) structure.

Remark 1: since every information set $S_{i}($ for $i \in I)$ contains the true state in the economy $\mathcal{E}$, the collection $\left(S_{i}\right)$ defines a structure and every set $\Sigma_{i}$ (for $i \in I)$ of a self-attainable refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$ also contains the true state.

### 2.2 Markets and consumers' behavior

There are two markets: one for assets and one for commodities.
The financial market permits limited income transfers across periods and states, via $J$ nominal assets $j \in\{1, \ldots, J\}$, whose payoffs in each state $s \in S$, denoted by $v_{j}[s]$, define a $S \times J$-matrix $V$. The payoff matrix $V$ is assumed to be of full column-rank and known by all agents. Denoting by $q \in \Re^{J}$ the asset price, a portfolio is a vector $z \in \Re^{J}$, tradable for $q \cdot z$ monetary units at $t=0$, against the promise of a flow $V \cdot z$ of contingent payoffs at $t=1$.

There also exist $\# S^{\prime}$ spot markets for the $L$ commodities $l \in\{1, \ldots, L\}$, which may be consumed at both dates. Given a price $p \in\left(\Re^{L}\right)^{S^{\prime}}$ and a subset $\Sigma$ of $S$, we denote by $p\left(\Sigma^{\prime}\right)$ trucation of $p$ on $\left(\Re^{L}\right)^{\Sigma^{\prime}} .{ }^{2}$

[^1]For every (nonempty) subset $\Sigma \subset S$, the generic agent $i \in I$ has, conditionnally on the information set $\Sigma$ she may reach during the first period, a consumption set $X_{i}^{\Sigma}:=\left\{x \in\left(\Re_{+}^{L}\right)^{S^{\prime}}: x[s]=0\right.$ for every $\left.s \in S \backslash \Sigma\right\}$, an endowment, $e_{i}^{\Sigma} \in X_{i}^{\Sigma}$, and a preference correspondence $P_{i}^{\Sigma}$ on consumptions. For every $x \in X_{i}^{\Sigma}$, the set $P_{i}^{\Sigma}(x)$ is defined as the subset of consumptions $y \in X_{i}^{\Sigma}$, which are strictly preferred to $x$ (hence, $x \notin P_{i}^{\Sigma}(x)$ ). Generalizing Cornet-De Boisdeffre (2002), this definition encompasses the case of preferences represented by a binary relation $\preccurlyeq_{i}^{\Sigma}$ and, in particular, by a conditional utility function $u_{i}^{\Sigma}: X_{i}^{\Sigma} \rightarrow \Re$. Using the notations in footnote, agents' preferences and endowments are assumed to meet the following conditions.

Given a price system $(p, q) \in\left(\Re^{L}\right)^{S^{\prime}} \times \Re^{J}$, the generic agent $i \in I$ detaining the information $\Sigma$ (for $\Sigma \subset S$ ) admits the following budget set, whose elements are called "strategies":

Given an information structure $\left(\Sigma_{i}\right)$, a collection $x:=\left(x_{i}\right) \in \Pi_{i=1}^{m} X_{i}^{\Sigma_{i}}$ is called an "allocation". When $\sum_{i=1}^{m}\left(x_{i}[s]-e_{i}^{\Sigma_{i}}[s]\right)=0$, for every $s \in \cap_{i \in I} \Sigma_{i}^{\prime}$, the allocation is said to be "attainable". Given a structure $\left(\Sigma_{i}\right)$, we denote by

for every price system $(p, q) \in\left(\Re^{L}\right)^{S^{\prime}} \times \Re^{J}$, the set of attainable strategies.
The generic $i^{t h}$ agent's problem, when her information set is $\Sigma_{i}$, is to elect a strategy that will optimize her welfare. If, during the first period, every agent $i \in I$ receives a private signal $S_{i} \subset S$, refines her information set up to $\Sigma_{i} \subset S_{i}$ and, then, defines her strategy, the solution (for $\left(\underline{\mathbf{S}}_{i}\right) \leq\left(\Sigma_{i}\right) \leq\left(S_{i}\right)$ ) yields the following concept of "no-arbitrage" equilibrium.

Definition 2 A price system $\left(p^{*}, q^{*}\right) \in\left(\Re^{L}\right)^{S^{\prime}} \times \Re^{J}$, a self-attainable refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$ and a collection of strategies $\left(x_{i}^{*}, z_{i}^{*}\right) \in B_{i}^{\Sigma_{i}}\left(p^{*}, q^{*}\right)$, for $i=$ $1, \ldots m$, define an equilibrium of the economy $\mathcal{E}$, or "no-arbitrage" equilibrium, if: (i) $\forall i \in I, P_{i}^{\Sigma_{i}}\left(x_{i}^{*}\right) \cap B_{i}^{* \Sigma_{i}}\left(p^{*}, q^{*}\right)=\emptyset$;
(ii) $\forall s \in \cap_{i \in I} \Sigma_{i}^{\prime}, \sum_{i \in I} x_{i}^{*}[s]=\sum_{i \in I} e_{i}^{\Sigma_{i}}[s]$;
(iii) $\sum_{i \in I} z_{i}^{*}=0$.

Remark 2 Apart from the use of preference correspondences, the above specification of the economy differs from Cornet-De Boisdeffre's (2002) on one formal point: we had previously defined the consumption set of the generic agent $i \in I$ detaining the information $\Sigma_{i} \subset S$ as $\left(\Re_{+}^{L}\right)^{\Sigma_{i}^{\prime}}$ (and, accordingly, endowments, budget sets and attainable allocations). Now, we let agents' consumption plans belong to a same vector space, namely $\left(\Re^{L}\right)^{S^{\prime}}$, whatever their information. This equivalent specification will be convenient for proving the existence of equilibrium in Section 3. It should be clear, however, that consumptions in unrealizable states have no economic meaning and could be set arbitrary.

We now present some basic properties of the model.

### 2.3 Properties of the no-arbitrage equilibrium

We present two types of properties. First, we recall arbitrage properties of equilibrium with asymmetric information, which permit to tackle the issue of information conveyed by prices in the absence of rational expectations and lead to a refined concept of "price-revealed" equilibrium. Second, we introduce properties of attainable allocations and strategies, which will help bound the economy and apply a fixed-point-like argument in Section 3.

### 2.3.1 Arbitrage properties

We first recall the following definitions from Cornet-De Boisdeffre (2002).

Definition 3 Let a structure $\left[V,\left(\Sigma_{i}\right)\right]$ be given. A price $q \in \Re^{J}$ is said to be a common no-arbitrage price of the structure $\left[V,\left(\Sigma_{i}\right)\right]$, or the structure $\left[V,\left(\Sigma_{i}\right)\right]$ to be q-arbitrage-free, if one of the following equivalent assertions holds:
(i) there is no agent $i \in I$ and portfolio $z_{i} \in \Re^{J}$ such that $-q \cdot z_{i} \geq 0$ and $V\left[s_{i}\right]$. $z_{i} \geq 0$ for every $s_{i} \in \Sigma_{i}$, with at least one strict inequality;
(ii) for every $i \in I$, there exists $\lambda_{i}=\left(\lambda_{i}[s]\right) \in \Re_{++}^{\Sigma_{i}}$, such that $q=\sum_{s \in \Sigma_{i}} \lambda_{i}[s] V[s]$. We denote by $Q_{c}\left[V,\left(\Sigma_{i}\right)\right]$ the set of common no-arbitrage prices of $\left[V,\left(\Sigma_{i}\right)\right]$. The structure $\left[V,\left(\Sigma_{i}\right)\right]$ is said to be arbitrage-free if $Q_{c}\left[V,\left(\Sigma_{i}\right)\right] \neq \emptyset$.
We say that $q \in \Re^{J}$ is a no-arbitrage price if there exists a refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$, such that $q \in Q_{c}\left[V,\left(\Sigma_{i}\right)\right]$. Moreover, if the refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$ is selfattainable, $q \in Q_{c}\left[V,\left(\Sigma_{i}\right)\right]$ is said to be self-attainable. We denote by $Q\left[V,\left(S_{i}\right)\right]$ the set of no-arbitrage prices and by $\underline{Q}\left[V,\left(S_{i}\right)\right]$ the subset of self-attainable prices. When no confusion is possible, the reference to $V$ is omitted in all notations and we use the term of arbitrage-free or $q$-arbitrage-free information structure.

We recall that a symmetric structure is always arbitrage-free and, hence, that the set of (self-attainable) no-arbitrage prices, which contains $Q_{c}\left[V,\left(\underline{\mathbf{S}}_{i}\right)\right]$, is never empty. We can now present the following properties.

Claim 1 Let a price system $(p, q) \in\left(\Re^{L}\right)^{S^{\prime}} \times \Re^{J}$ and a refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$ be given. The following Assertions hold:
(i) under Assumptions A1 and A3, if the price system $(p, q)$, the refinement $\left(\Sigma_{i}\right)$ and a collection of strategies $\left(x_{i}, z_{i}\right) \in B_{i}^{\Sigma_{i}}(p, q)$, for $i=1, \ldots, m$, meet Condition ( $i$ ) of the definition of the no-arbitrage equilibrium, then $q$ is a common no-arbitrage price of the structure $\left[V,\left(\Sigma_{i}\right)\right]$ (i.e., $q \in Q_{c}\left[V,\left(\Sigma_{i}\right)\right]$ ) and, hence, $\left[V,\left(\Sigma_{i}\right)\right]$ is arbitrage-free;
(ii) the structure $\left(\Sigma_{i}\right)$ is arbitrage-free if and only if it satisfies the following "AFAO" Condition ("Absence of Future Arbitrage Opportunities"): there is no $\left(z_{i}\right) \in\left(\Re^{J}\right)^{I}$ such that $\sum_{i \in I} z_{i}=0$ and $V\left[s_{i}\right] \cdot z_{i} \geq 0$ for all $i \in I$ and all $s_{i} \in \Sigma_{i}$, with at least one strict inequality;
(iii) if $q$ is a no-arbitrage price (i.e., $q \in Q\left[V,\left(S_{i}\right)\right]$ ), there exists a coarsest $q$-arbitrage-free refinement of $\left(S_{i}\right)$, denoted by $\left(\mathbf{S}_{i}(q)\right){ }^{3}$ If $q$ is self-attainable, then $\left(\mathbf{S}_{i}(q)\right)$ is self-attainable. Moreover, if agents have private information represented by $\left(S_{i}\right)$, they may always refine their information up to the structure $\left(\mathbf{S}_{i}(q)\right)$ from observing that price $q$. Therefore, the structure $\left(\mathbf{S}_{i}(q)\right)$ is said to be"revealed" by price $q$;
(iv) the set of arbitrage-free refinements of $\left(S_{i}\right)$ contains a coarsest element, denoted by $\left(\overline{\mathbf{S}}_{i}\right)$, which is self-attainable, revealed by any price $\bar{q} \in Q_{c}\left[V,\left(\overline{\mathbf{S}}_{i}\right)\right]$ and equal to $\left(S_{i}\right)$ if, and only if, $\left(S_{i}\right)$ is arbitrage-free. ${ }^{4}$

Proof See Cornet-De Boisdeffre (2002). ${ }^{5}$

[^2]The concept of no-arbitrage equilibrium does not explain how agents $i \in I$, starting from their signal sets $S_{i}$ and observing an equilibrium price $q$ can infer in a decentralized manner from that price the refinement of information $\left(\Sigma_{i}\right)$ of equilibrium. The properties recalled above permit to tackle this issue and to refine the concept of no-arbitrage equilibrium as follows.

Definition 4 A no-arbitrage equilibrium $\left[\left(p^{*}, q^{*}\right),\left(\Sigma_{i}\right),\left[\left(x_{i}^{*}, z_{i}^{*}\right)\right]\right] \in\left(\left(\Re^{L}\right)^{S^{\prime}} \times\right.$ $\left.\Re^{J}\right) \times \Gamma \times \Pi_{i=1}^{m} B_{i}^{\Sigma_{i}}\left(p^{*}, q^{*}\right)$ is called a"coarse information equilibrium" (C.I.E.), if $\left(\Sigma_{i}\right)=\left(\overline{\mathbf{S}}_{i}\right)$, and a"price-revealed equilibrium" (P.R.E.), if $\left(\Sigma_{i}\right)=\left(\mathbf{S}_{i}\left(q^{*}\right)\right)$.

When agents have no model of how equilibrium prices are determined (that is, rational expectations), the two latter concepts of equilibrium extend naturally to the asymmetric information setting the classical notion of financial equilibrium. Indeed, a coarse information equilibrium coincides with the classical notion of financial equilibrium when $\left(S_{i}\right)$ is symmetric. Moreover, since $\left(\overline{\mathbf{S}}_{i}\right)=\left(\mathbf{S}_{i}(q)\right)$ for every $q \in Q_{c}\left[\left(\overline{\mathbf{S}}_{i}\right)\right]$, a coarse information equilibrium is always a price-revealed equilibrium (the converse is not true). Thus, both concepts embed the requirement that the information structure be revealed by prices.

In Section 3, we show that, for any given structure $\left[V,\left(S_{i}\right)\right]$ and any selfattainable arbitrage-free refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$, there exists a no-arbitrage equilibrium relative to the refinement $\left(\Sigma_{i}\right)$. Hence, taking $\left(\Sigma_{i}\right)=\left(\overline{\mathbf{S}}_{i}\right)$, a coarse information equilibrium will always exist. But we need to introduce, first, other useful properties of the model.

### 2.3.2 Bounding attainable strategies

In the remainder of this section, we consider as given an arbitrary selfattainable arbitrage-free refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$, assumed to represent agents' final information at the first period. Our aim is now to show that we can bound agents' portfolios and consumptions in the equilibrium problem.

First, we consider the vector spaces:

We then let $\varepsilon>0$, be an arbitrary small, but positive, given number and we define the following price sets:

We can now state a useful property.
Claim 3 Let the arbitrage-free refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$ and a price set $\Pi_{\varepsilon}^{\left(\Sigma_{i}\right)}$, as defined above, be given. Then, there exists $r>0$, such that: $\left[(p, q) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)}\right.$ and $\left.(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)\right] \Longrightarrow[\|x\|+\|z\|<r]$.

## Proof

- First, we let $\Sigma:=\cap_{i \in I} \Sigma_{i}=\cap_{i \in I} S_{i}$ and show the existence of $r^{1}$ such that: $\left[(p, q) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)}\right.$ and $\left.(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)\right] \Longrightarrow\left[\left\|x\left(\Sigma^{\prime}\right)\right\|<r^{1}\right]$.

Indeed, for each $i \in I$, the consumption set $X_{i}^{\Sigma_{i}} \subset\left(\Re_{+}^{L}\right)^{S^{\prime}}$ is bounded by zero. Denoting $\alpha:=\max _{(i, s, l) \in I \times S^{\prime} \times\{1, \ldots, L\}}\left(e^{\Sigma_{i}}\right)^{l}[s]$, we let $(p, q) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)}$ and $(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)$ be given. Then, $x:=\left(x_{i}\right) \in \mathcal{A}^{\left(\Sigma_{i}\right)}$ implies that, for each $i \in I, 0 \leq x_{i}\left(\Sigma^{\prime}\right) \leq \sum_{j \in I \backslash\{i\}} e^{\Sigma j}\left(\Sigma^{\prime}\right)$, hence, $\left\|x_{i}\left(\Sigma^{\prime}\right)\right\| \leq m L\left(\# S^{\prime}\right) \alpha$. This yields: $\left[(p, q) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)} \&(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)\right] \Longrightarrow\left[\left\|x\left(\Sigma^{\prime}\right)\right\|<r^{1}:=m^{2} L\left(\# S^{\prime}\right) \alpha\right]$.

- Second, we show that, for every $M>0$, there exists $r^{M}$ such that: $\left[(p, q) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)},(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)\right.$ and $\left.\|z\|<M\right] \Longrightarrow\left[\|x\|<r^{M}\right]$.

Indeed, denoting $\beta:=\max _{(s, j) \in S^{\prime} \times\{1, \ldots, J\}}\left|v_{j}[s]\right|$, let $M>0,(p, q) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)}$ and $(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)$ be given, such that $\|z\|<M$. From the definition of $\Delta_{\varepsilon}^{\left(\Sigma_{i}\right)}, 0 \leq x_{i}^{l}[s]<\frac{1+\beta M J}{\varepsilon}+\alpha$, for each $(i, l) \in I \times\{1, \ldots, L\}$ and each $s \in \Sigma_{i} \backslash \Sigma$. Let $\gamma^{M}:=\frac{1+\beta M J}{\varepsilon}+\alpha$ and $r^{M}:=r^{1}+\operatorname{Lm}\left(\# S^{\prime}\right) \gamma^{M}$. Then, from above, $\|x\|<r^{M}$.

- Third, we prove, by contraposition, that there exists $r^{2}>0$, such that: $\left[(p, q) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)}\right.$ and $\left.(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)\right] \Longrightarrow\left[\|z\|<r^{2}\right]$.

Assume that the property fails, that is, for every positive integer $n$, there exist $\left(p^{n}, q^{n}\right) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)}$ and $\left(x^{n}, z^{n}\right) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}\left(p^{n}, q^{n}\right)$, such that $\left\|z^{n}\right\|>n$. Let $z^{\prime n}:=\frac{z_{n}}{\left\|z_{n}\right\|}$ for every $n \geq 1$. Each set $\overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}\left(p^{n}, q^{n}\right)$ is closed and convex and contains $(e, 0):=\left[\left(e_{i}^{\Sigma_{i}}, 0\right)\right]$. For every $n \geq 1$, we let $x^{\prime n}:=\frac{1}{\left\|z_{n}\right\|} x^{n}+\left(1-\frac{1}{\left\|z_{n}\right\|}\right) e$.

Clearly, for every $n>1,\left\|z^{\prime n}\right\|=1$ and $\left(x^{\prime n}, z^{\prime n}\right) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}\left(p^{n}, q^{n}\right)$. From above, the sequences $\left(x^{\prime n}, z^{\prime n}\right)$ and $\left(p^{n}, q^{n}\right)$, are bounded in some Euclidean space and in a compact set, and may be assumed to converge, say, towards $(x, z)$ and $(p, q) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)}$, and, by continuity of the scalar product, $\|z\|=1$ and $(x, z) \in$ $\overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)$.

Given $N>1$, we let, for every $n>N, x_{N}^{n}:=\frac{N}{\left\|z_{n}\right\|} x^{n}+\left(1-\frac{N}{\left\|z_{n}\right\|}\right) e$. By the same token, for $n>N,\left(x_{N}^{n}, N z^{\prime n}\right) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}\left(p^{n}, q^{n}\right)$ and the sequence $\left[\left(x_{N}^{n}, N z^{\prime n}\right)\right]_{n>N}$ may be assumed to converge to some $\left(x_{N}, z_{N}\right) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)$, such that $z_{N}=N z$ (for the same limits $z:=\left(z_{i}\right)$ and $(p, q)$ as above). Considering the sequence $\left[\left(x_{N}, z_{N}\right)\right]$, for $N>1$, one has, for every $N,\left(x_{N}, z_{N}\right) \in$ $\overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)$ and $z_{N}=N z$, with $\|z\|=1$.

All consumption sets being bounded from below, this latter condition implies $V\left[s_{i}\right] \cdot z_{i} \geq 0$, for every $i \in I$ and every $s_{i} \in \Sigma_{i}$, whereas $\sum_{i=1}^{m} z_{i} \in Z^{\left(\Sigma_{i}\right)}$ (since $\left.(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)\right)$. From the AFAO Condition, this implies $z_{i} \in Z^{\Sigma_{i}}$, for every $i \in I$. However, $(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)$ yields $z:=\left(z_{i}\right) \in \Pi_{i=1}^{m} Z^{\Sigma_{i} \perp}$. Hence, $z_{i} \in Z_{i}^{\Sigma_{i}} \cap Z_{i}^{\Sigma_{i} \perp}=\{0\}$, for every $i \in I$, that is, $z=0$, which contradicts the condition $\|z\|=1$. This contradiction proves the existence of some $r^{2}>0$, such that: $\left[(p, q) \in \Pi_{\varepsilon}^{\left(\Sigma_{i}\right)}\right.$ and $\left.(x, z) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)\right] \Longrightarrow\left[\|z\|<r^{2}\right]$.

- Finally, from above, Claim 3 holds for $r=M+r^{M}$, with $M=r^{2}$.

We can now examine existence properties.

## 3 An existence theorem for no-arbitrage equilibria

First, we state the main theorem of the model and define a notion of pseudoequilibrium, whose existence will insure the desired property. Next, we prove that a pseudo-equilibrium exists, along a standard fixed-point-like argument.

### 3.1 The existence theorem

We now state the main theorem of the paper.

Theorem 1 Under Assumptions A1 to A3, given a structure $\left[V,\left(S_{i}\right)\right]$ and a self-attainable arbitrage-free refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$, there exists a price system $(p, q) \in \Delta \times Q_{c}\left[V,\left(\Sigma_{i}\right)\right]$ and a collection of strategies $\left[\left(x_{i}, z_{i}\right)\right] \in \Pi_{i=1}^{m} B_{i}^{\Sigma_{i}}(p, q)$, such that $p[s] \neq 0$ for every $s \in \cup_{i \in I} \Sigma_{i}^{\prime}$ and $\left[(p, q),\left(\Sigma_{i}\right),\left[\left(x_{i}, z_{i}\right)\right]\right]$ defines a no-arbitrage equilibrium. In particular, for any structure $\left[V,\left(S_{i}\right)\right]$, there exists a coarse information equilibrium.

To prove this theorem, we henceforth consider as given a self-attainable arbitrage-free refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$ and we will assume, non restrictively, that $S=\cup_{i \in I} \Sigma_{i} .{ }^{7}$

We let a small $\varepsilon>0$ be given and, as above, we consider the price sets:
$\Delta_{\varepsilon}^{\left(\Sigma_{i}\right)}:=\left\{p \in\left(\Re^{L}\right)^{S^{\prime}}:\|p[s]\| \leq 1, \forall s \in S^{\prime}, p^{l}[s] \geq \varepsilon, \forall l \in\{1, \ldots, L\}, \forall s \notin \cap_{i} S_{i}^{\prime}\right\}$, $Q:=\left\{q \in Z^{\perp}:=\cap_{i \in I} Z^{\Sigma_{i} \perp}:\|q\| \leq 1\right\}$ and we simply denote $\Pi:=\Delta_{\varepsilon}^{\left(\Sigma_{i}\right)} \times Q$.

We set some upper bound $r$, satisfying the Condition of Claim 3 relative to $\Pi$. We denote by $B_{r}$ and $B_{r}^{J}$ the closed centered balls of radius $r$ of, respectively, $\left(\Re^{L}\right)^{S^{\prime}}$ and $\Re^{J}$, and let, for every $i \in I$ and every $(p, q) \in \Pi$ :

We now introduce a notion of "pseudo-equilibrium", in relation to that of no-arbitrage equilibrium.

Definition 5 Given the refinement $\left(\Sigma_{i}\right)$, a price $\operatorname{system}(p, q) \in \Pi$ and a collection of strategies $\left(x_{i}, z_{i}\right) \in B_{i}(p, q)$, for $i=1, \ldots, m$, define a pseudo-equilibrium of the economy $\mathcal{E}$ if:
(i) $\forall i \in I, P_{i}(x) \cap B_{i}^{*}(p, q)=\emptyset$, where $x:=\left(x_{i}\right) \in \Pi_{i=1}^{m} X_{i}$;
(ii) $\forall s \in \cap_{i} S_{i}^{\prime}, \sum_{i \in I}\left(x_{i}[s]-e_{i}[s]\right)=0$;
(iii) $\sum_{i \in I} z_{i} \in Z^{\left(\Sigma_{i}\right)}$.

For every $i \in I$ and every $z_{i} \in \Re^{J}$, we shall henceforth denote by $z_{i}^{i \perp}$ the orthogonal projection of $z_{i}$ on $Z^{\Sigma_{i} \perp}$. The relationships between the two concepts of pseudo-equilibrium and no-arbitrage equilibrium can now be presented.

Claim 4 Let a price system $(p, q) \in \Pi$ and a collection of strategies $\left[\left(x_{i}, z_{i}\right)\right] \in$ $\Pi_{i=1}^{m} B_{i}^{\Sigma_{i}}(p, q)$ be given. Then,
(i) if $\left((p, q),\left(\Sigma_{i}\right),\left[\left(x_{i}, z_{i}\right)\right]\right) \in \Pi \times \Gamma \times \Pi_{i=1}^{m} B_{i}^{\Sigma_{i}}(p, q)$ defines a no-arbitrage equilibrium, then $\left((p, q),\left[\left(x_{i}, z_{i}^{i \perp}\right)\right]\right)$ is a pseudo-equilibrium;
(ii) if $\left((p, q),\left[\left(x_{i}, z_{i}\right)\right]\right)$ is a pseudo-equilibrium, then, for every $i \in I$, there exists $z_{i}^{*} \in \Re^{J}$, such that $z_{i}=z_{i}^{* i \perp}$ and $\left((p, q),\left(\Sigma_{i}\right),\left[\left(x_{i}, z_{i}^{*}\right)\right]\right)$ defines a noarbitrage equilibrium.

## Proof

(i) Assume that $\left((p, q),\left(\Sigma_{i}\right),\left[\left(x_{i}, z_{i}\right)\right]\right) \in \Pi \times \Gamma \times \Pi_{i=1}^{m} B_{i}^{\Sigma_{i}}(p, q)$ defines a no-arbitrage equilibrium.

First, Conditions (ii) - (iii) of the Definition of a no-arbitrage equilibrium yield $\left.\left[\left(x_{i}, z_{i}\right)\right]\right] \in \mathcal{A}_{i}^{\left(\Sigma_{i}\right)}(p, q)$ and $\sum_{i \in I} z_{i}^{i \perp}=\sum_{i \in I}\left(z_{i}^{i \perp}-z_{i}\right) \in Z^{\left(\Sigma_{i}\right)}$. Referring to the above definitions, we then notice that $\left[\left(x_{i}, z_{i}^{i \perp}\right)\right] \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q):=$ $\left\{\left[\left(x_{i}, z_{i}\right)\right] \in \Pi_{i=1}^{m} \bar{B}_{i}^{\Sigma_{i}}(p, q):\left(x_{i}\right) \in \mathcal{A}^{\left(\Sigma_{i}\right)}, \sum_{i=1}^{m} z_{i} \in Z^{\left(Z_{i}\right)}\right\}$.

Hence, from Claim 3, $\left\|\left(x_{i}\right)\right\|+\left\|\left(z_{i}^{i \perp}\right)\right\|<r$. Consequently, the collection $\left[\left(x_{i}, z_{i}^{i \perp}\right)\right]$ belongs to $\Pi_{i=1}^{m} B_{i}(p, q)$ and satisfies $\left(x_{i}\right) \in \mathcal{A}, \sum_{i=1}^{m} z_{i}^{i \perp} \in Z^{\left(Z_{i}\right)}$, that is, Conditions (ii) and (iii) of the Definition of a pseudo-equilibrium.

Applying Condition $(i)$ of the Definition of the no-arbitrage equilibrium to $x:=\left(x_{i}\right) \in \mathcal{A}$ yields $P_{i}^{\Sigma_{i}}\left(x_{i}\right) \cap B_{i}^{* \Sigma_{i}}(p, q)=\emptyset$, for $i=1, \ldots, m$. Since $P_{i}(x) \subset$ $P_{i}^{\Sigma_{i}}\left(x_{i}\right)$ and $B_{i}^{*}(p, q) \subset B_{i}^{* \Sigma_{i}}(p, q)$, for every $i \in I$, the collection $\left[\left(x_{i}, z_{i}^{i \perp}\right)\right] \in$ $\Pi_{i=1}^{m} B_{i}(p, q)$ also meets Condition $(i)$ of the Definition of the pseudo-equilibrium and Claim 4-(i) holds.
(ii) Assume, now, that $\left((p, q),\left[\left(x_{i}, z_{i}\right)\right]\right) \in \Pi \times \Pi_{i=1}^{m} B_{i}(p, q)$ defines a pseudoequilibrium.

Then, from Condition (iii) of the above Definition, $\sum_{i \in I} z_{i} \in Z^{\left(\Sigma_{i}\right)}$, that is, $\sum_{i \in I} z_{i}=\sum_{i \in I} z_{i}^{\prime}$ for some collection $\left(z_{i}^{\prime}\right) \in \Pi_{i=1}^{m} Z^{\Sigma_{i}}$. Letting $\left(z_{i}^{*}\right):=$ $\left(\left[z_{i}-z_{i}^{\prime}\right]\right) \in\left(\Re^{J}\right)^{I}$, the collection $\left(z_{i}^{*}\right)$ satisfies $\left(z_{i}\right)=\left(z_{i}^{* i \perp}\right)$ and meets Condition (iii) of the definition of the no-arbitrage equilibrium, by construction. Moreover, the collection $\left[\left(x_{i}, z_{i}^{*}\right)\right.$ ] belongs to $\Pi_{i=1}^{m} B_{i}^{\Sigma_{i}}(p, q)$ and satisfies Condition (ii) of the definition of the no-arbitrage equilibrium, since $x:=\left(x_{i}\right) \in \mathcal{A}$.

Claim 4-(ii) will hold if we show that $\left[\left(x_{i}, z_{i}^{*}\right)\right]$ satisfies Condition $(i)$ of that definition.

Assume, by contraposition, that this is not the case, that is, there exists $i \in I$ and $\left(x_{i}^{\prime}, z_{i}^{\prime}\right) \in B_{i}^{\Sigma_{i}}(p, q)$, such that $x_{i}^{\prime} \in P_{i}^{\Sigma_{i}}\left(x_{i}\right)$. It is clear that $\left(x_{i}^{\prime}, z_{i}^{\prime \prime \perp}\right) \in$ $\widetilde{B}_{i}^{\Sigma_{i}}(p, q):=\left(X_{i}^{\Sigma_{i}} \times Z^{\Sigma_{i} \perp}\right) \cap B_{i}^{\Sigma_{i}}(p, q)$. Then, for every positive integer $n$, we define $x_{i}^{n}:=\left[x_{i}+\frac{1}{n}\left(x_{i}^{\prime}-x_{i}\right)\right]$ and $z_{i}^{n}:=\left[z_{i}+\frac{1}{n}\left(z_{i}^{\prime \perp}-z_{i}\right)\right] \in Z^{\Sigma_{i} \perp}$. Since $\widetilde{B}_{i}(p, q)$ is convex and contains $\left(x_{i}, z_{i}\right)$ and $\left(x_{i}^{\prime}, z_{i}^{\prime i \perp}\right)$, one has: $\left(x_{i}^{n}, z_{i}^{n}\right) \in \widetilde{B}_{i}(p, q)$, for every $n>0$. Yet, from Assumption $A 3, x_{i}^{n} \in P_{i}^{\Sigma_{i}}\left(x_{i}\right)$, for every $n>0$. Recalling the definition of a pseudo-equilibrium and of the set $\overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)$, we notice that $\left[\left(x_{i}, z_{i}\right)\right]$ belongs to $\overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}(p, q)$. Hence, from Claim $3\|x\|+\|z\|<r$. Therefore, there exists $N>0$, such that $\left\|x_{i}^{N}\right\|<r$ and $\left\|z_{i}^{N}\right\|<r$, that is, $\left(x_{i}^{N}, z_{i}^{N}\right) \in$ $B_{i}(p, q)$ and $x_{i}^{N} \in P_{i}(x):=X_{i} \cap P_{i}^{\Sigma_{i}}\left(x_{i}\right)$. Hence, $x_{i}^{N} \in B_{i}^{*}(p, q) \cap P_{i}(x)$, which contradicts Condition $(i)$ of the definition of the pseudo-equilibrium for $[(p, q),(x, z)]$. This completes the proof.

From Claim 4 and the fact that the self-attainable arbitrage-free refinement $\left(\Sigma_{i}\right)$ of $\left(S_{i}\right)$ has been chosen arbitrary, Theorem 1 will be proven if we display a pseudo-equilibrium along Definition 5. This is the final step of the paper.

### 3.2 The existence proof

To prove the existence of a pseudo-equilibrium, we introduce correspondences on the bounded sets ( $X_{i}, Z_{i}, \Pi \ldots$ ), which will yield an equilibrium, along successive Claims, derived from standard proofs of the symmetric information literature (e.g., Florenzano's, 1999). Following Bergstrom (1976), we thus define, for each $i=1, \ldots, m$ and each $(p, q) \in \Pi$, the modified budget sets:

where $\gamma_{i}(p, q) \in \Re^{\Sigma_{i}^{\prime}}$ is defined by:
$\gamma_{i}(p, q)[0]:=1-\min (1,\|p[0]\|+\|q\|)$, $\gamma_{i}(p, q)[s]:=1-\|p[s]\|$ for every $s \in \cap_{i} \Sigma_{i}=\cap_{i} S_{i}$ and $\gamma_{i}(p, q)[s]:=0$ for every $s \in \Sigma_{i} \backslash\left(\cap_{i} S_{i}\right)$.

Claim 5 For every $i \in I$, and every $(p, q) \in \Pi, B_{i}^{\prime \prime}(p, q) \neq \emptyset$.
Proof Let $i \in I$ and $(p, q) \in \Pi$ be given. From Assumption A2, we can choose $x \in X_{i}$, such that $\left[p_{\square}\left(x-e_{i}\right)\right]\left(\Sigma_{i}^{\prime}\right) \leq 0$, with a strict inequality in any state $s \in \Sigma_{i}^{\prime}$ such that $p[s] \neq 0$ (in particular, for every $s \in \Sigma_{i} \backslash\left(\cap_{i} S_{i}\right)$ ). In either cases, $p[0] \neq 0$ or $[p[0]=0$ and $q=0]$, one has $(x, 0) \in B_{i}^{\prime \prime}(p, q)$. Alternatively, if $p[0]=0$ and $q \neq 0$ (recalling $q \in\left(\sum_{i \in I} Z^{\Sigma_{i}}\right)^{\perp}=\cap_{i \in I} Z^{\Sigma_{i} \perp}$ ), the nonemptyness of $B_{i}^{\prime \prime}(p, q)$ is straightforward from the fact that $q \in Z^{\Sigma_{i} \perp}$ : for a sufficiently small $z \in Z_{i}$, such that $q \cdot z<0,(x, z) \in B_{i}^{\prime \prime}(p, q)$.

Claim 6 For every $i \in I$, the convex valued correspondence $B_{i}^{\prime \prime}$ is lower semicontinuous.

Proof Let $i \in I$ and $(p, q) \in \Pi$ be given. The convexity and the fact that $B_{i}^{\prime \prime}(p, q)$ is non-empty insures that $B_{i}^{\prime}(p, q)=\overline{B_{i}^{\prime \prime}(p, q)}$. The correspondence: $(p, q) \longmapsto\left\{(x, z) \in X_{i} \times Z_{i}:\left[p_{\square}\left(x-e_{i}\right)\right]\left(\Sigma_{i}^{\prime}\right) \ll W^{\Sigma_{i}^{\prime}}(q) z+\gamma_{i}(p, q)\right\}$ has an open graph. By a standard corollary, it is lower semicontinuous.

Claim 7 For every $i \in I$, the closed convex non-empty valued correspondence $B_{i}^{\prime}$ is upper semicontinuous.

Proof Let $i \in I$ be given. The correspondence $B_{i}^{\prime}$ has a closed graph, with non-empty convex values in the compact set $X_{i} \times Z_{i}$. By a standard corollary, it is, hence, upper semicontinuous.

We now introduce an additional agent $i=0$ representing the market and, following Gale-Mas-Colell (1975-1979), a reaction correspondence for each agent, defined on the convex compact set $\Omega:=\Pi \times\left(\Pi_{i=1}^{m} X_{i} \times Z_{i}\right)$. We thus let, for every $i \in I$ and every $((p, q),(x, z)) \in \Omega$ (where $\left.(x, z):=\left(x_{i}, z_{i}\right) \in \Pi_{i=1}^{m} X_{i} \times Z_{i}\right)$ :

We let the price correspondence satisfy, for every $((p, q),(x, z)) \in \Omega$ :

Claim 8 For each $i \in\{0,1, \ldots, m\}, \Psi_{i}$ is lower semicontinuous.
Proof First, the correspondence $\Psi_{0}$ is lower semicontinuous for having an open graph. Second, we let $i \in I$ and $\omega:=((p, q),(x, z)) \in \Omega$ be given and consider separately the two alternatives $\left(x_{i}, z_{i}\right) \notin B_{i}^{\prime}(p, q)$ and $\left(x_{i}, z_{i}\right) \in B_{i}^{\prime}(p, q)$ and show that, in both cases, $\Psi_{i}$ is lower semicontinuous at $\omega$.

- Assume, first, that $\left(x_{i}, z_{i}\right) \notin B_{i}^{\prime}(p, q)$. Then, $\Psi_{i}(\omega)=B_{i}^{\prime}(p, q)$.

Let $V$ be an open set in $X_{i} \times Z_{i}$, such that $V \cap B_{i}^{\prime}(p, q) \neq \emptyset$. It follows from the convexity of $B_{i}^{\prime}(p, q)$ and the non-emptyness of $B_{i}^{\prime \prime}(p, q)$ that $V \cap B_{i}^{\prime \prime}(p, q) \neq$ $\emptyset$. From Claim 6, there exists a neighborhood $U$ of $(p, q)$ in $\Pi$, such that $V \cap B_{i}^{\prime}\left(p^{\prime}, q^{\prime}\right) \supset V \cap B_{i}^{\prime \prime}\left(p^{\prime}, q^{\prime}\right) \neq \emptyset$, for every $\left(p^{\prime}, q^{\prime}\right) \in U$.

Since $B_{i}^{\prime}(p, q)$ is nonempty and closed in the compact set $X_{i} \times Z_{i}$, there exist two open sets $V_{1}$ and $V_{2}$ in $X_{i} \times Z_{i}$, such that $\left(x_{i}, z_{i}\right) \in V_{1}, B_{i}^{\prime}(p, q) \subset V_{2}$ and $V_{1} \cap V_{2}=\emptyset . .^{8}$ From Claim 7, there exists a neighborhood $U_{1} \subset U$ of $(p, q)$, such that $B_{i}^{\prime}\left(p^{\prime}, q^{\prime}\right) \subset V_{2}$, for every $\left(p^{\prime}, q^{\prime}\right) \in U_{1}$. Let $W=V_{1} \times U_{1}$. Then, $W$ is a neighborhood of $\omega$, such that $\Psi_{i}\left(\omega^{\prime}\right)=B_{i}^{\prime}\left(p^{\prime}, q^{\prime}\right)$, and, from above, $V \cap \Psi_{i}\left(\omega^{\prime}\right) \neq \emptyset$, for every $\omega^{\prime}:=\left(\left(x^{\prime}, z^{\prime}\right),\left(p^{\prime}, q^{\prime}\right)\right) \in W$. This proves the lower semicontinuity of $\Psi_{i}$ at $\omega$.

- Assume, now, that $\left(x_{i}, z_{i}\right) \in B_{i}^{\prime}(p, q)$, i.e., $\Psi_{i}(\omega)=B_{i}^{\prime \prime}(p, q) \cap\left(P_{i}(x) \times Z_{i}\right)$.

The lower semicontinuity of $\Psi_{i}$ at $\omega$ is immediate if $\Psi_{i}(\omega)=\emptyset$. Assume $\Psi_{i}(\omega) \neq \emptyset$. We recall that $P_{i}$ (from Assumption A3) is lower semicontinuous with open values and that $B_{i}^{\prime \prime}$ is non-empty valued and has an open graph. By a standard corollary (see Florenzano, 1999, page 34), this insures the lower semicontinuity of the correspondence $\left(\left(p^{\prime}, q^{\prime}\right),\left(x^{\prime}, z^{\prime}\right)\right) \in \Omega \longmapsto B_{i}^{\prime \prime}\left(p^{\prime}, q^{\prime}\right) \cap\left(P_{i}\left(x^{\prime}\right) \times\right.$ $\left.Z_{i}\right) \subset B_{i}^{\prime}\left(p^{\prime}, q^{\prime}\right)$. Hence, $\Psi_{i}$ is lower semicontinuous at $\omega$.

Claim 9 The correspondences $\Psi_{i}$ (for $i \in\{0,1, \ldots, m\}$ ) admit an element
$\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right)$ of $\Omega$, such that:
(i), $\forall(p, q) \in \Pi, p \cdot \sum_{i=1}^{m}\left(x_{i}^{*}-e_{i}\right)+q \cdot \sum_{i=1}^{m} z_{i}^{*}$
$\leq p^{*} \cdot \sum_{i=1}^{m}\left(x_{i}^{*}-e_{i}\right)+q^{*} \cdot \sum_{i=1}^{m} z_{i}^{*}$;
(ii), $\forall i \in I,\left(x_{i}^{*}, z_{i}^{*}\right) \in B_{i}^{\prime}\left(p^{*}, q^{*}\right)$ and $B_{i}^{\prime \prime}\left(p^{*}, q^{*}\right) \cap\left(P_{i}\left(x^{*}\right) \times Z_{i}\right)=\emptyset$.

[^5]Proof We recall the following fixed-point-like theorem, due to Gale and Mas-Colell (1975, 1979):
"Given $X=\Pi_{i=1}^{m} X i$, where $X_{i}$ is a non-empty compact convex subset of $\Re^{n}$, let $\varphi_{i}: X \rightarrow X_{i}$ be $m$ convex (possibly empty) valued correspondences, which are lower semicontinuous. Then there exists $x$ in $X$ such that for each $i$ either $x_{i} \in \varphi_{i}(x)$ or $\varphi_{i}(x)=\emptyset "$.

From above, the correspondences $\Psi_{0}: \Omega \rightarrow \Pi$ and $\Psi_{i}: \Omega \rightarrow X_{i} \times Z_{i}$ (for $i=1, \ldots, m)$ satisfy the conditions of the theorem and, hence, admit an element $\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right) \in \Omega$, such that either $\left(p^{*}, q^{*}\right) \in \Psi_{0}\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right)$ or $\Psi_{0}\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right)=\emptyset$, and, for each $i \in I$, either $\left(x_{i}^{*}, z_{i}^{*}\right) \in \Psi_{i}\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right)$ or $\Psi_{i}\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right)=\emptyset$. By construction, $\left(p^{*}, q^{*}\right) \notin \Psi_{0}\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right)$ and, for each $i \in I,\left(x_{i}^{*}, z_{i}^{*}\right) \notin \Psi_{i}\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right)$, since $x_{i}^{*} \notin P_{i}\left(x^{*}\right)$. Hence, $\Psi_{0}\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right)=\emptyset$, which yields the above Assertion $(i)$ and, for every $i \in I, \Psi_{i}\left(\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right)=\emptyset$, which yields the above Assertion (ii).

Claim $10 \sum_{i \in I} z_{i}^{*} \in Z^{\left(\Sigma_{i}\right)}$.
Proof Assume, by contraposition, $\sum_{i \in I} z_{i}^{*} \notin Z^{\left(\Sigma_{i}\right)}$. Then, from Claim 9$(i), q \cdot \sum_{i=1}^{m} z_{i}^{*} \leq q^{*} \cdot \sum_{i=1}^{m} z_{i}^{*}$, for every $q \in Q:=\left\{q \in\left(Z^{\left(\Sigma_{i}\right)}\right)^{\perp}:\|q\| \leq 1\right\}$, which implies $q^{*} \cdot \sum_{i \in I} z_{i}^{*}>0$ and $\left\|q^{*}\right\|=1$, hence, $\gamma_{i}\left(p^{*}, q^{*}\right)[0]=0$ for every $i \in I$.

From Claim 9-(ii), for every $i \in I,\left(x_{i}^{*}, z_{i}^{*}\right) \in B_{i}^{\prime}\left(p^{*}, q^{*}\right)$ and the budget constraint in state $s=0$ is written: $p^{*}[0] \cdot\left(x_{i}^{*}[0]-e_{i}[0]\right) \leq-q^{*} \cdot z_{i}^{*}$. Summing up these inequalities for $i \in I$ yields: $p^{*}[0] \cdot \sum_{i \in I}\left(x_{i}^{*}[0]-e_{i}[0]\right) \leq-q^{*} \cdot \sum_{i \in I} z_{i}^{*}<0$, in contradiction to Claim 9-( $i$, which insures: $p^{*}[0] \cdot \sum_{i \in I}\left(x_{i}^{*}[0]-e_{i}[0]\right) \geq 0$.

Claim $11 x^{*}=\left(x_{i}^{*}\right) \in \mathcal{A}^{\left(\Sigma_{i}\right)}$, i.e., $\sum_{i \in I}\left(x_{i}^{*}[s]-e_{i}[s]\right)=0$, for every $s \in \cap_{i} S_{i}^{\prime}$.
Proof (by contraposition). From Claim 10, there exists $\left(z_{i}^{\prime}\right) \in \Pi_{i=1}^{m} Z^{\Sigma_{i}}$ such that $\sum_{i=1}^{m} z_{i}^{*}=\sum_{i=1}^{m} z_{i}^{\prime}$. Then, $\left(z_{i}\right):=\left(\left(z_{i}^{*}-z_{i}^{\prime}\right)\right) \in\left(\Re^{J}\right)^{I}$ satisfies $\sum_{i \in I} z_{i}=0$ and $W\left(q^{*}\right)[s] \cdot z_{i}^{*}=W\left(q^{*}\right)[s] \cdot z_{i}$, for every $i \in I$ and every $s \in \cap_{i \in I} S_{i}^{\prime}$.

Assume that $\sum_{i \in I}\left(x_{i}^{*}[s]-e_{i}[s]\right) \neq 0$, for some $s \in \cap_{i \in I} S_{i}^{\prime}$. Then, from Claim $9-(i), p^{*}[s]=\frac{\sum_{i \in I}\left(x_{i}^{*}[s]-e_{i}[s]\right)}{\left\|\sum_{i \in I}\left(x_{i}^{*}[s]-e_{i}[s]\right)\right\|}$, which implies $p^{*}[s] \cdot \sum_{i \in I}\left(x_{i}^{*}[s]-e_{i}[s]\right)>0$, $\left\|p^{*}[s]\right\|=1$ and $\gamma_{i}\left(p^{*}, q^{*}\right)[s]=0$ for every $i \in I$.

From Claim 9-(ii), for every $i \in I,\left(x_{i}^{*}, z_{i}^{*}\right) \in B_{i}^{\prime}\left(p^{*}, q^{*}\right)$ and the budget constraint in state $s$ is written $p^{*}[s] \cdot\left(x_{i}^{*}[s]-e_{i}[s]\right) \leq W\left(q^{*}\right)[s] \cdot z_{i}^{*}$. Summing up these inequalities for $i=1, \ldots, m$ yields, from above:

Claim $12\left(x^{*}, z^{*}\right):=\left(\left(x_{i}^{*}, z_{i}^{*}\right)\right) \in \overline{\mathcal{A}}\left(p^{*}, q^{*}\right)$, hence, $\left\|x^{*}\right\|+\left\|z^{*}\right\|<r$.
Proof Recalling the above definitions (see page 8), Claim 9-(ii) yields $\left(x_{i}^{*}, z_{i}^{*}\right) \in B_{i}^{\prime}\left(p^{*}, q^{*}\right) \subset \bar{B}_{i}^{\Sigma_{i}}\left(p^{*}, q^{*}\right)$, for every $i \in I$. Hence, from Claims 10 and 11, $\left(x^{*}, z^{*}\right) \in \overline{\mathcal{A}}^{\left(\Sigma_{i}\right)}\left(p^{*}, q^{*}\right)$ and, from Claim $3,\left\|x^{*}\right\|+\left\|z^{*}\right\|<r$.

Claim 13 For each $i \in I,\left(x_{i}^{*}, z_{i}^{*}\right)$ is optimal in $B_{i}^{\prime}\left(p^{*}, q^{*}\right)$.
Proof Let $i \in I$ be given. From Claim 9-(ii), $\left(x_{i}^{*}, z_{i}^{*}\right) \in B_{i}^{\prime}\left(p^{*}, q^{*}\right)$ and $B_{i}^{\prime \prime}\left(p^{*}, q^{*}\right) \cap\left(P_{i}\left(x^{*}\right) \times Z_{i}\right)=\emptyset$.

By contraposition, assume there exists $\left(x_{i}, z_{i}\right) \in B_{i}^{\prime}\left(p^{*}, q^{*}\right) \cap\left(P_{i}\left(x^{*}\right) \times Z_{i}\right)$. From Claim 12, the strict inequalities $\left\|x_{i}^{*}\right\|<r$ and $\left\|z_{i}^{*}\right\|<r$ hold and, from Assumption $A 3$, the better strategy $\left(x_{i}, z_{i}\right)$ may be chosen "sufficiently close" to $\left(x_{i}^{*}, z_{i}^{*}\right)$ so that $\left\|x_{i}\right\|<r$ and $\left\|z_{i}\right\|<r$.

From Claim 5, there exists $\left(x_{i}^{\prime}, z_{i}^{\prime}\right) \in B_{i}^{\prime \prime}\left(p^{*}, q^{*}\right) \subset B_{i}^{\prime}\left(p^{*}, q^{*}\right)$. Since $B_{i}^{\prime}\left(p^{*}, q^{*}\right)$ is convex, $\left(x_{i}^{n}, z_{i}^{n}\right):=\left[\frac{1}{n}\left(x_{i}^{\prime}, z_{i}^{\prime}\right)+\left(1-\frac{1}{n}\right)\left(x_{i}, z_{i}\right)\right] \in B_{i}^{\prime}\left(p^{*}, q^{*}\right)$, whereas, by construction, $\left(x_{i}^{n}, z_{i}^{n}\right) \in B_{i}^{\prime \prime}\left(p^{*}, q^{*}\right)$, for every $n>0$. Fom Assumption $A 3, P_{i}$ is open valued and there exists $N>0$, such that $\left(x_{i}^{N}, z_{i}^{N}\right) \in P_{i}\left(x^{*}\right) \times Z_{i}$. Hence, $\left(x_{i}^{N}, z_{i}^{N}\right) \in B_{i}^{\prime \prime}\left(p^{*}, q^{*}\right) \cap\left(P_{i}\left(x^{*}\right) \times Z_{i}\right)$, which contradicts Claim 9-(ii).

Claim 14 For every $i \in I, \gamma_{i}\left(p^{*}, q^{*}\right)=0$, that is, $B_{i}^{\prime}\left(p^{*}, q^{*}\right)=B_{i}\left(p^{*}, q^{*}\right)$.
Proof Let $\Sigma:=\cap_{i \in I} \Sigma_{i}=\cap_{i \in I} S_{i}$ and consider a given state $s \in \Sigma^{\prime}$. From Claim 10, there exists $z^{\prime}:=\left(z_{i}^{\prime}\right) \in \prod_{i=1}^{m} Z^{\Sigma_{i}}$ such that $\sum_{i=1}^{m} z_{i}^{*}=\sum_{i=1}^{m} z_{i}^{\prime}$ and the collection $\left(z_{i}\right):=\left(\left(z_{i}^{*}-z_{i}^{\prime}\right)\right)$ satisfies $\sum_{i=1}^{m} z_{i}=0$ and $W\left(q^{*}\right)[s] \cdot z_{i}^{*}=$ $W\left(q^{*}\right)[s] \cdot z_{i}$, for every $i \in I$.

Let $i \in I$ be given.
We show first that $p^{*}[s] \cdot\left(x_{i}^{*}[s]-e_{i}[s]\right)=W\left(q^{*}\right)[s] \cdot z_{i}^{*}+\gamma_{i}\left(p^{*}, q^{*}\right)[s]$.
Indeed, from Claim 9- $(i i), p^{*}[s] \cdot\left(x_{i}^{*}[s]-e_{i}[s]\right) \leq W\left(q^{*}\right)[s] \cdot z_{i}^{*}+\gamma_{i}\left(p^{*}, q^{*}\right)[s]$, whereas, from Claim 12, $\left\|x_{i}^{*}\right\|<r$ and, from Assumptions $A 1-A 3$, there exists $x_{i} \in P_{i}\left(x^{*}\right)$, such that $x_{i}\left[s^{\prime}\right]=x_{i}^{*}\left[s^{\prime}\right]$ for every $s^{\prime} \neq s$. From Assumption $A 3$, if we had $p^{*}[s] \cdot\left(x_{i}^{*}[s]-e_{i}[s]\right)<W\left(q^{*}\right)[s] \cdot z_{i}^{*}+\gamma_{i}\left(p^{*}, q^{*}\right)[s]$, then, $x_{i}$ could be chosen "sufficiently close" to $x_{i}^{*}$ so that $p^{*}[s] \cdot\left(x_{i}[s]-e_{i}[s]\right)<W\left(q^{*}\right)[s] \cdot z_{i}^{*}+\gamma_{i}\left(p^{*}, q^{*}\right)[s]$ and this would contradict Claim 13.

Hence, from above, $p^{*}[s] \cdot\left(x_{i}^{*}[s]-e_{i}[s]\right)=W\left(q^{*}\right)[s] \cdot z_{i}+\gamma_{i}\left(p^{*}, q^{*}\right)[s]$, for every $i \in I$. Summing up these relations for $i=1, \ldots, m$ yields, from Claim 11 and from above:
$0=\sum_{i \in I} \gamma_{i}\left(p^{*}, q^{*}\right)[s]:=m\left(1-\left\|p^{*}[s]\right\|\right)$, for every $s \in \Sigma^{\prime}$.
From the definitions, this yields $\gamma_{i}\left(p^{*}, q^{*}\right)=0$ and $B_{i}^{\prime}\left(p^{*}, q^{*}\right)=B_{i}\left(p^{*}, q^{*}\right)$, for every $i \in I$.

Claim 15 The collection $\left[\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right):=\left[\left(x_{i}^{*}, z_{i}^{*}\right)\right]\right] \in \Omega$ defines a pseudoequilibrium of the economy $\mathcal{E}$, such that $\left\|p^{*}[s]\right\|=1$, for every $s \in \cap_{i \in I} S_{i}^{\prime}$ and, hence, Theorem 1 holds.

Proof The collection $\left[\left(p^{*}, q^{*}\right),\left(x^{*}, z^{*}\right)\right]$ satisfies Conditions $(i)$ of the definition of a pseudo-equilibrium, jointly with $\left\|p^{*}[s]\right\|=1$ for every $s \in \cap_{i} S_{i}^{\prime}$, from Claims 13 and 14, and Conditions (ii) - (iii) from Claims 10 and 11. Hence, Claim 4 insures the existence of a no-arbitrage equilibrium relative to the refinement $\left(\Sigma_{i}\right)$ and the price system $\left(p^{*}, q^{*}\right)$, which, indeed, satisfies $p^{*}[s] \neq 0$ for every $s \in \cup_{i \in I} \Sigma_{i}^{\prime}$. The other properties of Theorem 1 , namely $q^{*} \in Q_{c}\left[V,\left(\Sigma_{i}\right)\right]$ and the existence of a C.I.E., are straightforward from Claim 1.
