# WHAT'S IN A (FEDERAL) NAME? THE DENOMINATIONS OF MEMBERSHIP IN THE BOIOTIAN CONFEDERACY DURING THE CLASSICAL AND HELLENISTIC PERIODS

## POSITION OF THE PROBLEM

If one concept is falsely familiar in studies of the ancient Greek world, it is that of confederacy or confederal organization: it takes a great deal of work to understand precisely the indigenous terms and categories, such as *koinon* or *sympoliteia*, and then to make a comparison with contemporary systems at the right historical distance. Several teams of historians have been working on this task with renewed impetus since the 1990s, particularly in Italy, Germany and of course in France and in the French-speaking world,<sup>1</sup> in parallel with the development of the European Union. This is evidenced by the volume published in 2015 in Cambridge under the direction of Hans Beck and Peter Funke, *Federalism in Greek Antiquity*, which will remain as the most complete successor to Jakob Larsen's synthesis, *Greek Federal States*, published in 1968.

The editors of this massive book rightly recall that one of the key notions, and almost the initial question in the analysis of Greek confederal systems, has been that of citizenship, and more precisely of double citizenship, *Doppelbürgerrecht* or more precisely *Gesamtbürgerrecht*,<sup>2</sup> as Emil Szanto had already defined it in 1892 in his opuscule entitled *Das griechische Bürgerrecht*. As the latter wrote, “in solchen Sympolitien (i.e., confederal sympolities of the Achaean type), muss es ein Einzelbürgerrecht und ein Gesamtbürgerrecht geben und die Existenz beider Arten von Bürgerrecht ist ein ausreichender Beweis für eine solche Sympolitie”.<sup>3</sup> The aim was then to examine the processes of granting local and federal citizenship and the various rights from an institutional and structural point of view, including what was then (and unfortunately still is) called anachronistically the civil rights to which membership at both levels gave access.

Subsequently, the confederal question was enriched by a series of reflections, born of various historiographic traditions crossing the *koina* route: for example, on the organization and division of territories which led, for example, to the discovery at the end of the 1990s by Denis Knoepfler and Thomas Corsten of the districts (*tele*) in the Boiotian *koinon* of the Hellenistic period;<sup>4</sup> this type of study in turn has resulted in long analyses on the distribution of the population within these subdivisions, but also on representativeness and the rules of proportionality, a theme whose heuristic potential has not yet been thoroughly examined, with the exception of a few very recent studies;<sup>5</sup> secondly, on ethnic identity and the link between *ethnos* and *koinon*, which has been the subject of much debate, particularly on the origins of the confederations from the point of view of ethnogenesis: one thinks of Emily Mackil's thesis published in 2013 and,

before her, the work of Stephanie Larson<sup>6</sup> and Angela Kuhr;<sup>7</sup> lastly, and more recently, on confederal coinage, which this conference presents through the ANR-DFG KOINON project directed by Catherine Grandjean and conducted from a fundamentally historical perspective on shared structures and identities as they can be perceived through monetary production and circulation.

#### REVISITING THE ISSUE OF DUAL CITIZENSHIP FROM AN ANTHROPOLOGICAL PERSPECTIVE

These different research topics tended to at least partially obliterate the question of citizenship, which was probably thought to have been resolved, because a fairly clear idea of the rights and duties of a Boiotian, Achaian or Aitolian citizen had been acquired. However, the issue has somehow resurfaced in the 2010s, most clearly illustrated by Athanase Rizakis' work<sup>8</sup> on citizenship in the Achaian Confederation at a conference on multiple citizenships held in Tours.<sup>9</sup> Moreover, civic *politeia* itself has been the subject of innovative works, such as that of Josine Blok, which culminated in the publication in 2017 of her book on Athenian citizenship in the classical era,<sup>10</sup> a theme that might seem hackneyed, but which the author has been able to renew to a large extent by observing more closely the role of women in the system,<sup>11</sup> as well as the place held by cultic activities in the very definition of this *politeia*. We shall also refer to other more distant but equally stimulating works on the theme of citizenship, such as Victor Farenga's *Citizen and Self in Ancient Greece*, published in 2006, which addresses the *politeia* in terms of performance. In order to understand what the notion of performance (now widely used in the contemporary historiography of Ancient Greece) brings to the question of citizenship, I will give here an example of what I mean by this expression, taking the case of the famous courtesan Neaira, mentioned in the eponymous discourse of the Pseudo-Demosthenes.<sup>12</sup> This is, of course, an extreme example, but a very evocative one, since the character begins as a slave in Corinth and ends up as a quasi-citizen in Athens married to an Athenian, Stephanos; above all, her daughter Phanô, who married an *archon basileus*, became in a way a citizen because she acted like a citizen and was recognized as such: of course, the whole judicial issue here lies in the dissociation (and in fact the contradiction) between a legal status that is not that of a citizen according to the accusation and a behaviour that is that of a citizen and is accepted as such by the community until denunciation; the interest of my argument is that citizenship is in this case highlighted as being based in equal parts on a status (perhaps fraudulent, but it doesn't matter) and on a behaviour and gestures (in short, a performance) recognized as being those of a citizen.

Coming back to the *koina*, it seems to me that it is time to revisit the question of double or multiple federal citizenship from the perspective of the anthropology of politics, *i.e.* in terms of practices and representations rather than through the sole structures and institutions in a restrictive meaning, in line with the work of the anthropologist Catherine Neveu on contemporary citizenship.<sup>13</sup> It is well known today that the possession of rights and duties never automatically leads to their implementation (one only has to look at the percentage of French citizens who voted in the European elections in 2019): the statement of these rights is therefore only ever part of the description of the mechanisms of citizenship. The general question on which my remarks will be based is therefore the following: what does it mean to be a citizen in a Confederacy in terms of actions, practices and rituals? What does one do over time when one enjoys dual membership, as in the case of Europe where European citizenship is defined as "superimposed citizenship" in relation to the national citizenship? It is clear that voting and political participation in the narrow sense of the term are no longer sufficient to provide a definition, a perspective that resonates with the current demands of European citizens, who are no longer

content to simply cast their votes or to contribute financially to the works of Brussels through their States, but sometimes ask for and obtain different modes of participation.

Here is a key word that has now been dropped: participation. No term is more accurate than this one to define the Greeks' idea of *politeia*: it is a matter of *meteinai*, "to be with", and *metechein*, which can be translated as "to stand with". These terms, roughly equivalent at a semantic level, are constantly found in epigraphic sources, especially honorific decrees and treatises, to refer to the process of aggregation by which such and such a group or individual may benefit from a specific privilege: among many other examples, that point is evidenced by a decree of Keos for the Aitolians in the last third of the II<sup>nd</sup> century BC.<sup>14</sup> It could be objected, with regard to the sources, that the inscriptions referred to here are precisely normative documents and that the legal analysis applied until then in an extensive, even exclusive way, is a consequence of such a situation. However, the prescriptions contained in these texts are not simply above-ground statements whose applications, or even applicability, should be measured: they are also productions of the social body like any other and the sign of an appropriation of a problem by citizens within political institutions. In other words, they in turn say something about practices, in the same way as literary texts or archaeological sources do. I will therefore not artificially dissociate here the evocation of norms from that of practices on which they are based and vice versa. Nor will I forget one of the questions that is being asked of us through this conference, that of a possible conflict between the federal and the civic levels, with regard to the citizen's leeway. Finally, it is unthinkable, of course, to offer an exhaustive analysis of all the testimonies relating to the use of federal *politeia*. The main part of my contribution will therefore relate, through epigraphic sources, to the *koina* that I know best, those of Classical and Hellenistic Boiotia, although I will not refrain from making comparisons, particularly with Achaia and Aitolia.

### THE NAME ONE GIVES (ONESELF): FEDERAL ETHNICS

The question of double *politeia* involves a series of practices, numerous in number, the first of which concerns the way of naming others and naming oneself. It is on this question of naming, in relation to the action that motivates it, that I will focus my remarks from now on. As one knows, the mark of a dual belonging can be seen in the ethnic worn by the citizens of the *koina*.<sup>15</sup> Far from being simply the trace of a more or less regulated legal system, ethnics reveal the behaviour and identity strategies of those who wear them or the representations conveyed by those who give the name. In short, everything depends on the context of enunciation: the cases that interest me therefore concern the way in which individuals are presented or present themselves within their *koinon* or outside of it.

The case considered the most ordinary by historians is the one, well-studied by A. Rizakis for the Achaian Confederacy,<sup>16</sup> which presents the juxtaposition of the federal ethnic and the political one, for example *Achaios Olenios*, "Achaian from Olenos", which appears in a list of military contributions from the end of the V<sup>th</sup> or beginning of the IV<sup>th</sup> century BC.<sup>17</sup> But the federal ethnic is more generally followed by an indication that works as a political ethnic, "coming from such and such a city", as in the formula Achaian ἐξ Αἰγίου, "Achaian from Aigion", in a *politeia* decree of the Aitolian *koinon* for an Achaian citizen dated 272/271 BC.<sup>18</sup> The formula is exactly the same for the Aitolian *koinon*, as seen in an inscription from Delphi, where the Phocidian city grants privileges to an "Aitolian ἐξ Τιτράν", "Aitolian from Titrai",<sup>19</sup>

around 265-260 BC. These official external designations give unquestionable primacy to the large group to which *koina* nationals belong. In this formula, the truly political element is concentrated in the federal ethnic, while the second part, which is almost the equivalent of a *topikon*,<sup>20</sup> is more akin to a geographical notation, the mention of a homeland of origin.

What about the Boiotian case? Paul Roesch produced, in 1982 in his *Études bœtiennes*, a very complete survey of the use of federal ethnics between 378 and c. 100 BC, which can still be used as a basis for analysis, even if it deserves to be completed and especially clarified in the statement of categories.<sup>21</sup> In Boiotia, as in the other *koina*, the citizen can be presented as a *Boiotios* or *Boiotos* “coming from such and such a city”: this is the case in a shortened decree from Delphi granting at the end of the IVth or the beginning of the IIIRD century a whole series of privileges to a certain Python son of Empedon, “Boiotian from Coroneia”.<sup>22</sup> But, as Peter Fraser has clearly shown,<sup>23</sup> the situation is much less stable in terms of denomination than in Achaia, for example. It is therefore probably more difficult than elsewhere to assess the behaviour of users in relation to an assumed rule. Nevertheless, ethnics remain manipulable objects of naming, especially when they are found in contexts where individuals name themselves. And their use cannot be regarded in such cases as totally neutral, or even random and insignificant, contrary to Roesch’s initial assertion that “it would be dangerous (...) to draw conclusions from documents of a strictly private nature, where characters are seen to act as mere private individuals”.<sup>24</sup> The interpretative danger would exist only in relation to an assumed institutional norm, which would be deemed unbreakable. It is therefore the uses that interest me here through the examination of three examples. These are taken in a broad time span, at the limits of the Classical and Hellenistic *koina*, and involve three types of inscriptions whose stakes and purposes differ: a dedication, victors’ lists and proxeny decrees.

### THREE BOIOTIAN CASES

#### Epiddalos

The first example is that of Epiddalos, in fact Epizalos,<sup>25</sup> forgotten from Paul Roesch’s tables, perhaps because it does not fit in his theory according to which the epigraphic use of the ethnic “Boiotian”, both in singular and plural, is confined to a period from 338, date of the battle of Chaeronea (which for a long time caused the historiographic ravages that we know), until 171, date of the dissolution of the *koinon* by the Romans.<sup>26</sup> In the sanctuary of Delphi, Epiddalos consecrated a statue to Apollo, presenting himself as “Boiotian from Orchomenos” in an inscription in Boiotian alphabet, generally dated from the 470s:<sup>27</sup>

Hans Beck and Angela Ganter were right to underline, in the synthesis of the “New Larsen” devoted to Boiotia, the way in which this character emphasized, in terms of identity, his beotianity before his local belonging.<sup>28</sup> The case is all the more interesting here because, while the dedicant proclaims his double belonging, the sculptors Aristogeitôn and Hypatodôros call themselves exclusively “Thebans” with their civic affiliation used in the dual to designate the pair they form. No doubt they are known as such rather than as “Boiotians” and it is as such that they confer glory on their homeland. But the double ethnic under which Epiddalos presents himself is an embarrassment to historians. It is typical of the double appellation already mentioned and, if we follow Roesch’s point of view, should be proof of the very existence of the Boiotian *koinon* and, within it, of a federal *politeia* in the legal sense, at a date as high as the first half of the vth century BC, which is not generally accepted.<sup>29</sup> The *koinon*, as an institutional entity as known by the Oxyrhynchus historian,<sup>30</sup> probably began its existence in 446 BC after the Battle of Coroneia, which put an end to the Athenian claims on the region.<sup>31</sup>

The situation becomes clear if one considers, as Stephanie Larson has already done without drawing all the consequences, that the proposed date is far too high, including in terms of paleography.<sup>32</sup> The sculptors of this statue are also the authors of the group of the seven Argive chiefs against Thebes, known by Pausanias and which could celebrate the victory of Oinoe in Argolis over the Lacedemonians in 456 BC.<sup>33</sup> If the statue of Epiddalos is to be placed at about the same time, *i.e.* in the middle of the vth century BC (rather than in the second half of the century), then the pieces of the puzzle fall into place. Epiddalos is a member of that elite of Orchomenos who welcomed the Boiotian exiles during the period of Athenian domination between 457 and 446 and was so essential to the revolt against Athens that these exiles and their followers were said to be “orchomenizers”.<sup>34</sup> His gesture in Delphi must be understood not as a simple geographical or identity indication in a period when the *koinon* was not in place, but as a strong claim not only to Orchomenos’ place in the *koinon*, but to the very process of structuring the *koinon* in the years right before or after its establishment. There is a definite performative effect in this way of proclaiming oneself loud and clear as “Boiotian from Orchomenos”: the *koinon* exists all the more and all the better as those who make it say it exists. It will be said that 446 constitutes a *terminus ad quem* rather than *post quem* for the date of the inscription, from the moment one ceases to adopt a strictly legalistic position on the use of the double ethnic. It is less a question here of the exhibition of a binding institutional denomination than of a voluntary ideological position in favour of the establishment of the Confederacy in a context of opposition to the Athenians. It is clear, in fact, that the mention of the ethnic is the object of a personal choice, since the sculptors, for their part, choose to emphasize their civic affiliation for undoubtedly cultural reasons.

## Winners in contests

As one would expect, outside of Boiotia, for example in the Delphic *Sôteria*, athletes are designated by their federal ethnic, *Boiôtios*, and the latter alone without the civic ethnic.<sup>35</sup> Among many others, Charès son of Chairiôn, *Boiôtios*, who appears twice in the category of “children’s choir”, can be cited.<sup>36</sup> Even for the *auletaî*, it is indeed the federal ethnic that is expressed, while the Theban school was particularly well-known and, as Paul Roesch points out, “it was more glorious to be named by the ethnic Θηβαῖος –which immediately evoked for the reader the most famous of the flute schools–, than the ethnic Βοιώτιος which had only a political meaning”. The use of the *Boiôtios* ethnic, which does not leave room for any exception for the *Sôteria*, also appears systematic in other non-Boiotian competitions, as we can see in the *Panathenaia*,<sup>37</sup> the *Eleutheria* of Larissa,<sup>38</sup> or the *Asklepieia* of Cos.<sup>39</sup>

The interesting point in this external use of *Boiôtios* alone, which has hardly attracted the attention of historians, is that it’s generally used next to the double ethnic for other confederations. As proof of this, one can cite the presence, among the winners of the *Panathenaia* in the aforementioned catalogue, of a Μέν[ανδρ]ος Μενίππου Ἀχαιὸς ἀπ' Ἀργους, “Menandros son of Menippos Achaian from Argos” (l. 16-17), alongside the twice-named Boiotian Akastidas. Likewise, in the *Eleutheria* of Larissa, the Larisseans are said to be Thessalians from Larissa, while the Boiotians are simply Boiotians. In other words, being named by their federal ethnic by Boiotians outside of Boiotia is a choice that is not imposed here by the organizers of the competition, although it cannot be said that it is left to the decision of each individual athlete, since all bear the same.<sup>40</sup> There is clearly a collective will to appear as *Boiôtioi*, apparently obliterating against all expectations the local belongings.

An identical phenomenon can be observed within Boiotia for the Hellenistic *koinon*, i.e. before 171 BC, in the case of the only two contests that left catalogues prior to the dissolution: the *Basileia* of Lebadeia and the *Mouseia* of Thespiae. One should not be surprised by such a denomination in the first contest, which is played at the federal level in honour of a god, Zeus *Basileus*, who in turn became the protector of the *koinon*.<sup>41</sup> But such a use for the Thespian *Mouseia*, a civic competition *a priori*, is less expected. As D. Knoepfler rightly pointed out in his seminal article on the *Mouseia*, it should be interpreted as a willingness on the part of the Thespians to give a federal anchorage to their local contest, by imposing this ethnic on all the Boiotian winners. Such an anchoring, obviously acquired during the reorganization of the contest during the years 230-220 BC,<sup>42</sup> is obvious in the heading of one of the catalogues where the federal archon Lykinos “in Onchestos” follows the mention of the local archon Philon, probably around 190-180 BC.<sup>43</sup> The mention “in Onchestos” refers, in fact, to the sanctuary of Poseidon, which is the federal headquarters of the Hellenistic *koinon*. the same way, there is a good chance that, if we had visitors' lists for the *Ptoia* dating from the Hellenistic Confederation, these lists would mention in the same way the Boiotian victors with the sole federal ethnic.

In any case, the exclusive use of the federal ethnic for these winners in contests in or out of Boiotia seems to mean that participation and victory in such contests are a way of exercising one's federal *politeia*, by acting collectively for a common cause with the other Boiotian citizens (a way to "faire *koinon*" in French) and erasing any trace of local belonging: the Boiotians somehow team up although the contests are fundamentally individual or, in any case, the winners are clearly individualised. It may be argued that all this is perhaps only about Boiotian identity and *ethnos*, or about regional geography, as if ethnic identity were once again the elastic and vague form that a *koinon* takes when ones doesn't want to look at it at a political level. But things look different if we admit that *politeia* and politics are not limited to participation in "political" institutions and that their scope extends beyond the *archè* and *krisis* in the sense of "power of magistrates and judges".

After 171 BC, when the Hellenistic Confederacy was dissolved, the Boiotian competitors bear only their civic ethnic, as shown by the large number of victors' lists of the 1<sup>st</sup> and 1<sup>st</sup> century BC, which makes this use in this case a good chronological marker.<sup>44</sup> The situation is more complicated in other *koina*, especially in Achaia, as shown by the presence after 146 BC (destruction of Corinth) of at least three Achaians from Sicyon in lists from the Late Hellenistic period in Boiotia. Thus, in a catalogue of the *Mouseia*, there is a mention of an actor, *hypokrites* [Ἀχαιός ἀ]π[ὸ] Σικυώνος: although the federal ethnic is restored in the lacuna, the restitution seems very sure, given the presence of the *pi* before the mention of the *polis*. Similarly, in Oropos, in the catalogue of the first *Amphiaraiā Rhōmaia*,<sup>45</sup> the presence of two Ἀχαιός ἀπὸ ἀπὸ Σικυώνο[ς] has been much talked about: it was considered an impassable *terminus ante quem* (146 BC) by Yannis Kallontzis,<sup>46</sup> whereas all other indicators, especially prosopographic, tend to date it after the first Mithridatic war, that is to say after 86 BC. This mention of the double ethnic, especially in Oropos, whose inscription is easier to date than that of Thespiae because of the evocation of the "first" contests of the category, raises a difficulty: other catalogues of the same contest give indeed simple civic ethnics, as for Πολυκράτης Ἀγεμάχου Ἀργεῖος, "Polykrates son of Agemachos Argian", at a date that cannot be very far from the previous list.<sup>47</sup> One might suggest that this use of the double ethnic means the resurgence of the Achaian *koinon* at the date of the inscriptions.<sup>48</sup> The existence, attested by a dedication found in Olympia, of a list of Achaian cities that took part in a battle against the Galatians alongside the Romans and that made a consecration to Zeus *Olympios* in 122 BC is unfortunately of little use here: among the 19 civic ethnic groups mentioned, there are neither Sicyon nor Argos, which does not rule out their participation in this possible resurrected *koinon*.<sup>49</sup> Numismatists have certainly much to teach historians on this issue! But it is not totally excluded either that the victors' lists from Oropos and Thespiae use a federal ethnic that is in some way nostalgic or patriotic, just as the ethnic of the Olynthians or the Corinthians was still used long after the destruction of their respective cities in 348 and 146.<sup>50</sup>

***Proxenoi***

The last case is that of Boiotian citizens being granted *proxenia* among other privileges. The question is to know which story tells the use of their ethnic and what conclusions can be drawn from it. The naming of these *proxenoi* seems more complex than what P. Roesch suggested. *Proxenoi* can first be named by the federal ethnic, followed by the civic one. This practice is obvious on the so-called base of the “Boiotians in Delphi”, which includes some thirty proxeny decrees granted by the Delphians between the end of the IVth and the middle of the IIIrd century BC.<sup>51</sup> *Proxenoi* are generally named according to the model [‘Ομ]ολώιχος Ἐρμαίσκου Βοιώτιος ἐκ Κορωνείας, “Homolôichos son of Hermaiiskos, Boiotian from Coroneia”.<sup>52</sup> The only ones distinguished by the absence of a federal ethnic are the Thebans, at least during the period when the city was not yet part of the Hellenistic *koinon*, i.e. before 287 BC.<sup>53</sup> In any case, the civic ethnic is mentioned, since it constitutes the “address” of the *proxenos*, as it were, to which the citizens of the city that issued the decree could go. The value of the indication then seems essentially topical, as it is intended to “locate the citizen in Boiotia”.<sup>54</sup> The Aitolians follow the same principle, but with an even more radical practice in the majority of the cases noted: as shown by the lists of *proxenoi* found at the federal sanctuary of Thermos, they identify by their civic ethnic the foreigners to whom they grant the proxeny as a *koinon*, as is the case of Διογείτων Ποτάμμειος Ὀρχομενίος.<sup>55</sup> The naming system is exactly symmetrical when it is the Boiotian cities or the *koinon* that grant proxeny: one can see this in the federal decree for a Rhodian probably dated 201/200,<sup>56</sup> as in the Orchomenos decree for Sôsibios of Alexandria.<sup>57</sup> The result of this practice is a form of asymmetry in diplomatic relations since the *poleis* and the *koina* then address the cities directly, independently of the *koinon* to which the *honorandus* belongs. As shown by the database, although incomplete, elaborated by W. Mack,<sup>58</sup> there are very few *koinon-to-koinon proxenoi*: is this a form of competition or even conflict between the civic and federal levels in decision-making? This is an important question, if one wants to avoid over-interpretations: it is not certain that the Greeks themselves saw any difficulty in this.

The geographical logic of this practice can be explained, indeed, as Mack reminds us, by the fact that it endorses in general links between *poleis*, without it being possible to observe a weakening of these links during the Hellenistic period.<sup>59</sup> Moreover, the presence or even the enhancement of civic ethnics, particularly in the lists of *proxenoi* found in various cities, contribute to the very assertion of the existence of the cities to which the *proxenoi* belong and of their capacity to take their place within diplomatic networks and interrelations.<sup>60</sup> Under these conditions, one may wonder about the need to specify that such and such an Orchomenian or such and such a Thespian was also a Boiotian, a need from which some like the Aitolians easily freed themselves, as we have seen. The precision of belonging to the

*koinon* on the Delphic list has no practical significance: in particular, it is not here to allow the distinction between homonymous cities that are not so numerous. It therefore has another function that brings us back to the previous reflections concerning the Boiotians in the catalogues of winners: there is a strong influence of the federal *politeia* which means that in Boiotia one is first and foremost a citizen of the *koinon* before being a citizen of such and such a city, a claim that should be stated loud and clear, the question remaining to know what influence the beneficiary of the decree has in this particular case on his own denomination. Whatever answer is given to this question, it seems to me that the strength of the bond between members of this community can be measured in this usage, which may seem superfluous. One could even say that it is as a Boiotian that one can be a *proxenos* in one's city. Going even further, if we want to re-establish a function of the federal ethnic that is not purely ideological, we will say that its mention implies that the honored figures have (or are perceived as having) potentially a power of action throughout the entire territory of the *koinon* through their political importance and their notoriety among the elite, which goes beyond the borders of their own *polis*.

This case is therefore not so different from that of the *proxenoi* who are identified, the second case, by their federal ethnic alone.<sup>61</sup> We will take as an example among many others Bacchôn son of Niketas, "Boiotian" and nesiarch of the League of Islanders in the years 280 BC, honoured both by the League and by several Aegean cities.<sup>62</sup> Perhaps this name reflects the League's interest in the character's federal experience, while other Boiotians, who were probably part of his team,<sup>63</sup> were at the same time simply named Thebans.<sup>64</sup> In fact, in such a situation, as D. Knoepfler had already suggested in his corpus of Eretrian proxenies or, more recently, W. Mack in his own work,<sup>65</sup> we can think that these are individuals who no longer reside in their city of origin, but enjoy a regional reputation and exercise their *euergetia* from elsewhere, for example from a royal court or even from the city that honours them: this, of course, changes the meaning and practice of the proxy institution while the euergetic dimension remains intact.

## CONCLUSION

I will make two concluding remarks on a subject I've only scratched the surface of here.

The first relates to the private or public nature that one often wants to assign to documents in order to determine what would fall under an objective official name or a subjective individual name. It is clear that the situation is much more complex than this simple dichotomy, as denomination depends on what will be called the context of enunciation (who speaks for whom?): it is usually the result of a negotiation or compromise between the one who is named and the community that names him, in short, between the emic (indigenous) and etic (exogenous) perspective, to use the classic distinction established by anthropologists. This is the case, in my opinion, even in funerary inscriptions where many



Boiotians who died abroad are simply called *Boiôtoi* because it is the ethnic they received while residing in a certain city or region, just like Athenians abroad are called Athenians and not through their demotic.<sup>66</sup> Moreover, if the person who receives a label (Boiotian, Akraiphian, etc.) does not always have the choice of this label (if the denomination is constrained), it results less from an official denomination which would be imposed by a State of origin than from the perception of this State by those who give the name. I therefore do not believe that there is any “regulation of the name”, or even a true general rule of usage: that implies a case-by-case analysis of all contexts, with the risk of not being able to understand all the names because we do not have all the contexts of enunciation at our disposal. It is true that the federal ethnic in Boiotia shows a global tendency to disappear after 171 BC, for example in agonistic catalogues, which collaterally allows us to set a chronological limit, but this is a usage and not the result of a binding act. On the other hand, it is not certain that all documentary categories are concerned by a general return to civic ethnics after the end of the Hellenistic *koinon*, especially the epitaphs, which are therefore very difficult to date.

The second remark concerns the use of ethnics. This use is based on a dual, non-exclusive logic, certainly political and ideological on the one hand, but also pragmatic as much in the noble sense of *praxis* as in the trivial sense of practical daily habit. Thus, the federal ethnic, which is the place of expression of the federal *politeia*, shows the link of an individual with a *koinon*, which can be a very strong link, both displayed by the individual or the community he represents (this is the case of athletes, for example) or by the receiving community that confers the name (we think of the Delphic proxenies of the II<sup>nd</sup> century BC): here lies the ideological scope of the ethnic which means that the person feels or is perceived first as a member of a *koinon*. But this ethnic, in its pragmatic scope, also indicates the action or capacity for action (real or supposed) of the individual within his *koinon*, whatever the field of action of this citizenship which cannot be reduced to political and judicial participation: being a Boiotian also means being a *proxenos* in his city, in his *koinon*, in all the interpolitical and inter-federal networks, but it also means “teaming up”, forming a community with the athletes of his *koinon* at home and elsewhere. The essential thing is to reaffirm that the two ideological and pragmatic levels of this logic of participation are not mutually exclusive.



<sup>66</sup> According to a remark made by J. Roy during the conference, this use would in a way be similar to the one found in Xenophon in the *Anabasis* about the Boiotian mercenaries, who when they are not better known would be called Boiotians, but who, when they are better identified, would carry their civic ethnic. However, the most famous case, that of Proxenos generally called “the Boiotian” in Xenophon (three occurrences) and once the Theban (*Anabasis*, 2.1.10), does not seem to particularly confirm such an assertion. In fact, the *strategoi* who command Greek mercenaries are rather called by their regional ethnic, as a passage in the text shows (*Anabasis*, 2.5.31-32), οἱ μὲν στρατηγοὶ παρεχλήθησαν εἰςω, Πιρόξενος Βοιώτιος, Μένων Θετταλός, Ἀγιας Ἀρχάς, Κλέαρχος Λάκων, Σωκράτης Ἀχαιός, “the *strategoi* were called from within: Proxenos the Boiotian, Menôn the Thessalian, Agias the Arcadian, Clearchos the Laconian, Socrates the Achaian”: no doubt this is because they had to command soldiers from different cities within each *ethnos* and, as a result, were recognized as having what can be called a “regional scope”. They are therefore closer, in my opinion, to the case of Bacchôn among the Nesiots.
