### BACKGROUND

• Five-to-six-year-olds' abilities to detect and solve ambiguities in speech is a strong predictor of their later reading abilities in first-to-third grade [1-2].

### But why does this relationship exist?

- For some researchers, success in ambiguity detection is reflective of better language skills, which varies with socioeconomic status [3] and is known to impact reading [4].
- For others, kindergarteners' ability to deal with representational conflict in speech is better explained by their cognitive control skills (5), which also impacts literacy attainment [6].

# **RESEARCH QUESTIONS**

- What is the contribution of oral language knowledge, SES, and cognitive control skills to children's ability to detect ambiguities ?
- And what is the relationship among all these factors to early reading development?

# **METHODS AND MATERIALS**

**Participants:** Thirty-eight French-learning preschoolers (Mage=67.6mo, from 61 to

# RESULTS

- The relationship between individual differences on all the measures with children's performance in the ambiguity detection task was investigated.
- For the ambiguity detection task, we kept only the comparison with ambiguous and unambiguous sentences with two targets in our analyses.
- Our results (Fig2-A-B) show that 5-to-6-year-olds vary greatly in their ability to detect both lexical and structural ambiguities and their performance in the two type of ambiguities are strongly correlated.



Figure 2-A-B: Results of the Ambiguity Detection Task. The box-and-whiskers represents the average of the scores in (A) Ambiguous vs Unambiguous Trials on the left, and (B) in each type of Ambiguous sentence, on the right. Each gray dot represents the average for one participant in each condition. Within each plot, the white dashed line represents the mean of the distribution, and the solid black line in the middle represents the median. Children performed better in Unambiguous trials than Ambiguous trials (t(1,37)=12.37, p<.001\*\*\*) and in Structural Ambiguities than Lexical Ambiguities (t(1,37)= 4.09, p<.001\*\*\*). Within lexical ambiguities, participants performed better in detecting Noun-Noun Ambiguities than Noun-Verb Ambiguities (t(1,37)=5.13, p<.001\*\*\*).

### ABSTRACT

**Procedure:** Participants were tested in 3 different tasks and their SES was indexed by the number of years of maternal education after the end of high school.

### 1. Ambiguity detection task (adapted from [2]) :

- On each trial, the child heard a sentence and had to find the picture(s) that matched it. • 12 sentences contained a lexical ambiguity (6 with noun-noun homophones and 6 with noun-verb homophones)
  - 12 sentences contained structural ambiguities

For the ambiguous sentences, amongst the four pictures presented, two depicted different meanings for the same ambiguous sentence.

• 12 sentences were unambiguous (6 trials contained two pictures illustrating the same meaning for a given sentence, 6 trials had only one target picture)

• Children's cognitive control skills (i.e., Flanker Switch Cost) is the strongest predictor of kindergarteners' ambiguity resolution abilities. This effect does not interact with the type of ambiguity tested (lexical vs structural).

olds' abilities to detect and solve ambiguities in speech is a strong predictor of their later reading abilities in first-to-third grade. However, the origins of this relationship remain unclear. For some researchers, success in ambiguity detection is reflective of global language knowledge, while for others, it is reflective of cognitive control skills. In this study, we examined the contributions of oral language knowledge, SES, and cognitive control skills to preschoolers' ability to detect ambiguities. Later we will investigate the relationship among all these factors to early reading development. Our preliminary results show that 5-to-6-year-olds vary greatly in their ability to detect both lexical and structural ambiguities in speech. Moreover, regression analysis revealed that children's cognitive control skills is the strongest predictor of kindergarteners' ambiguity resolution abilities. This is the first study demonstrating that the ambiguity detection task designed to predict reading performance in children is also reflecting their cognitive control skills.

#### Figure 1. Examples of the trials used in the Ambiguity Detection Task.

Participants earned 4 points if they spontaneously identified two pictures illustrating each of the possible meanings; 3 points if they answered correctly after one additional prompt ("Are there any two pictures that sound EXACTLY alike?"); 2 points for a correct answer after another prompt (the experimenter named each picture, played the sentence again and reasked the question). If after all these attempts children did not identify the two correct pictures, no points were awarded in the trial and the experimenter passed to the next trial.

#### **2. Cognitive control task** (Flanker-No/Go task, same used in [5]) :

- Children had to "feed the hungry fish" in the middle of the screen by pressing a key at the left or the right side of the keyboard, depending on the direction in which the fish in the middle of the screen was swimming. When they saw empty fish bowls around the middle fish, they were told they should not press any button.
- 36 trials (12 in each condition: congruent, incongruent and no-go, e.g, Fig. 2)

## DISCUSSION

- From the age of 5, children are able to detect and successfully solve ambiguities in oral language. As a group, they successfully detected and solved both lexical and structural ambiguities.
- However, at the individual level, these ambiguity detection skills vary greatly from child to child.
- In accordance with the results of [5], we found that children's cognitive control skills measured via a Flanker task is the strongest predictor of preschoolers' ambiguity resolution skills.

### CONCLUSIONS

• This is the first study demonstrating that the ambiguity detection task designed (by [1],[2]) to predict reading performance in children is also reflecting their cognitive control skills.

• The next step is to test these same participants again once they learn to read (in two years) and evaluate the impact of all these factors in children's reading comprehension skills. We predict that any relationship between ambiguity detection and reading ability will be explained by cognitive control.
