#### 21 1 Introduction

22 Since Le Roy Ladurie's pioneering study of early-nineteenth-century French conscripts (Aron et al. 1972), further research, undertaken in the field of 23 anthropometrics, has revealed that during the first phase of industrialization, the 24 mean height (a measurement that is considered a reliable indicator of net nutrition) 25 of both Europeans and Americans declined, despite the fact that the standard 26 27 economic indexes indicate that the standard of living was stable if not rising: a pair 28 of phenomena known, respectively, as the early-industrial-growth puzzle and the 29 Antebellum puzzle (Komlos 1998; Steckel 1998).

30 Historians in the field of anthropometrics have yet to reach a consensus 31 concerning this paradox of a height decline during a period of economic growth,

32 although market integration and the rapid pace of urbanization are frequently 33 mentioned as key factors. That the urban setting had a negative influence on height 34 has been established by numerous studies of capital cities throughout the world.<sup>1</sup> 35 For Komlos, urbanites were relatively short during the early stages of industrial-36 ization not only because they consumed fewer calories and less protein than did 37 their rural counterparts (on account of the higher cost of food in the urban market) 38 but also because the supply systems were inefficient, favoring both producers and 39 consumers on the market's periphery when it came to variety and quality as well as 40 to price (Komlos 1995, 2003). For Steckel, Riley, and the like, gross nutrition-41 nutritional intake—is not the only explanation: one must also take into consideration 42 the unfavorable epidemiological context of urban areas. (Komlos 1995, 2003). In 43 the absence of a sewage system, of piped drinkable water, and of the public-health 44 reforms instigated by the discoveries of Pasteur, the extremely dense population of 45 nineteenth-century cities meant that contagions were far more frequent and spread 46 far more rapidly there than in the countryside.

47 In this respect, France would seem to be a rare double exception, in that she is one 48 of the few countries in which industrialization was not directly correlated with an 49 overall height decline and, moreover, in which, along with Spain, the concomitant 50 urbanization was in fact directly correlated with taller heights (Van Meerten 1990; 51 Weir 1997; Martínez Carrión and Moreno-Lázaro 2007). Spain and France would 52 seem to constitute a sort of latter-day version of an archaic Latin model whereby, in 53 the absence of genuine industrial growth, small towns would benefit from their status 54 as centers of traditional administrative, financial, and commercial concerns, since 55 such a thriving economy would generate a relatively elevated standard of living, as 56 indicated by a relatively elevated mean height.<sup>2</sup> However, it has been proved that 57 certain regions of France experienced a height decline at the end of the eighteenth century or during the first half of the nineteenth century; a number of researchers, 58 59 equipped with very different analytical techniques, have demonstrated that Parisians 60 were shorter than their rural counterparts (Koch and Schubert 2011; Heyberger 2007; 61 Komlos 1993; Soudjian 2008; Postel-Vinay and Sahn 2010).

62 The purpose of this study is to gauge, by applying to the hitherto blurred and obscure field of explanatory factors a new and improved analytical gauge, permitting 63 64 an analysis with a resolution far finer than that of previous analyses, which as a rule 65 have got no closer than the departmental-data level—the impact of urbanization on the height of French conscripts born in the middle of the nineteenth century.<sup>3</sup> The 66 crux of our analysis is a comparison of the influence on height of nutritional 67 68 availability (protein and calories) and energy expenditure (diseases, in an epidemi-69 ological context). We incorporate ancillary evidence of the importance of factors 70 such as literacy as determinants of net nutrition that there is a correlation as 71 demonstrated in the case of France both by Weir and by Postel-Vinay and Sahn but is

often neglected in analyses of other countries (Weir 1997; Postel-Vinay and Sahn 2010). We also discuss the relative impact on height of nutritional elements in terms of both diet and nutritional availability. By "diet", we mean the consumption of foods of particular importance for anthropometric growth, chiefly milk (in line with Baten's "milk hypothesis": Baten 1999a, b, 2009; Baten and Murray 2000; Baten and Komlos 2004), and by "nutrition", an estimate of nutritional availability broken down into its various elements (calories, protein, etc.).

79 Given that France's national railway system was being constructed during the 80 growth years of the conscripts in this study, we also consider what impact it may have had on height, since it has been shown that in the US, the development of the railway 81 82 system was correlated with shorter height (Haines 1998; Haines et al. 2003). Finally, 83 when it comes to methodology, since recent research underlines the necessity of 84 calling into question the postulate of normality on the basis of anthropometric history,<sup>4</sup> we compare our regressions by making the endogenous variable the mean 85 height, on the one hand, and the stunted proportion of conscripts, on the other.<sup>5</sup> 86

For anybody intending to tackle these questions, the nineteenth century offers an 87 88 array of resources. It is certainly true that throughout the century, France remained an 89 essentially rural country, the urban population being smaller than the rural one until as late as 1931; nevertheless, it was as early as the reign of Napoleon III (1852–1870) 90 91 that massive immigration, draining the countryside of its agricultural workforce, caused an urban population explosion.<sup>6</sup> According to Soudjian (2008), the Parisian 92 conscripts' mean height declined over the course of the first half of the century, 93 reaching its nadir with the 1851/1852 birth cohorts.<sup>7</sup> The same chronological pattern 94 prevailed in Mulhouse, "the French Manchester," and the explanation for it is not a 95 massive influx of poor peasants (Heyberger 2007). Since our data set consists of 96 measurements of conscripts born in 1848, it permits us to calculate the net-nutrition 97 level in French towns and cities at what seems to be-according to these two pieces 98 99 of anthropometric evidence and from an anthropometric angle-the most critical moment in the half-century-long period of industrialization. 100

- 101 The middle of the century also marked a rupture in the organization of the 102 market, which may have contributed to the evolution of anthropometrical trends on 103 a larger time scale.<sup>8</sup> Until mid-century, wheat, which had always been the basis of

104 the French diet, was undoubtedly marketed throughout the country, but mostly (all 105 but 13 %) at the local—district or arrondissement—level, not far from where it had 106 been harvested.<sup>9</sup> Improvements in agriculture and hence diet were virtually 107 nonexistent (Toutain 1971; Grantham 1995; Morineau 1971, 1972, 1974). In 1850, 108 the diet of the vast majority of the French population consisted of an age-old diet in 109 which protein was derived primarily from grains, but this was about to change, for 110 the second half of the century would be notable for an unprecedented increase in the consumption of foods, chiefly meat and milk, that provide animal protein (Bonnain-111 112 Moerdijk 1975; Toutain 1971).

When it comes to conjunctures of crises, the mid-century in France, and 113 elsewhere in Europe as well, was marked by a series of crises that were agricultural 114 115 as well as demographic. Nevertheless, when height is considered at the national 116 level, one finds no difference between the 1848 birth cohort and the previous birth decade—surprising, since one would expect a height decline during such hard times, 117 due to an increase in the malnutrition of the poorest.<sup>10</sup> Furthermore, at the local 118 level, there is no evidence that the 1848 birth cohort represents the worst year of the 119 century.<sup>11</sup> It is therefore not evident that these crises have any particular impact on 120 121 the height of young men born in 1848.

#### 122 **2** The sources and the data set

In the models that we have constructed, the endogenous variable is the individual 123 stature or the average height of conscripts and the explanatory variables are the 124 conscripts' profession and educational level, the degree of urbanization and the 125 126 presence or absence of a railway line in their canton of residence, the nutritional 127 availabilities at the district level, the department of residence, and the infantile mortality and life-expectancy rates at the departmental level. The agricultural 128 129 survey of 1852 presented data at the district—arrondissement—level, not just the 130 departmental one, as would be the case with later surveys, thus providing us with a 131 correspondingly more detailed picture of the standard French diet (Ministère de 132 l'agriculture, du commerce et des travaux publics 1858 and 1860). Thanks to this 133 survey—which, when it has been tapped for its statistics, has proved to be extremely

137 reliable (Désert 1975; Demonet 1990; Postel-Vinay and Robin 1992)—we have 138 been able to construct the nutritional variables of our models at the district level<sup>12</sup>: variables that permit us to gauge the nutritional availability according to 139 consumption patterns of both grains and meat and fish, the two principal sources 140 of calories and proteins.<sup>13</sup> Our estimate of calcium availability is based on cow's-141 milk production, excluding Paris's consumption of dairy products.<sup>14</sup> 142 143

Our purpose in using this variable is to test the nutritional importance of milk-Baten's "milk hypothesis"-on anthropometric growth. Milk constitutes an 144 145 inexpensive and nutritionally complete product, rich in both proteins and calcium, and therefore may be, when it comes to such growth, the most important of all 146 animal-protein sources. We also have production figures for vegetables, including 147 potatoes, but they are of little importance as sources of nutrition at the national 148 149 level, even if potatoes were far more consumed in some regions of our sample.<sup>15</sup> Because the agricultural survey does not provide data for the city of Paris which 150

The proportion of agricultural workers varies 12FL13 12FL14 considerably from one district to another; in fact, it is nonexistent or nearly so in a number of districts despite their being essentially rural. The composition of the active population is thus too complex and 12FL15 12FL16 varied at the district level for the wages of a given category of workers to have a significant impact on 12FL17 individual height. For the same reason, even though the regressions conducted at the individual level (the 12FL18 endogenous variable being individual height) demonstrate the importance of the job structure as a factor in the anthropometric disparities that we observe, the introduction of job-category variables into the 12FL19 12FL20 regressions conducted at the aggregated level (the endogenous variable being mean height per district) 12FL21 does not provide an explanation of those disparities. In fact, the two categories that not only are the most 12FL22 populous but also compose the shortest mean-height category (agricultural and textile workers) constitute 12FL23 such a small proportion of the total that their introduction as a poverty-level marker does not improve the 12FL24 models' capacity to explain the situation.

151 would permit us to calculate the nutritional content of the diet there, we have instead 152 used the reference work of Armand Husson.<sup>16</sup>

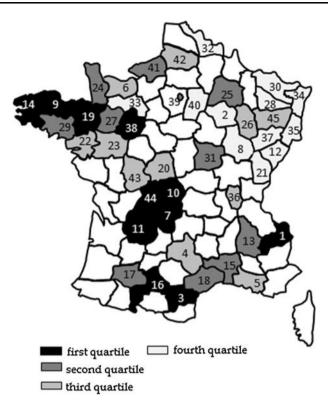


Fig. 1 First quartile: 162.24–164.49 cm; second quartile: 164.55–165.60 cm, third quartile: 165.69–166.80 cm, fourth quartile: 166.88–169.2 cm. *Source* see note 17. *1* Alpes (Hautes), *2* Aube, *3* Aude, *4* Aveyron, *5* Bouches-du-Rhône, *6* Calvados, *7* Corrèze, *8* Côte-d'Or, *9* Côtes-du-Nord, *10* Creuse, *11* Dordogne, *12* Doubs, *13* Drôme, *14* Finistère, *15* Gard, *16* Garonne (Haute), *17* Gers, *18* Hérault, *19* Ille-et-Vilaine, *20* Indre, *21* Jura, *22* Loire-Inférieure, *23* Maine-et-Loire, *24* Manche, *25* Marne, *26* Marne (Haute), *37* Mayenne, *28* Meurthe, *29* Morbihan, *30* Moselle, *31* Nièvre, *32* Nord, *33* Orne, *34* Rhin (Bas), *35* Rhin (Haut), *36* Rhône, *37* Saône (Haute), *38* Sarthe, *39* Seine, *40* Seine-et-Marne, *41* Seine-Inférieure, *42* Somme, *43* Vienne, *44* Vienne (Haute), *45* Vosges

The draft-lottery lists for the 1868 "classes" include the other important source 153 for this study.<sup>17</sup> These individual records, which date from early 1869, provide us 154 with the height, profession, educational level, and canton in which the conscripts-155 comprising Frenchmen born in 1848 and still alive in 1868—legally reside.<sup>18</sup> The 156 157 individual data contained in the lists drive from 45 departments spanning the 158 country (Fig. 1). For the purposes of this analysis, we have selected 105,324 159 individual conscript files, spanning 134 districts that together constitute 41.6 % of the total French population at the time of the 1851 census.<sup>19</sup> Our sample is not a 160 random sample, rather a "convenience sample".<sup>20</sup> However, it is large enough to 161 make historical arguments about the populations as a whole (Table 1). 162

The mean height in our sample is 165.61 cm (Table 2),<sup>21</sup> whereas the median height of Weir's 1848 birth cohort is only 164.70 cm (Weir 1997). The average of the sample is thus somewhat taller, and by extension better off, than the average for the whole of France. This is quite surprising, since this sample covers to an equal extent departments both to the north and to the south of the Saint-Malo-Geneva line (Fig. 1).

- 169 The pioneering study of Dupin (1827) proved that Frenchmen living to the south 170 of this line were, as a rule, shorter than their northern counterparts.<sup>22</sup> However, the
- 171 average height of the southern conscripts in this sample is the same as Weir's

The French administrative units are, from smallest to largest, the commune, the canton, the district, and the department; thus, canton-level data provide a high degree of material detail and hence permit an equally high degree of analytical accuracy.

173 and the Limousin, are included—if also the relatively prosperous southern 174 departments, such as Rhône and Bouches-du-Rhône-whereas the northern 175 conscripts were somewhat taller (166.6 cm, N = 51,414, see Fig. 1). Nevertheless, 176 one must bear in mind that here we are comparing our data set (the individual 177 heights of all the young men born in 1848 and still alive in 1869) with that of Weir (the median height of all of those deemed fit for service). It seems only logical that 178 179 the median height of those conscripts deemed fit for service would have been greater 180 than the average height of the entire birth cohort; one must not forget that Weir had 181 to correct his data because of the minimum-height requirement, which may have 182 made for underestimation, and above all that the aggregated data used by Weir are 183 apparently unreliable: "the observed distribution diverges, sometimes to a 184 ridiculous extent, from the bell curve (Bassino and Dormois 2009, p. 113; see 185 also Duclos et al. 2011), whereas in our data, the distribution of the individual

186 heights, checked by Komlos's recommended method (Komlos 2004), displays no

187 such anomalies.

188 A final, double, caution regarding our difficulties with these data: on the one 189 hand, in some departments, the extant height records at the district level are 190 incomplete; on the other hand, for reasons of methodology not all of those records 191 that were at our disposal could, in fact, be included.<sup>23</sup>

By combing the conscription lists for all references to the conscripts' employment status, we turned up more than 2,000 different job titles. In their

194 research based on a nineteenth-century French data set of similar size, Dupâquier 195 and Pélissier encountered the same sort of job-description material; we have 196 therefore adopted their method of classification (Dupâquier and Pélissier 1992). 197 Selecting seventeen job categories was a necessary compromise between the need 198 for synthesis—in the face of such a huge number of specialties—and a need for 199 accuracy—faced with the social complexity that these data describe.

From the canton-of-residence variable, we are able to derive the living milieu and railway variables, in line with the thresholds shown in Table 1.<sup>24</sup> These variables are very finely calibrated, since a district in our sample consists, on average, of eight cantons, whereas the average department, the size of which is roughly the equivalent of a county, consists of four districts.

The threshold between "town" and "country" that we have chosen to apply (5,000) is the one currently used by specialists in urban history and by certain economic historians, because it distinguishes between rural villages and genuine towns.<sup>25</sup> We have chosen to express the urbanization variable in its discrete form, because this permits us to gauge it at each threshold, a measurement obscured by Weir's approach, without altering the sign associated with the coefficients of the "town" variables.<sup>26</sup> Last but not least, this approach enables us to evaluate directly

The railway variable indicates that a track crosses the canton, but not necessarily 5 the presence of a station. In nineteenth-century France, the construction of a railway line could prompt the emergence of diseases new to the region which were liable to 6 7 sap the victims' strength and thus cause height to decline (Beaugrand 1874). In 8 order to factor in the totality of both the positive and the negative side effects of 9 railway construction, a railway-line model is more relevant than a railway-station 0 one. The population density of France greatly exceeded that of the US; it thus makes sense to conduct an analysis of the French railway network's impact at the cantonal level, since it is safe to assume that in France the lines ran through densely 223 populated regions and could be reached on foot in no more than one or 2 h; thus, the 224 canton-level data are sufficiently substantial to offer a far more accurate picture of the situation than would those at the district level.<sup>28</sup> The variable was created in 225 order to gauge the impact of the railway network in its first year of existence (1853), 226 only a year after the 1852 agricultural survey, and coinciding with the infancy of the 227 conscripts, even though only 11.6 % of the rural ones lived in a canton that 228 229 benefited from a railway line.

Nevertheless, the national network was largely constructed during the reign of 230 231 Napoleon III; 43.9 % of the rural conscripts lived in a canton that benefited from train service in 1868.<sup>29</sup> It is therefore important to measure the impact of the railway 232 in 1868. 233

234 A final point: Although the variables "life expectancy" at birth for female 235 (Bonneuil 1997) and infant mortality (Le Bras and Todd 1981) can be calculated only at the departmental level (Table 3), they are crucial figures, providing the only 236 reliable approximations we have of the epidemiological environment and thus of the 237 238 average energy-expenditure rate.

One can, in fact, consider height to be a measure of net nutrition obtained by 239 240 subtracting expended energy from gross nutrition (Baten 1999a). These energy expenditures range from basal metabolism to child labor by way of diseases 241 contracted during the growth years. Basal metabolism constitutes an irreducible 242 expenditure, whereas child labor is very difficult to quantify. An analysis of energy 243 244 expenditures therefore usually (including here) comes down to the impact of the 245 epidemiological context, estimated in terms of the infant mortality rate and life

expectancy at birth. The impact of infantile diseases on adult height is all the greater
in that it becomes apparent during the first 3 years of life, when the natural growth
rate is at its peak (Tanner 1994). Thus, for the birth cohort of a given year, infant
mortality, life expectancy at birth, and adult height are linked (Komlos 1998;
Horlings and Smits 1997; Weir 1997; Haines 1998).

For our analysis, the use of Bonneuil's data seems to be more accurate, since the infant mortality figures seem to constitute an underestimation of the urban mortality rate, whereas those for life expectancy do not.<sup>30</sup>

#### 254 3 An apparent paradox: big cities make for tall citizens—but at what price?

255 Comparison of the gross-average figures reveals that urban-rural height differences 256 were insignificant. Parisians (165.57 cm) were almost exactly the same height as their rural counterparts (165.59 cm), and even the inhabitants of other large cities 257 258 (Marseille, Lyon, Rouen, Lille), who were the worst off of the lot, were only 3 mm 259 shorter (165.26 cm). Those who seem to have benefited from the highest level of net nutrition were the inhabitants of medium-size and small towns (165.66 and 260 261 165.76 cm, respectively), very slightly above the height of the entire sample 262 (165.61 cm).

These results may seem surprising in light of the fact that, as we have already mentioned, the urban environment has been shown to have had a negative impact on

height during the first phase of industrialization in numerous countries and capital cities. Any lingering doubt regarding the sanitary conditions of nineteenth-century French cities is obliterated when one considers the grim female life-expectancy figures.<sup>31</sup> It therefore seems paradoxical that the inhabitants of Paris and other French cities would be so tall relative to their rural compatriots.

In fact, as soon as one controls the influence of the conscripts' living milieu for occupations and educational levels, combined (Table 4) or separate (not reported here), one finds that an urban penalty existed in nineteenth-century France, just as it did in other countries. The larger the city, the higher was the penalty. If the raw data indicate that residents of Paris and other French large towns were as tall as their rural counterparts, this parity is in fact a function of their having attained a superior educational level and their having found jobs that paid better and were less physically taxing than agricultural labor, thus offsetting the urban penalty. On the other hand, the urban penalty was insignificant if not nonexistent in small- and medium-size towns, no doubt because these towns were too small for the negative effects of their expansion to translate into a decline in height of their inhabitants.

The coefficients associated with various job groups bear the sign that one would 281 282 expect: the most advantaged were white-collar workers, whereas urban manual workers, paid a pittance, were at the bottom of the anthropometrical hierarchy.<sup>32</sup> 283 284 The beginning of the modern era, fundamentally industrial and urban, was thus accompanied by a widening of several anthropometric gaps, in conformity with 285 Kuznets's hypothesis that economic inequality increases during the period of early 286 287 industrialization. The height gap between craftsmen and farm-workers, employed as they were in traditional and rural sectors, was not as wide. Proximity to food sources 288 289 helps to account for a relatively high nutritional level among farmers. On the other hand, those who prepared foods ("food-production trade": butchers, pastry cooks, 290 bakers, et al.) did not enjoy a significant advantage, largely because this category 291 292 was not exclusively one of independent artisans but included a considerable number 293 of workers and apprentices as well.<sup>33</sup>

The results obtained concerning the influence of profession and educational level on anthropometric inequalities provide a nuanced clarification of the issue of the role played by income inequalities on the height decline that occurred during industrialization. On the national scale, it is notably thanks to a favorable income structure and to a superior cultural capital—in other words, to an increase in the

extent of inequalities—that the height of the residents of large cities, paradoxically, does not decline relative to average height in small towns and the countryside. This compensatory mechanism of anthropometric inequalities among various types of living areas coexists, nevertheless, with an income spread that is greater in major cities than in the countryside.

304 As for the nutritional variables as explanatory ones (the endogenous variable 305 being individual height), the coefficients associated with nutritional availabilities 306 are significant, if not equally important (Table 4, models 2 and 3). For instance, to 307 observe an individual height increase of 1 cm, an additional 2,500 cal or 14 g of animal protein, on average, is needed: nearly the equivalent of an entire day's 308 availability. This may seem like a large amount but in fact is in line with results 309 310 obtained by a different method for US individuals (Haines et al. 2003). On the other 311 hand, the same growth can be observed by increasing the Crude Nutrition Index (see 312 Table 1 for definition) of 16.7 % or by adding a mere 40 cl of raw milk or 33 g of protein.34 313

Comparison of the values for animal protein and milk could lead one to wonder whether, when it comes to accounting for a height increase, milk may be less important than meat, since a portion of <90 g of edible meat contains 14 g of animal protein, whereas one would have to drink 400 g of raw milk to absorb the equivalent amount, which would cost at least as much.<sup>35</sup>

We are not in a position to resolve the milk-versus-meat debate from a nutritional point of view; nevertheless, it seems safe to say that animal protein is an important factor in the net-nutrition discrepancies among individuals from different districts. The introduction of nutritional variables as explanatory ones does not significantly modify the coefficients associated with the living milieu (urban vs. rural), in the case of calories, proteins, or calcium (Table 4, models 1 and 2, and models not reported here). On the other hand, the introduction of the animal-protein variable

(Table 4, model 3) reveals the importance of a high-protein diet in maintaining
 urbanites' height.<sup>36</sup>

Introducing into the regression the variables for the department of residence results in such a sharp decrease in the value of the animal-protein coefficient that it is no longer significant (Table 5). This result is not, in fact, surprising, since the Saint-Malo-Geneva line is defined not only by anthropometric factors but also by a higher rate of animal-protein consumption in the north than in the south, that is, the anthropometric geography and the dietary geography are identical.

334 The negative coefficient for Paris also decreases significantly, but this is due to the fact that the department of Seine is nearly identical to the city of Paris. This 335 336 coefficient indicates only that the vast majority of Parisians (N = 8,347) were 337 somewhat shorter than their suburban counterparts (N = 812) and that most of the 338 urban penalty of Paris is captured by the "Seine" variable. More important is the 339 fact that the negative coefficients associated with the large and medium-size towns 340 almost double: not surprising, either, since they were located to the north of the 341 Saint-Malo-Geneva line and thus in the region of France with the tallest inhabitants. 342 Controlling for department of residence thus clarifies the phenomenon of the urban 343 penalty.

If one controls model 3 of Table 4 for the presence of a railway line in 1853 or 1868, the negative value of the cities coefficient increases slightly—models not reported here.<sup>37</sup> Although, as we have observed, the geographical layouts of the railway network in 1853 and 1868 were vastly different, the positive coefficients associated with its presence in these 2 years are virtually identical, on the order of 4 mm.

Nevertheless, this "positive" impact of the railway seems to be a statistical artifact. If one controls these models for the departments of residence—models not reported here—the coefficient associated with the railway lines diminishes almost to nothing, be the network that of 1868 (+2 mm) or that of 1853 (-0,1 mm). In other words, most of the railways were built in the most prosperous region; what was captured by the railway variable before introducing departments into the regression was partly a general socio-economic feature.

To test the hypothesis that energy expenditure, especially when disease is the cause, has a significant impact on health and therefore on height, we introduce the variables of female life expectancy and infant mortality, which can be observed only at the departmental level (Table 4, model 4, and a model not reported here). These variables turn out as expected: *ceteris paribus*, an increase of 7.7 years (life expectancy) or a decrease of 333 ‰ (infant mortality) is correlated with a height

increase of 1 cm.<sup>38</sup> What is more, the absolute value of the negative coefficient associated with cities diminishes when one controls the regression for life expectancy (Table 4, models 3 and 4): a certain percentage of the shortest inhabitants in a given city can be accounted for by the low overall life-expectancy rate there. Nevertheless, the coefficients associated with the cities in the fourth model (Table 4) remain negative even after one has controlled for life expectancy, especially in the case of Paris; one can therefore attribute the value of these coefficients to non-fatal illnesses.

Our analysis thus encourages reconsideration of the importance of those factors associated with energy expenses in determining height at a critical moment in French urban history. It lends equal support to the idea that the deterioration in epidemiological and hygienic conditions constituted the primary factor in the decline in the mean height of Parisians during the first half of the century.

376 The fact that the coefficients associated with the cities in Table 4, model 4, 377 remain negative even after one has controlled for life expectancy could also be 378 explained by the migration of poor (and short) rural workers, as migration was not 379 included in the analysis. An analysis in which conscripts living in Belfort and 380 Mulhouse (medium-size towns undergoing high levels of migration coupled with rapid industrial growth) were individually sorted into "city-born" and "country-381 382 born" revealed no significant height difference between the two categories (Heyberger 2005, 2008, see also note 12). It therefore seems unlikely that the 383 urban penalty observed in Table 4 is due to phenomenon of migration on the part of 384 385 the poorest sector of society. Furthermore, there is evidence that in nineteenthcentury France, migrants were, as a rule, taller than non-migrants (Boëtsch et al. 386 387 2008, see also Humphries and Leunig 2009 for England).

Controlling the influence of life expectancy (Table 4, model 4) for departments of residence causes a change in the sign of the life-expectancy coefficient, which remains significant at the 10 % level (Table 5, model 2): when life expectancy increases, height decreases. This phenomenon could be explained by the fact that non-fatal illnesses may be more important than fatal illnesses when it comes to determining height discrepancies between departments and districts.

The regressions in Tables 4 and 5, calculated as they are on the basis of observations at the individual level, serve as a fine filter for our analysis of the influence of one or another explanatory factor. However, when one takes into account the vast quantity of individual observations, the total variance in height is more a matter of genetics than of socio-economic factors. The adjusted  $R^2$ s are therefore very weak, even if the coefficients of each variable considered individually are of great interest.

401 Analyses at the aggregated level (Table 6), on the contrary, reveal what roles, 402 more or less important, socio-economic factors play to the extent that mean height, 403 as opposed to individual height, constitutes an index that is far more a function of socio-economic than of genetic factors.<sup>39</sup> To use a chronological analogy, in a 404 school, the observed difference in individual height among students in year X is 406 important in that it accords more importance to the genetic potential of each 407 person's growth than to inequalities in living conditions. On the other hand, if one compares the average height for year X in a given school to that for year X + 30 in 408 409 the same school, the observed height difference between year X and year X + 30will be much smaller than the observed difference between the shortest and the 410 411 tallest students in year X, but it is explained by socio-economic factors alone.

412 Certain explanatory variables that produced satisfactory results at the individual 413 level did not produce noticeable and significant results for mean height at the district level,<sup>40</sup> again on account of these problems of scale. This holds true not only for the 414 job structure but also for the impact of the milieu (city or country)<sup>41</sup>; we therefore 415 omit from our table the regressions that include these variables. At the same time, 416 the regressions calculated with mean height at the district level as endogenous 417 418 variable and a single explanatory factor indicate that calorie levels do not explain the anthropometric disparities found to exist between one district and another. On 419 420 the other hand, the other explanatory factors, which we consider separately, offer a partial explanation of the observed inequalities; the literacy rate provides the closest 421 correlation.<sup>42</sup> 422

This analysis is confirmed in Table 6:43 socio-economic factors account for the 423 majority of the anthropometric inter-district disparities. The fact that there is a 424 425 particularly close correlation between the conscripts' literacy level and the anthropometric indexes prompts one to reconsider-as did Postel-Vinay and Sahn 426 recently, on the departmental scale-the importance of human-capital formation in 427 428 the determination of net-nutrition levels (Postel-Vinay and Sahn 2010). A 1-cm 429 increase in the conscripts' average height requires a 14.3 % literacy rate increase: a 430 relatively small figure, to the extent that the standard deviation for the latter variable 431 is 18.9.

432 Literacy is not just a proxy for per capita income, although, for one thing, it 433 certainly helps to reduce the number of unwanted pregnancies and thus improves 434 children's gross nutrition (Weir 1993, 1997). For another, in certain cases, the 435 positive influence of instruction is observed even after one has controlled for income 436 (Meyer and Selmer 1999; Steckel 1998); the positive influence of educational level 437 would thus reflect not only the children's but also their parents' improved grasp of 438 nutrition issues, enabling them to fight more successfully against diseases by means 439 of health practices and paramedical care that were better adapted than were those of 440 the illiterate conscripts. Last but not least, as a rule children learn to read at school: 441 their being thus spared grueling physical labor during their growth years may help 442 them to reach a greater maximum adult height, although this issue is the focus of 443 intense debate (Ambadekar et al. 1999; Baten 1999a, p. 105; Bogin 1999; Kirby 444 1995; Komlos 1998, p. 791; Steckel 1998, pp. 6 and 9).

In addition, both gross nutrition (availability of animal protein) and net nutrition (female life expectancy) play a role in observed inequalities.<sup>44</sup> At the district level, an increase of 1 cm in average height requires a daily increase of 25 gms of animalprotein availability or an increase in life expectancy of 12.5 years. In both cases, it is a matter of higher values than in the case of individual regressions, but these values remain within plausible orders of magnitude.

#### 451 4 Conclusion

452 The analyses undertaken at the individual level show that the absence of an urban 453 penalty, in anthropometric terms, in nineteenth-century France constitutes a 454 statistical artifact. The height of city dwellers, and especially of Parisians, attains 455 the overall national average only thanks to their consumption of a considerable 456 amount of animal protein, which counterbalances the negative impact of the urban 457 milieu, when it comes to the issues of epidemiology and hygiene.

458 Other socio-economic factors, including the superior literacy rate and the professional structure found only in cities, help to explain the fact that the height of 459 460 city dwellers did not slip below the average for urban and rural areas combined. Overall, a trade-off between the "heightening" factors, which are nutritional (gross 461 nutrition), and the "shortening" ones, which are epidemiological (net nutrition), is 462 achieved not only in Paris but also in other large French cities and in medium-size 463 464 ones as well; this equilibrium prevents us from siding with either the nutrition or the 465 epidemiology camp in the debate over the primary cause of this height pattern.

To the extent that prior analyses of the French "exception" have emphasized the
importance of the role played by nutritional factors (Steckel and Floud 1997;
Komlos 2003), our results lean in the direction of an upward reevaluation of the

469 epidemiological ones. Insofar as Parisians' height declines over the course of the 470 first half of the century among the working classes as well as among the 471 bourgeoisie, the importance of the epidemiological factor, which affects all classes 472 to virtually the same extent, is confirmed—see note 7—especially since this height 473 decrease coincides with an increase in Parisians' food consumption (Husson 1856). 474 Moreover, the fact that no urban penalty is paid by small towns, which are 475 particularly numerous in France, prompts us to question the definition of "urban 476 areas" used in anthropometric studies.

477 At the local—canton—level, the positive and modest impact of the railway 478 proves to be a statistical artifact as soon as one controls for departments of 479 residence. In this respect, our study diverges from anthropometric studies of the 480 history of the railway in the US, in which a different methodology was used to 481 describe a negative (Haines 1998; Haines et al. 2003) or positive (Solakoglu 2007) 482 impact.

483 If one considers mean height at the district (as opposed to the individual) level, 484 the literacy rate is the factor that explains the observed anthropometric disparities 485 far better than do any of the nutritional or epidemiological ones: a finding that 486 suggests that the importance of educational factors as a predictor of net nutrition 487 may have been underestimated. It seems quite plausible that literacy, especially in the case of women, constituted an essential factor not only in the classic 488 demographic transition but also in the corollary physical-growth transition that 489 490 accompanied the Industrial Revolution.

491 When it comes to issues of methodology, we have seen that the most accurate estimates of the impact of gross nutrition on height are calculated on the basis of 492 493 animal-protein availability (meat and fish as well as milk). As for the entirety of our analyses-the endogenous variable at the individual and district levels-animal-494 protein availability produces better results than does either total nutritional 495 496 availability (calories or protein) or nutritional availability from a single product 497 (milk), even if both approaches generate satisfactory ones. Our results thus indicate 498 that the most economic and efficient analytical method is to evaluate the effect of 499 nutritional availability from a range of foodstuffs high in animal protein consumed 500 on a regular basis (meat and milk), rather than from a single product (milk). On the 501 other hand, calculating total caloric availability, far more time-consuming and 502 unreliable because of the deficiency of source material, is not the best option.

Finally, it seems that one could compensate for the lack of mean-height data by substituting an estimate of the stunted proportion of the population in question, since at the district level, the results derived from this statistic are virtually identical to those derived from mean-height data. Our results thus do not undermine the hypothesis of distribution normality currently being debated in anthropometrichistory circles: the stunted proportion of a given population seems to be a statistic no more sensitive to socio-economic factors than is mean height.
