# Introduction

Sometime in the latter half of the fifteenth century, the Swiss astrologer and physician Conrad Heingarter composed a short treatise on planetary latitudes contained in a manuscript destined for his patron, Duke John II of Bourbon (1426–88), while in residence at Belleperche. The work is divided into two sections: a *theorica* and a *practica*. The *theorica* purports to describe the planetary models upon which the tables of planetary latitude were based. The *practica* is a set of canons, which presents instructions to be used with three different types of latitude table. The inclusion of the *practica* implies that the author had more than just a theoretical interest in the subject in mind. He intended for his readers to compute with the tables, and he offered a tutorial on how to do so.

In light of Heingarter's role at the Bourbon court and his career trajectories, his efforts in establishing a practical guide for calculating planetary latitude values may reveal a growing interest among astrologers and physicians — and not just mathematical astronomers — in this relatively advanced branch of astronomy. This shift in technical interests was itself likely spurred on, at least in part, by changes in the practice of medical astrology. Throughout the late-thirteenth and fourteenth centuries in Europe, a medical astrologer's primary tools of prognostication resided in the *figura caeli*, the tracking of the Moon through critical days, and the attribution of astral properties to different medicines. These tools were taken up, in turn, by practitioners of the late medieval and early modern periods.<sup>1</sup>

Paramount among these stood the *figura caeli*, or horoscope, in which the positions of the seven classical planets and the lunar nodes were depicted on a square representation of the zodiac. The nodes, and sometimes the Moon's latitude, were included to account for lunar and solar eclipses. The horoscope was then divided into 12 triangles, representing the houses, which

surrounded a central square providing relevant information such as the time, place, and occasion for which the horoscope had been made. The *figura caeli* typically only included the seven planets' positions in the zodiac in terms of ecliptic longitude, neglecting the latitude values for all but the Moon.<sup>2</sup> With this primary tool, other crucial techniques of astrological practice could be performed, such as calculating directions and profections for the chart, determining planetary conjunctions and aspects, and establishing the date of conception for the native.<sup>3</sup> These latter calculations, however, relied upon the same planetary positions in longitude that a practitioner would find for the base horoscope.

By the late fifteenth century, several salient factors emerged that put pressure on physicians like Heingarter to re-evaluate the theoretical underpinnings of the practices developed for their profession. First, the influx of new texts and translations from the Greek language, especially in the decades leading up to the fall of Constantinople in 1453, had contributed to a concerted effort among scholars to uncover the original teachings of the ancients. From the perspective of the astral sciences, this humanistic impulse was directed towards the goal of finding the authentic doctrines of Ptolemy and the earliest Hellenistic practitioners of astrology.<sup>4</sup> Although there were some who used this search for original texts as an excuse to clear away what were considered to be accretions of later generations, there were others, like Heingarter, who instead sought to gather together and systematize the vast body of knowledge within a single framework.<sup>5</sup> As a consequence of the compiling efforts of this new generation of humanists in the major centres of learning in Western Europe, a greater variety of computing practices were made more widely available to aspiring medical and judicial astrologers that went well beyond planetary longitude and eclipse calculations.

At the same time, medical astrologers were facing a wave of sceptical criticism from those who would rid the arts and sciences of divinatory practices and fatalistic beliefs.<sup>6</sup> Heingarter's own fierce defence of the use of astronomy for medicine appears later in his career when such debates became more prevalent in scholarly circles.<sup>7</sup> In order to justify their craft, some astrologers sought a common ground with their critics by emphasizing the naturalistic foundation of their discipline. Direct causal connections between planetary motions and terrestrial effects were sought that could explain individual events on Earth in terms of specific physical changes in the heavens. Techniques involving planetary conjunctions, oppositions, and aspects were gathered together in astronomical canons, with others requiring an adept to pay close attention to the speed, direction, and nearness of a planet on its epicycle and eccentric in relation to the Earth. The latitudinal position of a planet held great significance within such

a naturalistic system since it could account for the position of the physical body of the planet rather than its projection onto the ecliptic plane.<sup>8</sup> It also played an important role in determining the aspects between these physical bodies. Thus, authors treating techniques involving the so-called planetary accidents or passions often advised the most careful practitioners to take into account the planet's latitudinal position in their computations.<sup>9</sup>

Finally, the greater attention afforded to planetary passions also contributed to what was a broader movement among students, practitioners, and scholars alike to reform the curriculum available for learning astronomy in the university. During this period, the *Theorica planetarum communis*, which had served as the central text on planetary astronomy for university instruction, was routinely criticized for the inadequacy of its final three chapters that considered retrograde and direct motion, the use of planetary latitude tables and their theoretical underpinnings, and planetary aspects.<sup>10</sup> In addition to addressing new interests and concerns in the realm of medical astrology, Heingarter's treatise on latitudes also intervened in these debates over the curriculum of the Latin university system. Thus, because Heingarter's own career sat at the intersection of court politics, the medical profession, and the university, it is clear that he composed his treatise to address different audiences hailing from multiple contexts. The treatise served simultaneously as a humanistic gift of erudition to his patron at Belleperche, a boon to aspiring practitioners of the astral sciences, and was also presented as a commentary text that would aid the arts faculty of Paris in their efforts to expand their curriculum.

By way of introducing Heingarter's treatise and its significance, this article will highlight these three aspects of his career in turn. The first section will discuss his firm commitment to the integration of mathematical astronomy into his practice as a physician and counsellor in the face of sceptical forces within the profession. In addition to this, we will show that his efforts in gathering and commenting on what he considered to be the most authoritative texts in his field brought to the fore several techniques that focused on the importance of planetary accidents in medical and judicial astrology. We will limit ourselves to reviewing the features of these techniques that are relevant to planetary latitudes.

The second section will consider the humanistic impulse that spurred Heingarter to collect and preserve a wide body of textual material on planetary latitude. The many extant witnesses to his library reveal an abiding interest in the subject over the course of many years. Through the identification and analysis of several of these manuscripts, we will reconstruct features of Heingarter's research and collection practice that are relevant to understanding how he composed the treatise.

The third section discusses Heingarter's continued collaboration with masters at the University of Paris and his intention to augment the arts curriculum with his teachings on latitude theory and computation. This element of Heingarter's career has received relatively little attention in the current secondary literature, and we hope to present this text as a facet of

Heingarter's larger project of guiding and training a new generation of students. In doing so, we will provide an overview and analysis of the treatise.

A critical edition and translation of Heingarter's treatise will appear at the end as an Appendix, together with a list of relevant vocabulary terms as a glossary.

# 1. Heingarter's Defence of Medical Astrology

Originally from Horgen near Zürich, Heingarter received his B.A. in 1454, his M.A. in 1455, and his licentiate in medicine at the University of Paris in March 1466. Perhaps as early as 1463 or 1464, Heingarter began his career in the service of John II, whom he served until the duke's death in 1488.<sup>11</sup> During his years of study in Paris, Heingarter had become an avid student of the quadrivium, as has been made readily apparent in the many extant manuscripts either belonging to him or that have transmitted his own original works. From those of his codices preserved at the Bibliothèque nationale de France in Paris, we are offered a unique window into the growth and development of his competencies in mathematical astronomy.<sup>12</sup>

Many of these witnesses contain mathematical texts that were gathered together by Heingarter when he was still a student at the University of Paris. In one such student manuscript, BnF, lat. 7197, introductory texts on arithmetic, geometry, and astronomy filled with Heingarter's annotations sit incongruously alongside Ciceronian orations and Hugh of St Victor's *De grammatica*. Manuscripts such as BnF, lat. 7197 constitute a series of exercises amounting to a corpus of juvenilia, but, even years after writing his youthful notes on the *Sphere* of John of Sacrobosco and the *Theorica planetarum communis*, Heingarter would return to these foundational works again and again for inspiration. He wrote no less than two marginal commentaries on the full text of the *Theorica*, and the planetary latitude treatise itself should be seen as a specialized version of a third such commentary focusing on the *Theorica*'s seventh chapter. He remained committed to the application of astronomy to his profession throughout his life.

A perusal of Heingarter's practice in the first decade or so of his career shows that his methods did not deviate drastically from those of his contemporaries. As a counsellor to the duke and his household, as well as a diplomat and advisor to King Louis XI (the brother of the duchess), Heingarter availed himself of the common astrological tools of his generation. In 1469, he prepared for the king an interpretation of the Saturn-Mars conjunction, although it is

no longer extant.<sup>13</sup> BnF, lat. 7446 contains a nativity that Heingarter prepared for Jean de la Gutte, a favourite at the Bourbon court. In BnF, lat. 7447 there appears a *iudicium anni* for the duke attributed to Heingarter.<sup>14</sup> Likewise Heingarter prepared a *iudicium anni* for the year 1476 addressed to King Louis that is preserved in BnF, lat. 7450.<sup>15</sup> These judgments conform to the typical conventions of finding the degree of the ascension and midheaven, dividing the houses, and finding planetary longitudes for a horoscope.

Something appears to have happened later in Heingarter's career that caused him to become much more self-conscious about the methods of medical astrology. Beginning in the late 1470s and continuing throughout the 1480s, he began writing medical advice and public circulars in which he zealously defended his practice against critics. He wrote one of his most strident defences of the integration of astronomy into medicine to Duchess Jeanne of Bourbon in a work of medical advice dated to August 26, 1480. At the very beginning of this excursus, he included a long chapter, aptly entitled *On the Usefulness of the Science of the Stars and what is Profitable and Necessary to Physicians (De utilitate sciencie astrorum et quod sit medicis proficua et necessaria).*<sup>16</sup> Written three years after Marsilius Ficino's *Disputatio contra iudicium astrologorum* and only six years before Pico della Mirandola's bombshell *900 Theses* were published in Rome, thereby challenging the very epistemic foundations of astrology, Heingarter's defence entered circulation at a moment of sceptical ferment within the medical profession.<sup>17</sup> The text offers an eclectic mix of justifications for astronomy's role in medicine, taking turns in appealing to traditional authorities and natural causation for proof of its efficacy.

It was an inescapable truth to Heingarter that the lower realm of the earth was ruled by celestial bodies and to prove this he called to his defense a host of authorities including Aristotle, Cicero, al-Rāzī, Bernard Gordon ('a modern medical man', cit.), Arnald of Villanova, Abū Ma'shar, Hippocrates, Ptolemy, and the *Speculum astronomie*, which he attributed to Albert the Great.<sup>18</sup> Making heavy weather of the fact that he had tradition on his side, Heingarter was offering a response to rivals who questioned the relevance of the astral sciences to their discipline. Such physicians, he anticipated, would have much to say against what he had written, even though it contained doctrines in agreement, as he himself explains, 'with none but authoritative sources'.<sup>19</sup>

Not satisfied with the invocation of authorities whom he anticipated his opponents would reject out of hand, Heingarter also made an appeal to the natural connections between the heavenly bodies and terrestrial occurrences. Summarizing his opponents' position, Heingarter explained that these physicians found it rash and superstitious for a doctor to consult the stars, since medicine was a science resting on principles of its own. Conceding that, from a methodological point of view, medicine was a discipline deriving its conclusions from its own principles, Heingarter, nevertheless, denied that this implied that medical knowledge

could be gleaned without recourse to the mathematical and natural sciences. Instead, he likened the active principles of medicines, natural compounds, and celestial bodies to the virtues of moral philosophy. 'Just as in ethics the virtues are connected', he wrote, 'so medicine cannot be separated from natural philosophy or astronomy'.<sup>20</sup> Thus, at least by the 1480s, Heingarter had made a point to explain the efficacy of the stars on the health of his patrons in terms of natural causation.

During these years, Heingarter had integrated himself into a circle of renowned medical astrologers, and he even found the time to mentor a budding new generation of scholars. While providing his services to the king, he joined the ranks of many other practitioners, such as Jean Coleman, Arnoul de La Palu, Pierre de Graville, Laurent Hutz, Jacques Loste, and Angelo Cato. More frequently, he would have interacted with his colleagues at the ducal court, including his sometime student Simon de Phares, as well as Jacques Sanglier, Antonio Chiapucin, and S. Belle.<sup>21</sup> In addition to teaching Simon de Phares, Heingarter also served as a mentor to Guillaume Cop and probably also Erhard Windsberger and Conrad Türst. These latter three were all physicians of Swiss origin.

It is from the young scholars whom Heingarter mentored that we find the clearest testimony of his commitment to defending astronomy's role in medicine and his interest in reforming it when necessary. In this regard, an exceptionally revealing document is a letter addressed to Heingarter by Guillaume Cop — the future physician to Louis XII and Francis I, but a *magister artium* and a baccalaureate in medicine at the University of Paris at the time of its composition.<sup>22</sup> The letter, which is dated to 1493, can be found in the first four folios of Vatican, Biblioteca Apostolica Vaticana, Reg. lat. 1241, a paper manuscript of 178 folios of astronomical content.<sup>23</sup> From the opening lines, one learns that Heingarter served as Cop's master and teacher (*dominus et preceptor*):

To the illustrious man Conrad Heingarter of the leafy garden of Zurich, professor of the sidereal science as well as medicine, most erudite physician of the most Christian king of France and the illustrious duke of Bourbon, Guillaume Cop of Basel, Master of Arts and bachelor of medicine, wishes as much health as possible to his master and preceptor, for he venerates him as one among the first rank.<sup>24</sup>

Cop went on to praise Heingarter for the effectiveness of his vigorous polemics against sceptics. Either alluding to his teacher's polemical *De utilitate sciencie astrorum* or to a later work called the *Defensio astronomie*, which, in 1488, he had written in Moulins for Louis Malet de Graville, admiral of France, he declared that Heingarter had effectively defended his abiding interest in the mathematical sciences:

And particularly in astronomy, against the detractors of which you wrote as rigorously as you did elegantly, so that anyone who would read through your 'edition', which you composed with great labour, are forced into silence, having lowered [their] head being unable to reply to it with anything.<sup>25</sup>

From Cop's testimony, we also learn of Heingarter's interest in modifying or clarifying techniques deemed necessary for the practice of the medical astrologer, known as directions. Adopting the rhetorical flourish of the new humanist style, Cop declared:

What could I say about the directions, which all the astrologers of our times have quite an aversion to? Having examined these, as if seeing the face of a Gorgon they would turn to stone and are deeply rendered speechless. You made all these things so clear and easy that to anyone even of little intelligence in a short amount of time those things would be accessible, which, formerly, even a sharp mind in a long amount of time could barely grasp.<sup>26</sup>

The practice of directing a planet in a horoscope had an ancient pedigree, with Ptolemy himself having described its astrological significance in the third book of the *Tetrabiblos*.<sup>27</sup> One planet was chosen from the chart to serve as the representative of the native's physical or spiritual well-being. It was called the significator, and the technique of directing this planet involved projecting it from the line of the ecliptic onto the celestial equator, and then imagining it to move to a place where another planet or aspect from the chart had also been projected onto the equator, this latter one called a promissor.<sup>28</sup> Each degree of movement on the celestial equator was thought to be equivalent to one year of the native's life. When a significator and a promissor met, it was believed that a significant event would occur to affect the native's physical or spiritual health — either for good or for ill.

Cop's assessment that Heingarter had worked on directions and sought to clarify their procedures is corroborated by the fact that one of the longest marginal notes in BnF, lat. 7432, the composition of which Heingarter had supervised for John II, is a paraphrase of John of Saxony's commentary on the influential *Introductorius* of Alcabitius ('Abd al-'Azīz al-Qabīşī).<sup>29</sup> In this passage, Heingarter preserved a detailed set of procedures for calculating

planetary directions.<sup>30</sup> It is one of several such instances in Heingarter's annotated library in which he emphasized the importance of determining planetary latitudes for astrological judgments.

Following the basic instructions for finding directions, which only required the calculation of the planetary longitudes, Heingarter went on to include a section in which he discussed the importance of taking into account planetary latitudes in more carefully considered calculations. Quoting from John of Saxony's commentary, he informed the reader that this method is more difficult.<sup>31</sup> In these cases, the position of the planet projected onto the celestial equator must originate from the physical body of the planet in the zodiac rather than from its unadjusted longitudinal position on the ecliptic line.

Heingarter also detailed the use of an instrument, called a *directorium*, for directing planets with latitude.<sup>32</sup> Such an instrument is described in a text attributed to John of Lignères, which can be found with a crude diagram in BnF, lat. 7295.<sup>33</sup> The instrument is constructed in much the same manner as an astrolabe with a projection of the celestial sphere's climate circles, namely the tropics of Capricorn and Cancer, as well as the celestial equator. A projection of the ecliptic with nested circles of ecliptic latitude are then constructed in the same way that one produces the almucantars found on an astrolabe's climate plate. Furthermore, the rotating element of the *directorium* is not the ecliptic circle, but rather a moveable local horizon set to the terrestrial latitude of the user. This analogue to the rete of an astrolabe is comprised of two arms, one representing the horizon and the other the midheaven. In this way, the *directorium* can determine the points on the celestial equator that rise, set, and culminate with the true position of the planet in latitude to the north or south of the ecliptic plane.

Describing techniques of determining directions, which took into account the planetary latitude, was not the only area of medical astrology where Heingarter sought correctives to contemporary methods. In the same manuscript of BnF, lat. 7432, Heingarter included an excerpt from a work on medical astrology that he entitled the *Tractatus de pronosticis et componendis et ministrandis medicinis* taken from a work by the English Dominican friar, Robert of York (fl. 1313-1325), who was also known as *Perscrutator*.<sup>34</sup> In conclusion 8 of his *De impressionibus aeris*, in which the author treats the forecasting of plagues and pestilences, it is explained that planetary latitudes were to be taken into account when forecasting future onsets of plague. The text identified certain star positions in the zodiac that signified disease and mortality. In the event that a superior planet formed an aspect with one of these positions, it would portend the outbreak of pestilence. To determine these positions, moreover, the planet's latitude and its direction to the south or to the north of the ecliptic had to be found before the aspect between the star and the planet was established. Heingarter included two small tables containing the longitudinal and latitudinal positions of these stars together with their orientations to the north or south of the ecliptic.

The concern described in the *Tractatus de pronosticis* for a practitioner to find a planet's latitude before determining its aspect with certain stars in the zodiac is one case among a subset

of general concerns about ensuring the coherence of astrological doctrine regarding the planetary conjunctions and their effects in the terrestrial realm. As John of Saxony described it in his commentary on the *Introductorius*, there was a difference between planetary aspects in longitude on the one hand, and planetary aspects in both longitude and latitude on the other.<sup>35</sup> If the vicissitudes of planetary rays were truly the cause of the various contingencies and changes on Earth, then planetary bodies surely had to be taken into account. These concerns about attending to the latitude of a planet became readily apparent to anyone who saw a planetary conjunction, for there were perceptible differences between a conjunction in longitude and latitude.

Finally, in his annotations on Pseudo-Ptolemy's *Centiloquium*, Heingarter duly noted the natural effects that a ruling planet could have on the bodily disposition of a native. In the 53<sup>rd</sup> aphorism, the text teaches the practitioner to calculate the ruling planet's latitude to determine the constitution of the individual for whom the birth chart had been drawn.<sup>36</sup> If the planet had no latitude, the native would be lean, and if the planet had a great latitude, the native would be large.

All of these careful notes that Heingarter arranged on the significance of latitudes were part of a much larger body of material that he collected on the importance of determining the velocity of the planets, identifying their stations, retrogradations, and directions, and finding the times when they were at apogee on the epicycles and eccentrics. The planetary latitudes seem to have taken pride of place in Heingarter's mind, and this may have been because ignoring them so starkly undermined any pretensions to a mathematically reliable medical astrology. Critics of the system were certainly aware of this. Deploying arguments that had been propounded earlier against practicing astrologers by such sceptics as Nicole Oresme and Henry of Langenstein, zealous opponents of medical and judicial astrology were quick to assail the insufficiencies of a practice that did not pay due attention to the latitudes of planets.<sup>37</sup> As Pico della Mirandola would so cuttingly observe in his posthumously published *Disputationes adversus astrologiam divinatricem*, even if most astrologers had mastered mathematical astronomy (a fact he was reluctant to accept), they had manifestly failed to apply it correctly. 'How great is their negligence', he wrote, that:

even among those who have an interest in calculating, which most of them lack, you will find few who do not resort to ephemerides to obtain the true position of the stars. [...] But those who do so necessarily make many false statements and omit many things, thereby invalidating the entire truthfulness of the predictions. For there is almost never a reference to the latitudes of the planets; but at what point will the astrologer not err, will he not lie, if he does not take this into account, if we suppose that the principles of this art are true?<sup>38</sup>

The treatise, which Heingarter finally prepared in order to establish the geometrical foundations of the latitude theory and the proper procedures for finding latitude values using the tables, appeared in the same manuscript where so many of these notes on the importance of planetary latitude for medical astrology can be found.

# 2. A Scrupulous Collector and Compiler

Given the content and form of the extant manuscript in which the text was preserved, it would appear that Heingarter's treatise on planetary latitude was also written to convey the erudition of an author worthy to serve under the auspices of a great lord. The treatise can be found as a single witness in the margins of BnF, lat. 7432, which is a codex consisting of 275 folios bearing dimensions of approximately  $125 \times 205$  mm. The manuscript's rich array of marginal notes presented alongside a superbly decorated iconographic programme make it clear that it was meant to be a presentation copy for John II.<sup>39</sup> It exhibits a single neat hand and large margins to include commentaries throughout. Though there may have been several individuals collectively responsible for its creation, the production of the manuscript was carried out under Heingarter's supervision at the castle of Belleperche and is an expression of his public persona. The multi-faceted nature of the manuscript's production, moreover (the three dates of 1468, 1477, and 1485, which can be found in different notes and colophons throughout the manuscript, point to a processual and multi-year composition of the texts and annotations therein), also has the effect of creating conjunctures with other works, tables, stylistic habits, and annotations that are found elsewhere in Heingarter's corpus. What we shall see in this section is that the treatise and its accompanying canons and tables cannot be read independently of other codices contained in his library. The overall effect was that the reading and use of the latitude treatise was performed at the level of a unified library in which common topics of interest found in separate manuscripts emerged in conjunction with one another.

In addition, the types of texts that appear in these manuscripts were chosen strategically to showcase their compiler's status as a consummate humanist collector. The opening works of BnF, lat. 7432, a text on the life of Ptolemy (*De vita Ptholomei*) and another on the life of Hermes Trismegistus (*De Hermete*), were not original to Heingarter, but were rather excerpted from the thirteenth-century *Liber philosophorum moralium antiquorum* attributed to John of Procida (*c*. 1210–*c*. 1298).<sup>40</sup> Nevertheless, their presence at the beginning of the codex signal their compiler's interest in honouring these original adepts of his craft, and perhaps drawing

affinities between them and himself. In this manner, he was also mirroring the posture of his own patron who styled himself a champion of the humanist movement and a great preserver of ancient knowledge. Indeed, Heingarter credited John II with a worldwide survey project on the knowledge of various peoples and praised him for having ordered the correction of some altered works of antiquity.<sup>41</sup> The duke, in Heingarter's estimation, had decided to build up a library after he saw how many volumes had been lost due to the fall of Constantinople in 1453. This led him to collect worthy books from all over the word, repairing and emending them as he deemed necessary.<sup>42</sup>

Insofar as Heingarter contributed to the library's expansion, he did so in ways that manifest conspicuous commonalities across the manuscripts he possessed. For example, Heingarter frequently adorned the manuscripts of his collection with a patina of the humanistic aesthetic in the form of Grecisms and transliterations of Latin text into Greek script. The last four folios of BnF, lat. 7432 contain Greek letters with their orthographic variants, a list of Greek diphthongs, and Christian prayers in Greek with an interlinear Latin translation (*Gloria patri* / Δόξα τῷ πατρὶ, *In nomine patris* / εἰς τὸ ὄνομα τοῦ Πατρὸς, *Ave gratia plena Maria* / Χαῖρε κεχαριτωμένη Μαρία, *Pater noster* / Πάτερ ἡ ῶν, etc.).<sup>43</sup>

His student Guillaume Cop characterized Heingarter as a voracious reader of Greek literature.<sup>44</sup> Witnesses to several works of mathematical astronomy that were Heingarter's bear the same features of transliterating or translating phrases into Greek. The final word of the fly leaf in BnF, lat. 7333 reads 'end', or  $\tau \epsilon \lambda o \zeta$ ,<sup>45</sup> to signal the termination of a contents list giving the title of the major works in the manuscript. And, again, the explicit to a treatise on arithmetic in BnF, lat. 7295A, concludes with a transliteration into Greek of the Latin phrase *Explicit seu finis per Konradum Heingarter*, thereby confirming that parts of this manuscript are indeed an autograph.<sup>46</sup>

These latter two sources are workaday codices, the second of which (BnF, lat. 7295A) has recently been aptly named a 'toolbox' manuscript due to the gradually accumulated sets of relevant computational techniques preserved within it.<sup>47</sup> The similarity between the contents of the works found in these two manuscripts, as well as others in Heingarter's library, and that of BnF, lat. 7432, however, go well beyond the presence of Greek text. They also contain facets of common astronomical problems taken from different perspectives or different genres that clearly relate to one another when read together. For instance, the treatise on planetary latitudes

appears as a marginal commentary on folios  $219^{r}-222^{v}$  of BnF, lat. 7432, mostly framing the last two chapters of the *Theorica planetarum communis*, which are entitled 'On the Latitudes of the Six Planets and the Declination of the Sun', and 'On Finding the Aspects of the Planets'.<sup>48</sup> In like manner, we find two annotated texts in earlier manuscripts that were in Heingarter's possession. In BnF, lat. 7333, Heingarter composed a complete marginal commentary of the *Theorica* (ff. 54<sup>v</sup>-63<sup>r</sup>). Earlier than this, likely during his days as a student at Paris, Heingarter had also extensively annotated another witness to the *Theorica*, which is preserved in BnF, lat. 7197 (ff. 51<sup>r</sup>-57<sup>v</sup>).

In his glosses and commentaries, we can see Heingarter's interest in certain topics taking root, expanding, and developing over time. In the case of the latitudes, Heingarter's first treatment, found in BnF, lat. 7197 (ff.  $56^{r}-57^{v}$ ), is rather sparse, containing three *nota* in Heingarter's hand. In BnF, lat. 7333 (ff.  $61^{v}-63^{r}$ ), however, folios  $62^{r}-63^{r}$  are filled with definitions and clarifications of the original text treating the latitudes. Furthermore, the introduction to this commentary, found on folio  $54^{v}$ , is reminiscent in many important ways of the more specialized marginal commentary found in BnF, lat. 7432. They both divide their subject matter neatly into a *theorica*, treating attributes of astronomy defined as theoretical, followed by a *practica*, treating those attributes of astronomy defined as practical.

Furthermore, the introduction to the BnF, lat. 7333 commentary already betrays Heingarter's concerns to refine planetary calculations in order to identify the precise locations of planetary positions. He emphasizes the importance of understanding all the components of a planet's position that together constitute its true motion. This includes identifying its position in both the eighth and ninth spheres, but also in attending to all of its accidental qualities or the planetary passions. And finally, Heingarter explains that calculating the planetary latitude in addition to the planetary longitude is necessary to find this true motion.<sup>49</sup>

In the same way, the accompanying canons, tables, and instrument texts relating to planetary latitudes that appear in BnF, lat. 7432 recur again in multiple volumes of Heingarter's library. In BnF, lat. 7333 a table of contents in the hand of Heingarter points out the treatment of the stations and retrogradations of the planets together with their latitude, as part of the Liber super totam astrologiam by the late-thirteenth-century Franciscan Bernard of Verdun. As Claudia Kren has noted in her seminal article on the development of planetary latitude theory and practice in the late-medieval West, Bernard of Verdun's was one of the very few pre-Alfonsine works that attempted to grapple with the confusions of latitude theory as it was inherited from the *Theorica planetarum communis* and the Toledan tradition.<sup>50</sup> On folio 43<sup>r</sup>, where the chapter *De stationibus et retrogradationibus atque planetarum latitudinibus* begins, a marginal note in Heingarter's hand is provided, which reads hic incipit tractatus nonus et habet distinctiones duas, quarum prima est de planetarum retrogradationibus et continet capitula tria (et distinctio secunda est de latitudinibus et earum annexis et continet capitula novem). Throughout the entire Liber super totam astrologiam, this note in the hand of Heingarter is by far the lengthiest among a set of marginal annotations that are otherwise rather short and sporadic.

In addition to the *Liber super totam astrologiam*, in BnF, lat. 7333 Heingarter also preserved a work by Bernard of Verdun dealing with an instrument called the *torquetum* (*truquetum* in the manuscript). This is followed by another text concerning the same instrument by Franco de Polonia (ff.  $49^{r}-52^{v}$ ), which Heingarter had earlier included in BnF, lat. 7197 (ff.  $15^{r}-16^{r}$ ). The *torquetum* may have been of some interest to Heingarter due to his personal proclivities for latitude theory, as the instrument can be used for coordinate measurement and

conversion, and the determination of a heavenly body's position using either ecliptic or equatorial coordinates.<sup>51</sup>

The commonalities of texts and topics across manuscripts sometimes are also indicated by the scribal marks of Heingarter's editing, which may be evidence of the direct transfer of certain works from one manuscript to another. On folio 176<sup>r</sup>–176<sup>v</sup> of BnF, lat. 7295A, for instance, we find the chapters of the *Priores astrologi* treating planetary latitude.<sup>52</sup> It is possible here to detect traces of Heingarter's careful reading of the latitude canons as he applied a scribal technique of adding red slashes to the chapters. On the same folio there are also marginal notes written in his hand, corresponding to these same chapters.

These notes and scribal marks were either added to aid Heingarter in his reading of the chapters, or, more likely, to edit parts that would be used in his final treatise. For these same chapters on planetary latitude would be paraphrased in the *practica* of his treatise in BnF, lat. 7432, as well as being appended to his version of John of Saxony's canon set (incipit: *Tempus* est mensura motus) in the same presentation manuscript. Indeed, from folios 224r-236v in BnF, lat. 7432, Heingarter decided to add supplemental canons to his set of the Tempus est mensura motus canons. To this end, we find three canons from the set of John of Lignères (incipit: Priores astrologi) following John of Saxony's canons, together with four canons excerpted from the Cb canons of the Toledan Tables, and a canon for equating the houses of unknown provenance. The canons excerpted from the Toledan canons had already been preserved by Heingarter in a comparative gloss of Alfonsine and Toledan astronomy found in BnF, lat. 7295A bearing the incipit Arabes maxime, and those annotated canons of the Priores astrologi found in BnF, lat. 7295A may similarly be the source of their equivalent texts accompanying Tempus est mensura motus in BnF, lat. 7432.53 Thus, earlier texts studied and annotated in his toolbox manuscripts were apparently repurposed and rewritten in his presentation copy to the duke.

That the notes contained in BnF, lat. 7295A would serve as the groundwork of significant parts of Heingarter's later *practica* is also corroborated by clear connections that

one can find between his descriptions of the latitude tables associated with the treatise in BnF, lat. 7432 and the presence of these same tables and their descriptions in BnF, lat. 7295A. In BnF, lat. 7295A, f. 127<sup>v</sup> and f. 164<sup>v</sup>, one finds latitude tables, one of which appears to have been directly incorporated into BnF, lat. 7432. These two tables in BnF, lat. 7295A, which we shall label A and B, contain numerical values deriving from the Ptolemaic tradition, which had been adapted by John of Lignères from the Toledan Tables and the  $z\bar{i}j$  of al-Battānī.

Despite many similarities between the two tables contained in BnF, lat. 7295A, it seems that Heingarter privileged Table A. Copied in his own hand, it was addended to the eleventh quire of the manuscript alongside the equation tables of the Parisian Alfonsine Tables, and a close reading of its title and column headings show that it was adapted and integrated into BnF, lat. 7432 to be used in conjunction with the *practica* of his treatise. Table A is found on folio 255<sup>v</sup> of BnF, lat. 7432 bearing the title *Tabula latitudinum quinque planetarum que est distancia eorum a via solis*, which differs from the title of Table B.<sup>54</sup> Furthermore, there are subtle alterations to the vocabulary of the columns containing latitude values for the inferior planets. For instance, instead of using the more common term *reflexio* for the second angle of inclination on the epicycle, which is referred to as 'slant' in modern commentaries, Heingarter opted for the slightly modified term *reflexus*. This word is repeated in the table contained on folio 255<sup>v</sup> of BnF, lat. 7432.

Table A also corrects for what is most probably a copying error found in the upper part of the column for the northern latitude of Saturn in table B. Indeed, in the 24° entry, the corresponding value in table B is 2;8 instead of 2;7. 2;8 normally corresponds to the value for the next entry 30°. From 24° to 84°, the values are therefore shifted by one line. To fill the gap created by a misalignment of the values, Heingarter repeats the value of 2;30 at 84° and 90°. One final distinguishing feature of Table A is the presence of a third column for the proportional minutes (*minuta proportionalia*), which is not found in Table B, and was not common to this kind of latitude table.<sup>55</sup>

These differences between Tables A and B amount to only very slight alterations on the part of Heingarter. Nevertheless, he deemed them significant enough to make note of them in his treatise. In the *practica*, he associated the third method for finding latitudes discussed therein with a latitude table he claimed to have altered from the original set of John of Lignères, writing:

And there is another, a third, way in which you will truly find the latitude of the five planets according to the following method using a table composed by John de Lignères, which we have made easier and clearer.<sup>56</sup>

He then goes on to paraphrase the latitude canons from the *Priores astrologi* to be used with his table in BnF, lat. 7432 adapted for this purpose. Whatever reasons inspired Heingarter to copy out his own latitude table — whether it was to correct the copyist's errors in Table B or whether it was to add his own values of proportional minutes — the links between Table A in BnF, lat. 7295A and the canons of BnF, lat. 7432 are drawn fairly explicitly in Heingarter's treatise.

In addition to these tables taken from the  $z\bar{i}j$  of al-Battānī, Heingarter would later include the tables from the  $z\bar{i}j$  of al-Khwārizmī in his presentation copy to the duke as well.

They appear in the manuscript following the treatise in BnF, lat. 7432 on f. 222<sup>r</sup> and 255<sup>v</sup>–258<sup>r</sup>. His inclusion of these tables similarly reveals connections between BnF, lat. 7295A and BnF, lat. 7432. Following Heingarter's treatise in the latter manuscript are found the two tables of the Indian tradition. The first of these tables, the *Tabula quadripartialis ad sciendum latitudines quinque planetarum*, starts at folio 256<sup>v</sup> and ends with folio 257<sup>r</sup>.<sup>57</sup> These are followed by the *Tabula bipartialis* from folios 257<sup>v</sup>–258<sup>r</sup>.<sup>58</sup> Much of the *practica* is devoted to the explication of these tables, and the methods of calculation that one applies to use them.

Manuscript 7295A, though it does not contain the tables themselves, ends with the *Arabes maxime* (already mentioned above), which is a comparative exposition of canons to the Alfonsine Tables and the Cb canons of the Toledan Tables. This work includes five chapters on planetary latitude from folios 189<sup>rb</sup>-190<sup>rb</sup> drawn from the Toledan canons.<sup>59</sup> The instructions found in the *Arabes maxime* explain how to calculate a latitude using the *bipartialis* and *quadripartialis* tables. Furthermore, as we discuss more fully in the next section, just as Heingarter relied upon the *De scientia astrorum* by Alfraganus (al-Farghānī) to explicate the canons and tables in his treatise, so too does the *Arabes maxime* invoke this text frequently in order to gloss the Toledan canons. Heingarter's decision to make use of an unusual vocabulary found in Alfraganus to describe different aspects of the planetary latitude model, which we will discuss below, becomes less surprising if one has already read the chapters on latitude in the *Arabes maxime* that developed the same terminology. Thus, even though the *bipartialis* and *quadripartialis* tables are not found in BnF, lat. 7295A, the *practica* and tables of BnF, lat. 7432 can still be considered a continuation of the same project as that one being developed by the *Arabes maxime*.

One final set of latitude tables described in the treatise, the so-called Oxford Tables, which had been computed by Englishman William Batecombe in 1348, offers the starkest example of the manner in which BnF, lat. 7432 relies upon BnF, lat. 7295A for coherency.<sup>60</sup> In the *practica* of his treatise, Heingarter described their format and how to use them, writing:

The first [kind of latitude table] is that in which [the table] is entered with the mean centre in the descending line, and with the mean argument in the transversal line; and what is taken is that which is in the convergence of the [two] lines; and that will be the latitude of the planet; and this method is easy.<sup>61</sup>

No such tables exist in BnF, lat. 7432, however, and Heingarter's only copy of them appears in the thirteenth quire of BnF, lat. 7295A.<sup>62</sup>

These connections between BnF, lat. 7432, BnF, lat. 7295A, and BnF, lat. 7333 reveal a fascinating practice on the part of Heingarter to not only order related works within a single manuscript, but also to arrange them across multiple manuscripts within a single library.<sup>63</sup> Some of the texts in question may have been composed when Heingarter was still a student; others were written at a time when Heingarter had begun his career as a medical professional following his licentiate. However, the mutually interrelated topics found across all of these texts suggest a tendency to cross-reference, augment, and edit topics of interest in such a way that no single codex was self-sufficient. The coherent application of computational techniques found in 7432, then, could only be achieved with recourse to multiple volumes of the library.

# 3. The Planetary Latitude Treatise and the Arts Curriculum at Paris

The latitude treatise, together with the compiled texts, tables, and annotations stored in the volumes detailed above, might rightly be understood as a research agenda, and the questions they raised probably animated Heingarter's mind over many years of his life. They also suggest that Heingarter's interest in these topics belonged to a more communal practice in which multiple actors were involved. In this way, the content and concern of the treatise was of more than just a personal nature. The treatise was likely intended to serve as a touchstone for the study of latitude theory and calculation.

The general pitch of the dedicatory introduction would suggest this, as it is presented in the form of a letter to Michael Roscher, Master of Arts at the University of Paris. Roscher was procurator of the nations of England and Germany when Heingarter was still at the university, and the two seem to have developed a rapport. In 1466, Roscher had worked together with Heingarter, who, on behalf of Jean Rosée, dean of the medical faculty, had petitioned to secure funding for students pursuing the doctoral degree in medicine.<sup>64</sup> The opening lines of the letter reproduce, almost verbatim, the beginning of the prologue to Boethius' *De institutione arithmetica*, a reference that would hardly escape the attention of a university master. Indeed, the division of the mathematical sciences into arithmetic, music, geometry, and astronomy displayed in *De institutione arithmetica* was widely assumed to be the basis of the medieval curriculum. Equally worthy of note is the fact that the parallel construction of Boethius and Heingarter's introductions are mirrored by the circumstances under which they both appear to have been composed. For Boethius also intended his scholarly

efforts to serve the purpose of a gift to a patron and friend. In his case, the treatise was addressed to the Roman senator, Symmachus, who was also his father-in-law.<sup>65</sup>

The relevant connection between the arts faculty and Heingarter's production of the treatise is further confirmed by his explicit statement that students were the intended recipients of the work. He explained:

I have brought to you (Michael Roscher, Master of Arts) the not so lazy load of works, for which nothing is more ready for action than when <a thirst> for acquisition has been kindled; but I have sent these, which, taken from the wealth of the wise, we have gathered for the utility of students. And because in the previous books we have thoroughly gone through the motion of the stars and planets according to longitude with however much of theory and practice as suffices, I set out to compose this treatise on the motion of the planets according to latitude, which I shall divide into two chapters: the first of these explains the theory; the second explains the practice and the method of finding [the planets'] latitude with their genzahar<sup>66</sup> for the era of the Illustrious John, duke of Bourbon and Auvergne.<sup>67</sup>

The dedication of the text, not only to Roscher, but also to students of astronomy, reveals a third dimension to Heingarter's interest in latitude, quite different from the defence of his profession and the contributions to a humanistic library at Belleperche. He was also offering an authoritative text to be used in the context of formal instruction.<sup>68</sup>

Heingarter continued to foster a relationship with the university even after he had departed for Belleperche. In 1471, there was something of a power struggle between the king of France and duke of Bourbon on the one hand and the corporate authorities of the University of Paris on the other. The university had appointed a certain Anthony de Busco as acting scribe of the conservator (*scriba conservationis*), who, for reasons that remain unclear, was deemed unacceptable by the king. In response to the king's displeasure, the duke sent letters to the faculty requesting that Anthony de Busco be removed from office. In his place, John II suggested Heingarter should fill the post for the rest of the former scribe's tenure.<sup>69</sup>

Heingarter ultimately did not replace Anthony de Busco as *scriba conservationis*, but the fact that his name was raised as a possible replacement shows that both he and his patron continued to take a great interest in the affairs of the university.<sup>70</sup> This included not only a desire to guide the school's administrative affairs, but also an apparent interest in determining the curriculum for lectures in astronomy. Heingarter's curriculum was memorialized in the words of Guillaume Cop, who, in his above-mentioned 1493 letter, states that it is hard to tell whether it is Heingarter who is indebted to the quadrivial curriculum, or if it is not rather the contrary that is the case. Moreover, in Cop's words, Heingarter is the one who restored these

mathematical sciences to light — particularly astronomy — to which Heingarter contributed greatly with the works he wrote.  $^{71}$ 

Cop would go on in the letter to lay out the curriculum of astronomical texts, tables, and instruments that Heingarter introduced to him for mastery of the discipline.<sup>72</sup> Cop presents the *Theorica planetarum communis* as the introductory work of Heingarter's teaching regimen.<sup>73</sup> Neither as thorough nor as coherent as its earlier chapters treating planetary longitudes, the quality of the seventh chapter on latitude had already been challenged by Henry of Langenstein, whose *De reprobatione ecentricorum et epiciclorum* (1364) would gain currency at the University of Vienna after he moved there in the late fourteenth century.<sup>74</sup> By the time of Heingarter's writing, the *Theorica planetarum* was generally agreed to be inadequate. A still more devastating attack than Langenstein's would be published at about the same time as Heingarter's latitude treatise when Johannes Regiomontanus held it up to bitter scrutiny in the *Disputationes contra deliramenta cremonensia* (1475).<sup>75</sup> Because the *Theorica planetarum communis* continued to play such an integral role in university instruction of astronomy even after such broadsides had been levelled, it makes sense that masters of arts at Paris would call upon someone to clarify the text and correct it where necessary.

In Heingarter's efforts to do so, we see that he offered two rather different strategies in his *theorica* and his *practica*, respectively. In the *theorica*, he sought to establish what one might call an authoritative and univocal account of planetary motion in latitude. He does not present two models, one to be associated with the  $z\bar{i}j$  of al-Khwārizmī and the other with the  $z\bar{i}j$  of al-Battānī. Instead, the planetary motions described in Heingarter's *theorica* are unambiguously associated with the models established by Ptolemy in the thirteenth book of the *Almagest* and transmitted by the  $z\bar{i}j$  of al-Battānī.<sup>76</sup>

In the *theorica* of the treatise, Heingarter differentiates, just as Ptolemy had done, between two categories of latitudinal motion, one that pertains to the superior planets and the other to the inferior. In the case of the superior planets, both the deferent and the epicycle of the simple longitudinal model are brought out of the plane of the ecliptic to account for the planet's latitude. He explains that in the case of the inclination of the planet's deferent, the angle is fixed. The circles of the deferent and the ecliptic intersect at two points called nodes or *genzahar*, and a straight line between these two points forms the nodal line, dividing the circle of the deferent into two unequal parts, where the larger part is the north and the smaller

south.<sup>77</sup> The second inclination is that between the epicycle and the deferent. As opposed to the inclination of the deferent, the epicycle's inclination varies over time with its axis of rotation always parallel to the nodal line.<sup>78</sup> When the epicycle is at the nodes, it is in the plane of the ecliptic, but the inclination reaches its maximum when the epicycle centre reaches its highest point on the deferent.<sup>79</sup>

As for the inferior planets, Heingarter explains that their motion in latitude has three components. Like the superior planets, their deferents incline from the ecliptic plane, but this time the angle of the tilt varies over time. When the centre of the epicycle is at the nodes, the deferent is in the ecliptic plane, but when it is at the top of the deferent, the inclination reaches its maximum.<sup>80</sup> Heingarter goes on to say that, like the superior planets, the inferior planets also have an inclination of the epicycle rotating about the diameter of the epicycle that runs parallel to the nodal line, except that, in the case of the inferior planets, this inclination varies such that the epicycle is in plane when the epicycle centre is at the top of the deferent and the inclination must be added, with an axis of rotation about the diameter of the epicycle that is perpendicular to that of the first epicyclic inclination. This inclination varies such that the epicycle is in plane when the epicycle centre is at its maximum when the epicycle centre is at the nodes.<sup>81</sup> It is at its maximum when the epicycle centre is at the nodes.<sup>82</sup> It is at its maximum when the epicycle centre is the top of the deferent.<sup>83</sup>

Despite Heingarter's self-described attempt to thoroughly treat planetary latitude theory just as previous authors had done for planetary longitudes, his efforts to offer this unequivocal exposition were hindered by a general lack of standardization in the terminology, procedural methodology, and mathematical models he inherited from previous source material. The heterogeneity of latitude terminology stands in stark contrast with the terminology developed for planetary longitudes. As Olaf Pedersen observed in his seminal article, 'The Origins of the *Theorica planetarum*', the *Theorica planetarum communis* had effectively championed the models of Ptolemaic astronomy against other alternatives by consistently establishing a vocabulary that could be applied to the canonical procedures and the numerical values of the tables available to the practitioner. Pedersen wrote that the author of the *Theorica planetarum communis* 

successfully trie[d] to overcome the terminological ambiguity in Ptolemy by introducing separate Latin terms for separate concepts, for instance by creating a variety of terms for all the variables that are called 'anomaly' in the *Almagest*. This is not to say that he knew Greek, or even a Latin translation of the *Almagest*, but only that he was aware of the need for a consistent and unequivocal vocabulary in planetary theory. [...] Historically speaking there is no doubt that these five chapters were instrumental in acquainting students with the principal features of the various kinematical models of the *Almagest*, and thus in strengthening the position of Ptolemaic astronomy against attacks from teachers who, following al-Bitruji, tried to introduce other models.<sup>84</sup>

Heingarter did not enjoy the benefit of having inherited a similarly unified vocabulary for his *theorica* on latitudes. As if to confirm the dearth of contemporary fifteenth-century texts

containing a consistent and conventional idiom, in the first chapter of the treatise Heingarter leans heavily upon the older (and largely outmoded) terminology found in the eighteenth chapter of John of Seville's translation of Alfraganus' Science of the Stars.<sup>85</sup> Written in the twelfth century, the text contains a vocabulary that is not consistent with that of the more conventional lexicon of astronomical terms that had taken root in the university in subsequent centuries. Even astronomical objects that are ubiquitous to the Ptolemaic models, like that of the eccentric circle (circulus egresse cuspis in Alfraganus, but more typically rendered as circulus ecentrici) or the epicycle (circulus brevis in Alfraganus, but more typically rendered as epiciclus), diverge from the standard vocabulary. This is to say nothing of the more specialized terminology of latitude theory like the inclination of the deferent, which is often translated as 'deviation' in modern commentaries, but that Heingarter calls the declinatio ecentrici ab ecliptica in the theorica. Heingarter's descriptive phrase expresses the spatial relations between the deferent and the ecliptic nicely, but it differs from the more common term deviatio, which could be found in the canons and is employed by Heingarter in his practica. Similarly, the second angle of inclination on the epicycles of the inferior planets, often translated as 'slant' in modern commentaries, is given the much more unusual name involutio in the *theorica*. This differs from most other Latin sources on the subject, including the Toledan and Alfonsine canons, which refer to this same angle as the *reflexio* — a term that Heingarter again reverts to in the *practica*.<sup>86</sup>

Heingarter's introduction of novel terminology in the *theorica* may have undermined his unifying efforts in some cases, but there are other instances in which he can be seen updating outdated modes of expression by either silently changing the terms in his compilation or by including the vocabulary that one would find in canon texts taught in the university alongside the older term. For example, when referring to the epicycle centre, he often calls it the *cuspis seu centrum epicicli*. He also attempted to reinterpret passages from the *Theorica planetarum communis* that did not conform with the Ptolemaic model of planetary latitude detailed by Alfraganus in the *Science of the Stars*. For example, Heingarter quotes a passage from the *Theorica planetarum communis*' seventh chapter verbatim when explaining how the epicycle of a superior planet inclines from its deferent plane, writing:

The epicycle, moreover, is inclined from the eccentric such that the planet will always be between the ecliptic and the centre of the epicycle, except when the centre of the epicycle is at the head or tail; then, the epicycle is right on the eccentric.<sup>87</sup>

This passage is not coherent with the planetary models described by Ptolemy, however, since it is not the planet that will always be between the ecliptic and the epicycle centre due to the epicycle's inclination, but rather the epicycle's apogee. Heingarter glosses this passage in a way that agrees with the description found in Alfraganus, however, by explaining that

... the inclination of the lower half of the epicycle from the plane of the deferent is always in that direction toward which that half of the deferent — in which is the centre of the epicycle — declines from the plane of the ecliptic. And, therefore, when the centre of the epicycle is outside

of the nodes, the planet on the upper part of the epicycle is between two planes, namely that of the ecliptic and its deferent.<sup>88</sup>

That is to say, the epicycle's perigee is always further from the plane of the ecliptic than is the centre of the epicycle. Thus, when the planet is on the part of the epicycle closer to the apogee, it will fall between the planes of the ecliptic and the deferent. This statement is in agreement with the Ptolemaic model, though it contradicts the passage taken from the *Theorica planetarum communis*, to which it serves as a gloss.<sup>89</sup>

This latter example of Heingarter's efforts to bring some order and consistency to the many sources that he integrated into his treatise serves to show that, more serious than the terminological variability of the latitude theory, was the multiplicity of descriptions of the models lying behind these terms and the procedures involved in their calculation.

Such ambiguities became more apparent in Heingarter's *practica*, where multiple canons are provided for using different tables to find latitude values. As opposed to his approach in the *theorica*, Heingarter decided to leave the multiple methods alongside one another in the *practica* with no attempt to reconcile them to one another. Instead, he provides one set of instructions for using tables ultimately derived from al-Battānī's  $z\bar{i}j$ , which require the user to find two angles of inclination for the superior planets and three angles of inclination for the inferior planets. These values are then combined to obtain the final latitudinal position of the planet. This is the method that one would find in the canons written by John of Lignères and paraphrased in Heingarter's *practica*.<sup>90</sup>

When drawing upon the Toledan canons, Heingarter provided a different set of instructions, which preserved the procedures designed for the Indian model as found in the  $z\bar{i}j$  of al-Khwārizmī. These procedures required simultaneous use of the *bipartialis* and *quadripartialis* tables, the format of which is described in the previous section. For these tables, he provided two canons: one for the superior planets, the other for the inferior.<sup>91</sup>

That the canon instructions, the tables, and, by implication, the models discussed in the treatise's second chapter are demonstrably divergent from each other was apparently not Heingarter's chief concern in the *practica*. Instead, he appears to have cared most of all about offering workable and clear instructions for students, instructing them in how to use each table set regardless of whether the table set in question was linked to the model described in the first chapter. He was aware that these tabular methods were different and likely knew they yielded different numerical results. Nevertheless, by giving these different methods as a *practica*, Heingarter did not necessarily wish to resolve all the ambiguities implied in the tables.

# Conclusion

It remains to be seen if Heingarter ever applied the procedural instructions of his latitude treatise in any systematic way to his horoscope charts later in life. Indeed, since the extant artefacts of Heingarter's career date from the 1460s to the early 1480s and very possibly predate the writing of the treatise, we may not be able to say with any degree of certainty if he changed

his practices in discernible ways later in his career.<sup>92</sup> Given what we know of the other arenas of Heingarter's life — gathering a manuscript collection at the court and developing a curriculum for students at the University of Paris — it is also possible that the latitude treatise could have served other purposes as well. In some instances, Heingarter's insistence on precisely calculating planetary latitudes for medical astrology may have been directed more at those who would attack a medical astrologer's practice than those who would actually do the calculations in emulation of it. Thus, there was probably at least an element of his research agenda that was much more rhetorical than practical and that intended to answer the questions of sceptics or tyros as much as to expand the repertoire of the seasoned calculator.

What is undeniable, however, is that Heingarter was a part of a new generation of practitioner in the late fifteenth century that had become profoundly interested in problems of planetary latitude, and he sought to gather as much material on the topic as possible. Furthermore, the importance of accounting for latitude in astrological procedures, as Heingarter explored in the annotations of BnF, lat. 7432, would garner more and more advocates as the discipline of medical astrology came under increasing critical scrutiny in the decades following Heingarter's composition of the treatise. This was particularly the case for the technique of finding planetary directions. Giovanni Bianchini and Johannes Regiomontanus both computed canons and tables for planetary directions with provisions that would allow a user to include planetary latitude values.<sup>93</sup> Later still, late-sixteenth- and early-seventeenth-century horoscopes, such as those drawn up by Girolamo Cardano and Galileo Galilei, would contain planetary latitudes for use in directing the significator of a nativity.<sup>94</sup> Similarly, Giovanni Antonio Magini would compute direction tables for planets with different latitudes in his posthumous *De directionibus*.<sup>95</sup> Such calculations had become a convention by the time Jean-Baptiste Morin treated the subject in his encyclopaedic *Astrologia Gallica*.<sup>96</sup>

For the quotidian calculations of the practicing medical astrologer, these procedures would have been simplified by the printed ephemerides that would increasingly include planetary latitude positions as well as longitude. Evidence to this effect would include some of the most widely circulating ephemerides of eminent authors such as Regiomontanus, Cardano, Johann Stöffler, Jacob Pflaum, Philipp Imsser, Luca Gauricus, Giovanni Battista Carello, Johann Stadius, and Cyprian Leowitz.<sup>97</sup> In short, Heingarter's concerns about latitudes can be

understood in terms of many broader trends in the practice of astronomy that were developing at the end of the fifteenth century.

# Appendix

# 1. Editorial Principles

### 1.1 The Text

The following critical edition represents the first edition of the treatise on planetary latitude by Conrad Heinarter found in Paris, BnF, lat. 7432 on ff. 219<sup>r</sup>–222<sup>v</sup>. We attempted to reproduce this text as faithfully as possible, retaining its orthography almost in all instances. However, we have standardised the alterations of the consonant spelling of 'ci/ti' (e.g. opulencia>opulentia declinacio>declinatio, inclinacio>inclination...), as it does not seem possible to assess the prevalence of one spelling habit over the other throughout the text. Moreover, we opted for the capitalisation of proper names (e.g. iohannes>Iohannes, avernia>Avernia, alfraganus>Alfraganus) and planets (mercurius>Mercurius, mars>Mars, venus>Venus), although they are found in lower case in the manuscript witness.<sup>98</sup>

To mark syntactic units, we have applied a modern system of punctuation. In the process of editing the text, we have made a concerted effort to remain true to the apparent division of the text. Nonetheless, it is important to acknowledge that capital letters are frequently utilised to indicate information considered significant by the author and may not always signal the beginning of new sentences or paragraphs.

To improve the readability of the text, we have taken the liberty of creating new paragraphs where necessary, even if not explicitly indicated in the manuscript. This decision was made after careful consideration and a deep understanding of the intended meaning and sense of the text. Our primary objective is to present an accurate and comprehensible edition of the text, and we believe that our approach will enable readers to gain a more profound appreciation of the author's intent and meaning.

Within the text at hand, numerical expressions are restricted only to the sexagesimal values. Conversely, adverbs such as "primo, secundo, tertio," and so forth, are spelled out in full despite the fact that their abbreviated form employs a numeral. Moreover, ordinal numbers are also spelled out in their alphabetic form (e.g.  $3^{a}$  latitudo > tertia latitudo).

The edited text is accompanied by an *apparatus criticus* and an *apparatus fontium*: (1) the first apparatus records few conjectures and scribal errors; (2) the second apparatus includes

the sources of the text. Only on the first page of the edition a footnote is added to clarify the integration of a word in angular brackets.

In this edition, the page change is noted in the right margin and within the text by a vertical bar. Finally, the edition was conducted on the basis of a single manuscript, and therefore, to avoid unnecessary repetition, we have not included its *siglum* in the apparatus.

### 1.2 The Translation

The translation we provide hereafter is intended to help the reader through the understanding of the treatise and offer a handy context of reference for the contribution preceding this Appendix. We attempted to translate the text as literally as possible, inserting words in square brackets only when we considered it suitable for its readability.

The very nature of Latin syntax allows for long compound sentences whereas English syntax does not. Hence, in a few instances we have altered the syntax of the text, by breaking a long sentence into two or more separate shorter sentences. In order to preserve the connection between the text and its translation, the reference to the page change is noted in the right margin and within the text by a vertical bar.

# Glossary of Terms

Conrad Heingarter's theoretical chapter on planetary latitudes relied heavily upon John of Seville's Latin translation of Alfraganus' *Science of the Stars*, while his practical chapter drew mainly from the canons to John of Lignères' tables (bearing the incipit *Priores astrologi*) and the version of the canons to the Toledan Tables, which Fritz Pedersen has designated by the letters Cb. The technical vocabulary used by Alfraganus to describe the models for planetary latitudes differs significantly from that of the canons to the Alfonsine and Toledan Tables. Despite his occasional updating of John of Seville's terms for epicycle and eccentric, however, Heingarter chose not to standardize the lexicon of terms that he had at his disposal to describe the various angles of motion involved in finding planetary latitudes. For this reason, we have deemed a glossary of terms to be a useful addition to the edited text and translation provided above. Each entry consists of a single-word term. Phrases, which incorporate a word but signify a distinct concept, are included in bold within the definition of each entry. Each entry word is presented in its nominative and genitive form with its gender signified in italics alongside it.

- abscisio, abscisionis, f.: intersection; in its verbal form, the term is used to describe the point where a planet's eccentric plane cuts the ecliptic plane; when used in the phrase locus abscisionis, the term refers to a planetary node. See also, caput et cauda draconis, genzahar, intersectio, and nodus.
- arcus, arcus, m.: arc; the term arcus circuli inter stellam et equinoxialem is used to define the declination of a star or a planet from the celestial equator. See also, declinatio.
- **argumentum, argumenti**, *n*.: argument; the term is used in two senses in the text: first as the elongation of the true position of the Moon from the true position of the northern lunar node, the **argumentum latitudinis lune**; second, the term is used to refer to a planet's true elongation from the apogee of its epicycle, or the **argumentum equatum planete**.
- **aux, augis**, *f*.: aux, apogee; referred to simply as the "aux" in the translation above, this term refers to the point on the epicycle where the planet will have reached its furthest distance from the Earth, which is the **aux epicicli**; on the eccentric circle, the term is used to designate the furthest point of the centre of the epicycle from the Earth, which is the **aux ecentric**.
- **axis**, **axis**, *m*.: axis; Heingarter uses the term to indicate the movement of a body about a fixed point of rotation. To this end, he refers to the axis of the celestial equator (**axis circuli equinoxialis**), the axis of the ecliptic (**axis circuli signorum**), and the axis of the eccentric circles (**axis ecentricorum**) of specific planets; he also describes the motion of planetary epicycles and eccentrics in terms of axial rotation (e.g. **axis qui transit per ambo puncta longitudinum mediarum epicicli**).
- **caput, capitis**, *n*.: head; in reference to the "head and tail of the dragon" (**caput et cauda draconis**), namely the nodes of lunar latitude, in which the head signifies the point from which the Moon ascends northward above the ecliptic plane.
- **cauda**, **caudae**, *f*.: tail; the "tail of the dragon" (**cauda draconis**) signifies the point from which the Moon descends southward below the ecliptic plane.
- **centrum, centri**, *n*.: centre; the centre is the elongation of the mean planet from its apogee on the eccentric circle; because the Ptolemaic theory of planetary latitude requires an adjustment of the planet's centre to or away from the planet's eccentric apogee, Heingarter distinguishes between the planet's centre before adjusting for the nodes (**simplex centrum**) and after (**centrum cum suo addito**); the centre of an epicycle (**centrum seu cuspis epicicli**) refers to the mean motion of a planet.
- **circulus, circuli**, *m*.: circle; the term designates several periodic and regular motions used to calculate planetary positions; Heingarter chooses to maintain certain outmoded terms for planetary motion, such as the use of the term **circulus brevis** for an epicycle (**epiciclus**), the term *circulus egresse cuspis* in reference to an eccentric (**circulus ecentrici**); the term is also deployed frequently as a synonym for the celestial equator (**circulus equinoxialis**) and the ecliptic (**circulus signorum**).
- declinatio, declinationis, f.: declination; although generally used to describe the angle of inclination from the celestial equator to the body of a star or planet (delinatio planete ab circulo equinoxiali), in Heingarter's theoretical chapter it takes on a variety of meanings: it can be used to describe a planet's latitude (declinatio planete ab ecliptica); it also is used interchangeably with inclinatio (see below) to describe the tilt of a planets' epicycle at the points of apogee and perigee (declinatio epicicli); it can be

used to describe the angle of deviation (see below) found in the canons, which is defined by the tilt of the eccentric plane from the ecliptic (declinatio ecentrici ab ecliptica); finally it is used interchangeably with the term involutio (see below) to describe the rotation of the two mean longitudes of an epicycle (declinatio utrarumque longitudinum epicicli mediarum), otherwise known as "reflection" or "slant" in contemporary literature (see reflexio below).

- **deferens, deferentis**<sup>99</sup>: deferent; a rarer term in Heingarter used as a synonym for the eccentric circle on which the centre of the epicycle rides.
- **deviatio, deviationis**, *f*.: deviation; used only in the canons, this term is used to describe the angle of inclination formed between the plane of a planet's eccentric circle and the plane of the ecliptic; in the theoretical chapter, the deviation is referred to as the "declination of the eccentric from the ecliptic" (**declinatio ecentrici ab ecliptica**). See **declinatio** above.
- **directus, directi**: direct; this term is used to describe the manner in which the epicycle circle aligns with the ecliptic plane at the planetary nodes; it is also a term used to describe values found in planetary tables at a place opposite (**in directo**) to the values of the argument of the table.
- **dyameter, dyametri**, as *sub. m.* or *n.*: diameter; Heingarter uses the term to highlight two epicycle diameters of particular significance in the latitude models: the first of these is the diameter that passes through the apogee and perigee of the epicycle reaching the Earth's centre, and this is called the **dyameter que est ab auge vera epicicli usque in oppositum augis**; the other is the diameter that goes through the two mean longitudes of the epicycle, and is called the **dyameter que vadit super utrasque longitudines medias**.
- ecliptica, eclipticae, *f*.: ecliptic; the Sun's apparent annual motion through the fixed stars of the zodiac; in Heingarter's treatise, the ecliptic is more frequently referred to as the "circle of the signs" (circulus signorum). See circulus above.
- genzahar (*or* geuzahar; undeclinable): genzahar; from the Arabic *jawzahar* and the Persian *gawzahar*, the genzahar refer to the planetary nodes. See also, abscissio, caput et cauda draconis, intersectio, and nodus.
- inclinatio, inclinationis, *f*.: inclination; the angle that cuts through the plane of eccentric circle when a planets' epicycle tilts (inclinatio epicicli) northward or southward at the points of apogee and perigee (aka declinatio epicicli). See declinatio above.
- intersectio, intersectionis, f.: intersection; another word used by Heingarter to refer to the planetary nodes. See also, abscissio, caput et cauda draconis, genzahar, and nodus.
- involutio, involutionis, f.: involution; the term in Heingarter's theoretical chapter used to describe the rotation of the two mean longitudes of an epicycle (declinatio utrarumque longitudinum epicicli mediarum), otherwise known as "reflection" or "slant" in contemporary literature. See reflexio below.
- **latitudo, latitudinis**, *f*.: latitude; generally the width or breadth of a thing, but specifically used to describe the angle of inclination from the ecliptic to the body of a star or planet; see also Heingarter's use of the phrase **declinatio planete ab ecliptica** under **declinatio** above.

**longitudo, longitudinis,** *f*.: longitude; generally the length or elongation between two bodies with astronomical significance, but specifically the position of a planet in the plane of the ecliptic as measured from the head of Aries; the terms "further longitude" (longitudo longior) or "nearer longitude" (longitudo propior) make reference to the points on an eccentric where the epicycle centre is at its furthest or nearest position with respect to the Earth (in the translation we simply render these terms as "apogee" and "perigee"); the positions on a planet's epicycle where the body of the planet is at its furthest or nearest point is also called the longitudo longior and the longitudo propior respectively; Heingarter refers to the positions at right angles to these the longitudines mediae.

locus, loci, *m*.: place, position.

- motus, moti, m.: motion, position.; motus declinationis vel inclinationis epicicli
- **nodus, nodi**, *m*.: node; another word used by Heingarter to refer to the planetary nodes. See also, **abscissio, caput et cauda draconis, genzahar**, and **intersectio**.
- **oppositus**, **oppositus**, *m*.: opposite, opposed; used as an adjective to describe the position on the eccentric or epicycle circle that is directly opposite the apogee (**oppositum augis**), which is, namely the perigee.
- **pars, partis,** *f*.: part, side, direction; a term used frequently to establish the orientation of a planet in latitude, whether to the north or to the south of the ecliptic plane; the term can also be used to describe the ascending or descending position of an epicycle or eccentric circle; the word is also used to describe the fourth term in a proportional relation the **pars proporcionalis** that is guided by the rule of three as a kind of linear interpolation.
- **reflexio, reflexionis**, *f*.: reflection; the term in the canons that describes the rotation of the two mean longitudes of the epicycle of one of the inferior planets (**declinatio utrarum-que longitudinum epicicli mediarum**), otherwise known as the **involutio** in Heingarter's theoretical chapter. See **involutio** above.
- **signum, signi**, *n*.: sign; Heingarter uses the term explicitly to refer, not to the 12 zodiacal signs of  $30^{\circ}$  each, but rather the 6 "physical" signs (**signa phisica**) of  $60^{\circ}$  each.

In giving and receiving gifts, such kindnesses are rightly esteemed 219<sup>r</sup> (especially among those who love, honor and respect one another) if it will be clearly agreed that, on account of this, there is neither anything to be found which one should offer more freely, nor is there ever anything to be received which one should take from another more delightfully, than benevolence. Considering this, I have brought to you (Michael Roscher, master of arts) the not so lazy load of works, for which nothing is more ready for action than when <a thirst> for acquisition has been kindled; but I have sent these, which, taken from the wealth of the wise, we have gathered for the utility of students. And because in the previous books we have thoroughly gone through the motion of the stars and planets according to longitude with however much of theory and practice as suffices, I set out to compose this treatise on the motion of the planets according to latitude, which I shall divide into two chapters: The first of these explains the theory; the second explains the practice and the method of finding [the planets'] latitude with their genzahar<sup>1</sup> for the era of the Illustrious John<sup>2</sup>, duke of Bourbon and Auvergne.

#### <The First Chapter>

Now the latitude of a planet is their declination from the ecliptic of the circle of the signs<sup>3</sup> in both directions, namely of the north and of the south. And if we consider a circle passing through the axis of the circle of the signs and through the stars and their degrees from the circle of the signs, the arc of that circle between the star and its degree will be the same as the

distance of its latitude from the circle.<sup>4</sup> By its course from west to east, the Sun will describe for us the circle of the signs because the plane of that eccentric<sup>5</sup> circle in which it moves is inseparable from the plane of the circle of the signs, not declining from it. I shall describe the remaining planets besides the Sun from what was said by ALFRAGANUS.

Indeed the motion of all the fixed stars toward the east is [centered] on both poles of the axis of the circle of the signs. And, therefore, whichever from among these is on the plane of the circle of the signs, it will not decline from it; moreover, whichever among these is outside the plane of the circle of the signs, toward the north or south, its motion will be inseparable from the quantity of the distance which is between that [star] and the circle of the signs in latitude, nor will it ever move from this [position]. It is, therefore, clear that each of the fixed stars either has no latitude from the circle of the signs, or its latitude is always of one quantity.

This will be quite the contrary for the Moon or the five wandering planets, because their motion is not always [centered] on the poles of the axis of the circle of the signs, but are on the axes of the eccentrics, which cut the plane | of the circle of the signs on the diameter of the circle of the signs, and decline from it toward the north or south. And therefore, their latitude appears different from the circle of the signs.

Indeed, the plane of the eccentric circle of the Moon cuts the plane of the circle of the signs on both points, that is, of the head and tail, and declines from it to the north or south. Its declination is also fixed at one quantity, and does not move from this. And the plane of its small circle is inseparable from the plane of the eccentric circle, and it does not decline

from it. And therefore, it has a single difference in latitude on account of the declination of the eccentric from the circle of the signs.

In the latitude of the five wandering planets, however, there is not just one difference, because the circles of their eccentrics decline from the circle of the signs, and the circles of the epicycles also decline from the eccentric circles. In fact, the eccentric circles cut the circle of the signs on its diameter, and they decline from it to the north and south. And the places of intersection of these five planets are these<sup>6</sup>: the place of the intersection of Saturn is in the middle between the mean longitude and both divergent longitudes.<sup>7</sup> In the remaining four planets, however, they are nearly at both mean longitudes. I mean they are nearly observed [there], because their intersections are not precisely in the middle of mean longitude as shall be made clear hereafter.

And note that that intersection by which the planet moves away from the ecliptic toward the north is always called the head of the dragon or the genzahar. And the other intersection by which the planet moves away from the ecliptic to the south is called the tail of the dragon. The Moon's intersections move from the east to the west by about three minutes every day.

The declination<sup>8</sup> of the eccentric deferents of the three superior planets is to the north of the circle of the signs for the apogees<sup>9</sup>, to the south for the

perigees, [and is] fixed and eternally immobile, just as it is for the Moon. But the two intersections of the three superior planets' eccentrics with the ecliptic do not move except by the motion of the eighth sphere.

And note that the place of Saturn's genzahar is 40 degrees away from the place opposite of the aux of the deferent following the order of the signs; others put it at 45. And its other intersection, which is called the tail, is, in like manner, 40 (some say 45) degrees away from the place of the aux of the eccentric following the order of the signs. Therefore, the place of the part of the deferent declining most to the north is 50 degrees away from the place of the aux of the place of the deferent against the order of the signs. And the place of the part of the deferent declining [most] to the south is also 50 degrees away from the place opposite of the signs.

And indeed the place of greatest declination is always that which is equally distant from either intersection. And those who posit 45 degrees agree more with ALFRAGANUS. And the place of the genzahar of Jupiter is 70 degrees away from the place of its deferent's aux against the order of the signs; therefore, the position of the side of its deferent declining most toward the north will be 20 degrees away from the place of the aux following the order of the signs. And the place of Mars' [genzahar] is 90 degrees away from the aux of its eccentric against the order of the signs. Therefore, the place of the side of its deferent that declines most to the north will be at the place of the deferent's aux. And the latitudes of these three planets written in their tables are positioned as if the center of the 220<sup>r</sup>

epicycle were always in that place of the deferent, which declines most to the north or the south.

And there is one other motion in these three superior planets according to which the upper half and lower half of the epicycle move by declining from the plane of the deferent from both the north and south's side. And this is called the motion of the epicycle's declination or inclination. This motion, moreover, is about the axis that crosses through both points of the mean longitudes of the epicycle, which points, indeed, are 90 degrees away from the true aux of the epicycle. And the diameter, which is from the true aux of the epicycle up to the point opposite of the aux, is always parallel to the plane of the ecliptic, except when the center of the epicycle is on the nodes of the intersections.<sup>10</sup> For then that [diameter] will be on the plane of the ecliptic<sup>11</sup>, and then, indeed, there will be no inclination. But this inclination is greatest when the center of the epicycle is in the intermediate places.<sup>12</sup> And the inclination of the lower half of the epicycle from the plane of the deferent is always in that direction toward which that half of the deferent – in which is the center of the epicycle – declines from the plane of the ecliptic.<sup>13</sup> And, therefore, when the center of the epicycle is outside of the nodes, the planet on the upper part of the epicycle is between two planes, namely that of the ecliptic and its deferent.

The epicycle, moreover, is inclined from the eccentric such that the planet will always be between the ecliptic and the center of the epicycle, except when the center of the epicycle is at the head or tail; then the epicycle is right on the eccentric.<sup>14</sup>

The declination of the eccentrics of Venus and Mercury, however, is not fixed, but moves on the diameter of the circle of the signs, and goes about both nodes with a small motion toward the north and the south; and it returns back to its starting place once in a year, just as the motion of longitude returns; and the apogee's<sup>15</sup> half of the eccentric will be to the north of the circle of the signs for six months, and to the south for six mon|ths. And, similarly, the perigee's half moves toward the north and south. And the plane of the eccentric is set under the plane of the circle of the signs twice in a year, and this will be when the cusp of the small circle<sup>16</sup> is in both nodes.

And when the cusp of the small circle of Venus is in one of the nodes, it will be the beginning of the declination of the half of the eccentric that is entering that node to the north; and the other half of the eccentric toward the south. But in Mercury the contrary is the case, because, when the cusp of the small circle is on one of the nodes, it will be the beginning of the declination of that half that enters that node towards the south; and the other half toward the north. 220<sup>v</sup>

Therefore, it necessarily happens that the cusp or center of the epicycle<sup>17</sup> of each one of these planets is either in the plane of the circle of the signs when it is at both nodes, or to one side of the circle of the signs, and never declines to the other side. Indeed the center of the epicycle of Venus will always be to the north of the circle of the signs, and Mercury's always to the south. And it is clear that the completion of the declination circles of Venus and Mercury's eccentrics are to the north and south of the circle of the signs.

When the cusp or center of the epicycle is at the apogee or perigee of the eccentric, moreover, the declination of the five planets' epicycles moves and changes; its return to its beginning position will be once a year, just as is the return of the motion of longitude. But the motion of the epicycle in the three superior planets is on the diameter that goes through both mean longitudes. The apogee of the epicycle is away from the eccentric circle toward the north for six months, and toward the south for six months; and the motion of the diameter that goes through both mean longitudes will be right on the plane of the circle of the signs.

And this will be the plane of the epicycle, cutting the plane of the eccentric, and it is not set under it [i.e. the eccentric]; but it is set under the plane of the circle of the signs twice in a year. That is, when the motion of the cusp or its center is at both positions of the nodes. And the beginning of this declination, which is of the apogee of the epicycle and its perigee from the eccentric, happens at both positions of the nodes. Indeed its completion is at its apogee and perigee.

The directions of the declination are also distinguished thus: the perigees of the epicycle decline from the eccentrics in the direction of the eccentric circles' declination from the circle of the signs; the apogees are the opposite. And the declination of the perigees of the epicycles will be

toward the north, when it is on the northern hally ves of the eccentrics. And  $221^{r}$  it will be toward the south, when it is on southern halves.

Venus and Mercury have two motions in the declination of the epicycle, one of which is like the motion of the three superior planets, which is from the eccentric on the part of the epicycle's apogee and perigee.<sup>18</sup> And the other [motion] is from the direction of the declination of both of the epicycle's mean longitudes. And this declination is called involution.<sup>19</sup> And the beginning of the declination of the epicycle's apogee and perigee away from the eccentric will be on the apogee and perigee in the eccentrics; and its completion is at both nodes, and then the plane of the epicycle is set under on the plane of the eccentric. The beginning of the declination of both mean longitudes of the epicycle from the eccentric is on both nodes, and its completion is at the apogee and perigee of the eccentric; and then there will be a completion of the declination of the eccentric from the circle of the signs. It is clear, therefore, that when each of these declinations of the epicycle is at its completion, there will be no effect in any way from the other declination, because the beginning of one of them happens at the completion of the other.

The directions of the declination are thus: when the center of the epicycle is on the half which begins from the apogee of the eccentric, the declination of the apogee of the epicycle of Venus will be from the eccentric to the north. And the perigee will be contrary to this for the longitude of the epicycle. And when the cusp or center is on the other half of the eccentric, it will be contrary to that which we have just described; it is, therefore, clear from what has been said about the other three planets that the greatest part of this declination happens at the nodes, and then both mean longitudes of the epicycles of these two planets are attached to

the plane of the eccentric and the circle of the signs, each set under the other.

As for the direction of the declination of involution, when the center of the epicycle is at the apogee of the eccentric, the declination of the eastern mean longitude of the epicycle from the eccentric will be northerly for Venus, and southerly for Mercury; but the western mean longitude will be contrary for the eastern part. And when the center is on the perigee's half of the eccentric, it will be contrary to what we said about the apogee's half; and it is clear that the greatest part of this inclination occurs at the apogee and perigee of the eccentric; and then it happens that both the apogee and perigee of the epicycle cohere to the plane of the eccentric. The places of the intersections for Venus and Mercury, however, are away from the ecliptic in their deferents.

But the community of astronomers verify the genzahar of the planets in this way. For 140 degrees are subtracted from the aux of Saturn, 70 degrees from the aux of Jupiter, 90 degrees from Mars, nothing from the aux of Venus, for its node is always | in the place of its aux. 180 degrees are subtracted from the aux of Mercury; and having done this, the true places of the genzahar of the five planets will remain. The quantities of these latitudes in the north and south from the circle of the signs are thus. The latitude of the Moon is five degrees from the degrees of the circle of the signs. But for the five planets, let us describe briefly that which is gathered from the latitude of all of those motions in the north and the south. Indeed the latitude of Saturn is three degrees; Jupiter is two; Mars is four degrees and a third and a fourth in the north and seven degrees in the south; Venus is six degrees and a third, as is made clear in the Almagest, and, outside the Almagest, nine; Mercury is four degrees.<sup>20</sup> And thus we have completed the latitudes of all the motions, thereby finishing the first chapter with God's help.

# The Second Chapter On the Practice of Finding the Latitudes of the Planets

There is, moreover, a difference between the declination and latitude of planets. Indeed the declination, properly called, is taken from the equinoctial circle such that the declination of the planet or star is the distance or the quantity of the arc of the circle between the star and the equinoctial [circle]. I am speaking of the circle going through the axis of the equinoctial circle, the star and the degree of the equinoctial circle.

But the latitude of the planet is explained above in the first chapter. Indeed, one should proceed thus in order to obtain the latitudes of the Moon. Subtract the equated place of the genzahar from the equated place of the Moon, or add the mean motion of the genzahar to the equated place of the Moon, and you will have the arc of the Moon; and with this, enter the lines of number of the equation of the Moon, and take the latitude of the Moon that is placed opposite of it; this will be northern ascending if its argument is from one degree to 90. If, however, [it is] from 90 to 180, then it will be northern descending. If, moreover, it is from 180 to 270, it will be southern descending. And [if it is] from 270 to 360, it will be southern ascending.

And you will find the declination of the Sun and the stars in the same way by entering with the degree of the Sun into the table of declination; and that which is opposite it will be the true declination of the Sun, which is ascending in the north or descending in the south, in that way in which we said about the Moon. But in the six planets apart from the Sun, the declination is found in another way. For, if the latitude is northern, it is necessary to add it to the declination found for the degree of the planet, or – if it is southern – [it is necessary] to subtract it; and what remains will be the planet's declination from the equinoctial circle.

To find the latitudes of the five planets, moreover, tables of three kinds are arranged: the first [kind] is that in which [the table] is entered with the mean center in the descending line, and with the mean argument in the transversal line; and that which is taken is that which is in the con vergence of the [two] lines; and that will be the latitude of the planet; and that method is easy.<sup>21</sup> And there is another way by means of two-part number and four-part number tables.<sup>22</sup> They are called two-part as they show the latitude resulting from the epicycle's part; therefore, one enters into them with the equated argument. But the four-part show the latitude resulting from the part of the eccentric; therefore, one enters into them with the equated center.

Moreover, to get the arguments of the latitudes of the five planets: it is necessary to know their intersections, that is, the genzahar with the ecliptic which were at the beginning of the era of the Arabs, as is made clear in the following table and at the beginning of the era of the Illustrious John, duke of Bourbon and Auvergne, as [is is shown] in the following table by which we will operate in our own time, that is, in the year of our Lord 1425; and for a future time we will add to the genzahar of any of the five planets that which is placed in the table of the continuation of their motions.<sup>23</sup>

#### On the Latitude of the Three Superior Planets

Moreover, if you wish to find [the latitude] through the two-part number table of the three upper planets, enter the lines of number of the two-part tables with the equated argument of whichever you wish, and write apart what is opposite of it in the table of that planet; and this will be the root of the latitude. Next, subtract the genzahar of that same planet from its corrected place, or add the mean motion of the same planet's genzahar to its corrected place, and you will have the argument of latitude; and with

this, enter the lines of number of the four-part table, and take what you have found in table of the planet; and divide that by the root of latitude that was found above. And what results from the division is the latitude of the planet. In case you cannot divide, break it into smaller parts and then divide as happens with fractions of hours.

And if the argument of latitude, with which you entered, is from one degree to 90, this latitude will be northern ascending, in that way in which we have declared above about the Moon. Nevertheless, others, when they could not divide the second latitude by the first, do this conversely, and then compute the latitude from the limb of the zodiac toward the ecliptic.<sup>24</sup> And so is had, moreover, knowledge of the latitude of Venus and Mercury. We enter the two-part number tables with their equated argument, and we operate as has been said about the others. Moreover, we compute the argument of latitude thus: we add their equated argument to the mean motion of the Sun, and, from what is added, we subtract their genzahar or we add the mean motion of their genzahar to the same summed number; and thus we find the argument of their latitude; and with this, we enter the lines of the four-part number tables and we operate for everything as we did in the case of the three upper planets; and thus we shall find the latitudes of these two planets by computing from the ecliptic or from the limb of the zodiac; and this suffices concerning the second way for finding the latitude of the planets.

And there is another, a third, way<sup>25</sup> in which you will truly find the latitudes of the five planets according to the following method using a

table composed by [JOHN] OF LIGNÈRES, which we have made easier and clearer.

#### On the Latitude of Saturn, Jupiter and Mars

First, the center and the equated argument of any of them should be written by themselves. Second, add 50 degrees to the equated center of Saturn; 20 degrees should be subtracted from the true center of Jupiter and from the center of Mars nothing should be changed. Third, with the center of any of these [planets] take the minutes of proportion. Fourth, with the true argument of any planet take the latitude such that, when indeed the true center, with its added, subtracted, or unchanged [value], is found on the upper part of the table, then you take a northern latitude. If not, then [you take a] southern [latitude]. Fifth, from that latitude take the proportional part according to the proportion to 60 and this proportional part will be the latitude of the planet.

#### On the Latitude of Venus

First, let any center be written down with the equated center by itself. Second, with the equated argument take what is opposite of it in the table of declination<sup>26</sup> and reflection<sup>27</sup>, and let it be written aside. Third, add 60 degrees to the center and with those take the minutes of proportion. Fourth, take the proportional part of the saved declination according to the proportion to 60, and that proportional part will be the latitude of the epicycle; save it, and if the center, with its added [value], and the true argument are in the same part of the table, whether in the upper or the lower, then the latitude will be southern. If, however, they are in different tables, then the latitude will be northern; therefore, write down the name of its direction. Fifth, with the simple center of Venus previously saved, take the minutes of proportion and let them be written down separately

and similarly take again the sixth part of the minutes of proportion, and that is the third latitude that results from the deviation<sup>28</sup> of the deferent from the ecliptic, and is always northern; and with the minutes of proportion that have been saved apart, take the proportional part from the reflection that has been saved according to the proportion to 60; and this will be the reflection examined for a second time; write it down.

Then, if the simple center of Venus is on the upper half and the true argument of the planet is less than 3 physical signs, the reflection will be northern. If the argument is more [than 3 physical signs], then it will be southern. But, if the center is on the lower half [of the table] and the argument [is] less than three signs, then the reflection will be southern. If the argument is more than three signs, it will be northern; and this is the second examined latitude, that results from the declination of the epicycle; save it, and write down the name of its direction.

Finally, combine together these three latitudes in like manner, and subtract the lesser from the greater if [the latitude] is not in the same direction. And the latitude will be denominated from the greater. But if all are in the same direction, add them all together at once, and this will be the latitude of Venus.

#### On the Latitude of Mercury

First, let any true center and true argument be written down by themselves. Second, with the true argument take what you find opposite to it in the table of declination and reflection and let it be written by itself; in like manner, take again the tenth part of the reflection which you will subtract from the reflection if the true center is found on the upper part of the table. If not, however, add that tenth part of the reflection to the reflection; keep it, having deleted the first value. Third, with the true center of Mercury add 4 physical signs and 30 degrees and with these take the minutes of proportion. Take the proportional part from the declination already saved

according to the proportion to 60; and what results will be the latitude examined for the first time, resulting from the declination of the epicycle; keep this. And if the center with its added [value] and the true argument are in the same part of the table, then the latitude will be southern. If they are in different [parts of the table], then [the latitude] will be northern; write down the name of its direction. Fourth, add three physical signs to the true center of Mercury with which you get the minutes of proportion; in like manner, take the fourth part with half a fourth. And this will be the third latitude of Mercury which is always southern; write this apart, and with the minutes of proportion and the reflection previously saved, take the proportional part according to a proportion to 60 and this will be the examined reflection, which you will save.

Now if the true center of Mercury, with its added [value], together with its minutes of proportion that you have finally taken, is on the upper half [of the table], and the true argument of the planet is less than three signs, then the reflection will be northern. But if [the true argument] is more than three signs, then [the reflection] will be southern. But, if the center with its added [value] is on the lower half and the argument is less than three signs, then the reflexion will be southern; if the argument is more than three signs, then it will be northern; this is the latitude examined for a second time which results from the declination of the epicycle; save it, and write the name of its direction. Finally, add these three latitudes together, if they were in the same direction, and you will have the latitude of Mercury. If, however, they were in different directions, then subtract the lesser from the greater, and what remains will be the true latitude of Mercury computed from the path of the Sun.

Now this, my Michael, is what we have briefly composed from the sayings of the Wise on the latitudes of planets and stars with respect to theory and practice. Farewell.
