# The Palestinian Refugees, Christian Humanitarianism, and the Remaking of the Melkite Church

### Abstract

The arrival of thousands of Palestinian refugees in Jordan after 1948 and 1967 represented a major challenge for young states, international institutions and humanitarian organisations, both faith-based or secular. In this context, the Melkite Church developed its assistance activities, particularly health and vocational education, to respond to this humanitarian crisis and the needs of the refugees. By questioning the humanitarian strategy implemented by the Church through its representative Mgr Assaf, this article will revisit the modalities of deployment of a Melkite humanitarianism in Jordan. The latter was based on the redefinition of the Church's modes of action and its expansion into new cities on a national scale. In order to do so, the Church began major structural changes, especially in its personnel: feminisation, laicisation and internationalisation. How does the case of Melkite humanitarianism allow us to understand a large-scale response to the humanitarian crisis in Jordan, especially in urban space outside the camps? How does the case of Melkite humanitarianism contribute to a deeper understanding of the structural changes in the in the recent history of the churches in the Middle East?

Keywords: Palestinian refugees, Melkite humanitarianism, humanitarian diplomacy, Jordan

#### Introduction

In 1948, with the Arab-Israeli war and the *Nakba*, the exile of thousands of Palestinian refugees to neighbouring countries created an unprecedented humanitarian emergency situation in the Middle East to which states, international institutions and religious organisations had to respond.<sup>1</sup> In 1950, the West Bank was formally annexed to the Hashemite Kingdom of Jordan. Jordan was the main host territory for an estimated 280,000 Palestinian refugees.<sup>2</sup> In 1967, the arrival of a second wave of refugees or displaced persons swelled this number. These migrations constitute a structuring, yet little documented, turning point in the history of humanitarianism and Christian assistance policies in the region. Most of the humanitarian institutions or international NGOs developed their activities in Jordan with the arrival of Palestinian refugees,

after 1948 in the case of the Near East Christian Committee for Refugee Work,<sup>3</sup> after 1967 for Caritas for example.

From 1948 onwards, together with the young governments of the region, religious institutions strove to respond to the humanitarian crisis. In addition to Muslim assistance,<sup>4</sup> churches developed their activities. This article looks back at the structuring of Melkite humanitarianism in Jordan from 1948 onwards. It will show that the newly appointed Archbishop Michel Assaf played a crucial role to promote the Melkite Church as a key actor of Christian humanitarianism in Jordan, by implementing new forms of humanitarian action. How was Melkite humanitarianism defined and characterised? How has Melkite humanitarian diplomacy been used to serve competitive humanitarianism in the field, predominantly towards other Catholic institutions but also to counter the development of Muslim social action? In order to do so, the present article will review two structural characteristics of post-1948 Melkite humanitarianism: the feminisation of the Church personnel involved in social action, and its laicisation. How does the case of Melkite humanitarianism allow us to better understand the large-scale response to the humanitarian crisis in the country's urban spaces? How does it contribute to a deeper understanding of the structural changes in the in the recent history of the churches in the Middle East?

Research articulating humanitarianism and the Palestinian refugee issue initially focused on the work of the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA). The latter was established in 1949 by the UN General Assembly with the prerogative of improving the living conditions of refugees and reintegrating them into the economies of their host countries, with a primary focus on education and vocational training.<sup>5</sup> UNRWA's humanitarian policy<sup>6</sup> was thus thoroughly documented, including the institution's representations of its humanitarian action, through the medium of photography.<sup>7</sup> Next, research focused on UNRMWA's activities as far as legal, economic and nation-building policies.<sup>8</sup> The attention paid to UNRWA and the importance of the Palestinian migration phenomenon in the region led to the development of research on assistance to Palestinian refugees, largely focused on the camp space from 1952 onwards,<sup>9</sup> and the encampment policies encouraged by the states of the region and international institutions.<sup>10</sup>. However, while studies on the articulation

between faith-based humanitarianism and assistance to refugees have flourished since 2011 and the war in Syria,<sup>11</sup> the response of religious institutions and faith-based NGOs to the 1948 and the 1967 humanitarian crises remains under-researched.<sup>12</sup>

This article builds on the recent literature on faith-based humanitarianism. It discusses the notion of secularisation and the dichotomy between faith-based and secular humanitarianism.<sup>13</sup> The confessional dimension of charity, including refugee assistance, is increasingly scrutinised in order to highlight the links between religion and charity, humanitarianism and confessionalism.<sup>14</sup> The genealogy of Christian humanitarianism in the region can be traced back to the end of the 19th century, when the Middle East was established as a "laboratory of modern humanitarianism".<sup>15</sup> Management of the migratory phenomenon has been central to this genealogy since the Ottoman period and has conditioned the development of a "humanitarian diplomacy".<sup>16</sup> This humanitarian diplomacy is linked to the implementation of strategies and/or cooperation aimed at influencing the deployment of policies implemented by the public authorities towards the populations targeted by the relief work. It is based on multi-scale networks of solidarity and influence. After WW1 it was reshaped asymmetrically by the churches within the new national borders.

Missionary organisations and then Christian associations flourished in the Middle East from the end of the 19th century and they provided assistance to the "poor" or "deprived

population", particularly in Palestine,<sup>17</sup> Egypt<sup>18</sup> and Lebanon.<sup>19</sup> It is mainly within the Protestant world that the connection between charity and the Christian religion has been studied.<sup>20</sup> The humanitarian networks linked to the Catholic Churches remain little studied even though they shed light on blind spots in the competitive fabric of humanitarianism in the Middle East. In Jordan, after the initial development of Protestant and Catholic health and educational assistance at the end of the Ottoman period, the creation of the Emirate of Transjordan under the British mandate made Amman a new front for missionary competition, with the opening of hospitals, such as the Italian hospital in Amman in 1926 or another one in Karak in 1932 by the ASMI. The Church Missionary Society, a British Protestant missionary society, also opened several dispensaries at the end of the 19th century and opened a hospital in Amman in 1926 in the al-Ashrafiyya district. These churches laid the foundations for the humanitarian institutions which went on to develop a response to the reception of Palestinian refugees after 1948 and then again after 1967.

The Melkite or Greek Catholic Church, a Middle Eastern or local church, attached to Rome since the 18th century, is an Eastern Rite Church. Widely established in Palestine, Syria and Lebanon, it developed in Jordan from the inter-war period as a result of missionary activity and then with the arrival of Palestinian refugees. From the early  $20^{\text{th}}$  century it was referred to as the bridging church (*Église-pont*) by certain members of the catholic episcopal hierarchy. During the inter-war period it was considered as a missionary church *par excellence* through its development of schools, chapels and churches throughout the country.<sup>21</sup> Since the refoundation of the Patriarchate of Jerusalem in 1847 and its latinisation policy, conflicts had been recurrent between the representatives of the Latin and Eastern rites within the Catholic Church, often in competition on the field. This led to several attempts at reconciliation with the setting up of inter-ritual schools or even projects for a single patriarchate.<sup>22</sup>

From the 1920s onwards, the rapid development of the Melkite Church in the Emirate of Transjordan led to the creation of the Archeparchy (archdiocese) of Petra and Philadelphia in 1932, whose prerogatives extended to the national borders. It was first entrusted to Paul Salman, a Syrian and former seminarian of Saint Anne of Jerusalem.<sup>23</sup> After his death in 1948, his

successor, Michel Assaf, a Syrian also trained at Saint Anne continued his policy of expansion on a national scale, notably through the development of social action and assistance to Palestinian refugees. The Melkite Church, which was very active in the education sector, had not developed a charitable health activity in Jordan until the arrival of Palestinian refugees. This article then questions the model of Melkite humanitarianism developed after 1948. What were the modalities of its implementation? This article argues that the crafting of Melkite humanitarianism cannot be understood without taking into account humanitarian diplomacy in Jordan: field activities were deployed thanks to the development of international philanthropic funding networks and above all through collaboration with international institutions, including the UN. The notion of humanitarian diplomacy will shed light on the networks of actors (religious, lay, philanthropists) linked to the assistance of Palestinian refugees and the strategies developed in order to constitute a Melkite humanitarian space in Jordan through the support of Jordanian authorities, international institutions and the Catholic hierarchy. This humanitarian diplomacy brought in new actors: women and laity, keys actors in the recent history of the church and the redefining of its activities in the field.
