24	Abstract
25	Over the last millennium, the town of Aghmat (Morocco) has undergone major socio-
26	economic changes, raising the question of how these transformations have affected the
27	development of agricultural systems and exploited landscapes over time. This preliminary
28	pilot study brings together for the first time carpological, anthracological, and isotopic results
29	from the Aghmat archaeological program that show a certain stability for staple productions
30	(cereals, fruit) over the last millennium, and the exploitation of various landscapes. A shift
31	appears to occur during the late Middle Ages, potentially due to more favorable conditions,
32	with a specialization in olive cultivation as early as the fourteenth century, and significant
33	deforestation following this olive growing boom. During the modern period, the importance
34	of olive cultivation is confirmed, whether or not in conjunction with a decline in water
35	availability and what appears to be irreversible deforestation.

41	Introduction

Numerous studies over the last several decades have addressed the relationship between 42 human societies and their environments (both agricultural and forestry) in the medieval and 43 modern western Mediterranean using written and iconographic sources (e.g., Bourin-derruau, 44 1987), archaeological sources (e.g., Demians d'Archimbaud, 1982), or a combination of 45 several of these sources (e.g. Ouerfelli & Voguet, 2009). With rare exceptions (e.g., Durand, 46 1998; Puig, 2003; Ros et al., 2014), this extremely rich body of work has focused on the 47 occupation of the countryside in the broadest sense (occupation dynamics, land structuring), 48 without specifically focusing on characterizing the exploited plant resources, cultivation 49 practices (manure, irrigation), or agrosilvopastoral landscapes, which are fundamental to 50 establishing how past societies adapted their methods of exploiting plants and animals, and 51 the landscapes in which they evolved, according to the socio-economic (local, global) and 52 environmental context (climate change, availability of resources). The study of agricultural 53 54 and forestry systems is particularly interesting over the long term as it provides the necessary hindsight to understand their evolution, their resilience, and the role of each parameter 55 56 (cultural, economic, political, environmental) that has influenced them.

The development of archaeobotany in the 1970s and 1980s in France and Spain led to 58 the production of the first synthesis documenting, on a local or regional scale, the agricultural 59 and forestry systems of the historic western Mediterranean (e.g., Durand, 1998; Ruas, 2005; 60 Peña-Chocarro et al., 2019; Ros et al., 2019; Ros, 2020). In Morocco, these systems have long 61 been studied solely through the prism of textual sources, in particular works by geographers 62 and travel accounts. Over the same decades, several archaeological missions have initiated 63 research into medieval agrosilvopastoral production, practices, and landscapes, resulting in a 64 number of pioneering publications (Pollock, 1986), although several studies remained 65 unpublished and difficult to access. The 2000s saw a new development (Ruas, 2018) resulting 66 from interdisciplinary approaches in ancient and medieval sites, such as Lixus and Volubilis 67 (Grau Almero et al., 2001, 2010; Fuller, 2002, 2004; Pérez Jordà, 2005; Fuller & Stevens, 68 69 2009; Fuller & Pelling, 2018). Since the 2010s, new sites have been and are still being investigated on a large scale, with research dedicated to the palaeoenvironmental 70 reconstructions. Examples include the large-scale excavations at Îgîlîz, Rirha, and Thamusida 71 (Ruas et al., 2011, Allevato et al., 2013, 2016; Ruas et al., 2016a, b; Carrato et al., 2020). 72 Among these regions, Al Haouz has been the focus of particularly important archaeological, 73 bioarchaeological and ethnological research in recent years, particularly in the area of 74 75 Aghmat, a town of medieval origin located at the foot of the High Atlas (Ros et al., 2021),

because of its chronology of occupation, which spans the whole of the High and Late MiddleAges, and part of the Modern era.

## 79 Aghmat: Environmental and archaeological context

The city of Aghmat is located about 35 km south-southeast of Marrakesh (Morocco) at an 80 altitude of about 541 m.a.s.l. in the high altitude plain of the Haouz, at the foot of the High 81 Atlas Mountains (Ait El Mekki & Laftouhi, 2016) (Fig. 1). According to Héritier-Salama et 82 al. (2016), its location on the plain at the mouth of the Ourika valley was highly conducive to 83 the early development of large-scale irrigated agriculture. It has a warm, semi-arid climate 84 (BSh climate type according to Koppen climate classification, Koppen 1936), the minimal 85 and maximal mean temperatures ranging from 10.9°C to 24.8°C (AQUASTAT Climate 86 Information Tool, FAO; http://www.fao.org/nr/water/aquastat/climateinfotool/index.stm). The 87 annual average precipitation is 541 mm/year (Saidi et al., 2010). The soil, with modern 88 Quaternary formations, is Fersiallitic (medium Sandy Clay Loam) of good permeability and 89 90 drainage (i.e., gravel, sand) (Ait El Mekki & Laftouhi, 2016). These climatic and environmental conditions allow the development of the Quercetea ilicis, an often evergreen 91 and sclerophyllous Mediterranean shrub/tree vegetation (Achhal, 1979; Barbéro & Quézel, 92 1981; Benabid, 1982). Groups of araar trees (Tetraclinis articulata) are found on the foothills 93 of the Atlas mixed with other species (Juniperus phoenicea, J. oxycedrus, Pistacia lentiscus, 94 Cistus monspeliensis, and, on shady slopes, with *Quercus ilex* subsp. rotundifolia, Arbutus 95 unedo, Phillyrea angustifolia, Cistus salviifolius) (Benabid, 1985; Fennane, 1988; Ouhammou 96 & Aubin, 1991). Further downstream from Aghmat a thermophilous shrubland develops 97 (Pistacia lentiscus, Ziziphus lotus, wild Olea europaea) (Quézel & Médail, 2003). The fertile 98 Ourika valley allows cultivation of cereal and tree crops (Héritier-Salama, 2019). 99 100

During the Middle Ages, Aghmat is described by textual sources at the beginning of 106 the ninth century as "a major commercial crossroads, a flourishing city and a very important 107 agricultural production centre." It became a capital under the Almoravids in 1058, but was 108 then gradually abandoned towards the end of the fourteenth century in the face of the 109 hegemony of the new Almoravid capital: Marrakech. In the sixteenth century, Leon the 110 African described a ruined city occupied by rural inhabitants. Since 2005, archaeological 111 studies of Aghmat have allowed a better understanding of this transitional period during the 112 Late Middle Ages (fourteenth-fifteenth centuries) (Fig. 2). The archaeological data show that 113 the period of abandonment was very gradual, over nearly two centuries from the fourteenth to 114 the end of the fifteenth, and partial, never really leading to a total desertion, with certain 115 districts being reinhabited or changing function (Héritier et al., 2016). The sixteenth century 116 was characterized by the arrival of a more rural and modest population, the Sufis, a 117 brotherhood of ascetics (Héritier et al., 2016). Aghmat also saw immigration linked to the 118 Portuguese incursions on the coast. The town then underwent a settlement breakdown and an 119 agricultural conversion (Héritier et al., 2016). While these major socio-economic dynamics 120 are becoming well understood from a historical and archaeological point of view, their 121 possible effects on landscapes use and on agropastoral productions and practices are only 122 beginning to be explored (Ros et al., 2021). Consequently, we propose a preliminary pilot 123 study that demonstrates the great value of combining different methods and materials. 124 125

## 134 Research Goals

- Reconstruct the diversity and evolution of the forest cover over the last millennium in
   relation to changes in the city's status
- Document the main cultivated/exploited plant species and any changes they may have
  undergone (diversity, type of remains, frequency)
- Highlight agricultural practices (fertilization, irrigation, land used) in relation to cereal
  growing.

# 142 Materials and methods

143 Origin of the archaeobotanical samples and method of extraction and identification

We analyzed a total of 26 archaeobotanical samples from 23 archaeological features. These
features mainly correspond to secondary deposits from 'open' features, such as ditches, living
spaces (e.g., houses), gardens, rubbish dumps, plantation pits and hearths. The original
volume of the samples ranges from 0.5 to 14 liters. All the samples were sieved using a

148 flotation machine (2 mm and 250  $\mu$ m) during the different excavation campaigns.

The identification of the seed and charcoal remains was carried out at the ISEM 149 laboratory (Montpellier, France), using a Nikon SMZ645 stereoscopic magnifier (x0.8 to x10 150 magnification). For the identification of seed remains, we used a reference collection of fresh 151 and archaeological seeds as well as Cappers et al., 2006; Jacomet, 2006; Rameau et al., 2008. 152 The remains were quantified, either as entire specimens or as fragments and the frequency of 153 occurrence of cultivated taxa was calculated per sample / phase. For anthracological analysis, 154 specific recognition was done using an Olympus BH2-UMA reflection microscope, with 155 156 black/white background and x100, x200 and x500 magnification, with the help of reference atlases (Jacquiot, 1955; Jacquiot et al., 1973; Schweingruber, 1990; Vernet et al., 2001) and 157 the reference collection of the team "Dynamique de la biodiversité, anthropo-écologie" 158 (ISEM, UMR 5554). The latin nomenclature follows the French 'Inventaire National du 159 Patrimoine Naturel' (Museum National d'Histoire Naturelle, Paris). 160

## 162 Radiocarbon datings

Radiocarbon age determinations were performed on eight charred seeds (naked wheat and
barley caryopses, olive kernel, jujube kernel fragment) extracted from eight different
stratigraphic units, using AMS (Accelerator Mass Spectrometry) facilities at Poznan
Radiocarbon Laboratory (Table 1). The calibration of <sup>14</sup>C-dates was performed using OxCal
4.4 program version and the calibration data set was IntCal20 Northern Hemisphere

atmospheric curve (Reimer et al., 2020) (Table 1).

#### 175 *Isotopic analysis*

A total of 40 archaeobotanical charred seeds of hulled barley (n=20) and naked wheat (n=20)176 were selected for carbon, nitrogen and sulfur isotopic analysis ( $\delta^{13}$ C,  $\delta^{15}$ N and  $\delta^{34}$ S). All were 177 rinsed three times for 10 min in ultrapure Milli-O® water at room temperature, dried 178 overnight (40°C), before being crushed and homogenized. About 0.5 to 2 mg of powder was 179 then weighed using a precise balance  $(\pm 1 \mu g)$  and loaded into small tin capsules (3.5 x 5 mm) 180 for N and C. For sulfur, 10 to 15 mg of material were introduced in bigger tin capsules (5 x 8 181 mm size). The crushing and encapsulation were carried out using tweezers that were cleaned 182 between each sample. 183

Isotopic and elemental contents analysis for C, N and S were measured by dry 184 combustion using a Pyrocube Elemental Analyser (EA, Elementar GmbH) equipped with a 185 purge and trap gas separation system configured in combustion mode (Fourel et al., 2014). 186 The elemental Analyser was connected on line in continuous flow mode to an IsoPrime 100 187 isotope ratio mass spectrometer (Elementar UK Ltd). Data were calibrated against 188 international reference material IAEA-600, IAEA-CH6 and IAEA-N2. The  $\delta^{13}$ C,  $\delta^{15}$ N and 189  $\delta^{34}$ S values are expressed in  $\delta$  notation, deviation from standards in parts per thousand (‰), 190 relative to V-PDB (Vienna Pee Dee Bee Belemnite), V-N2 (atmospheric N<sub>2</sub>) and V-CDT 191 (Vienna-Cañon Diablo Troilite) respectively:  $\delta^m X = (R_{sample}/R_{standard} - 1) \times 1000$  where R = 192  $^{13}C/^{12}C$  for carbon,  $^{15}N/^{14}N$  for nitrogen or  $^{34}S/^{32}S$  for sulfur. The precision for  $\delta^{13}C$ ,  $\delta^{15}N$  and 193  $\delta^{34}$ S is better than 0.1 ‰. The results of elemental C, N, S contents are expressed as (%) and 194 are also presented as C/N and N/S atomic ratios. 195

Correction factors are applied to the  $\delta^{13}$ C seed samples due to long term changes of 196 the carbon isotopic composition of the atmospheric CO<sub>2</sub> ( $\delta^{13}C_{AIR-CO2}$ ) over time according to 197 Antarctic ice core records (Francey et al., 1999; Leuenberger et al., 1992), as described in 198 Ferrio et al. (2005).  $\delta^{13}$ C seed values and  $\delta^{15}$ N seed values were also corrected for the effect 199 of charring (+0.11‰ for the  $\delta^{13}$ C and +0.31‰ for the  $\delta^{15}$ N; Nitsch et al., 2015). During 200 biological processes, isotopic differences (i.e. between tissues, species) can be calculated and 201 those represented by the " $\Delta$ " symbol corresponds to isotopic discrimination. We calculated 202 the carbon isotopic discrimination ( $\Delta^{13}C_{\text{SEED-CO2}}$ ) by adapting the equation of Farquhar et al. 203 (1982),  $\Delta^{13}C_{\text{SEED-CO2}} = (\delta^{13}C_{\text{AIR}} - \delta^{13}C_{\text{SEED}})/(1 + \delta^{13}C_{\text{SEED}}/1000)$ , where  $\delta^{13}C_{\text{AIR}}$  and  $\delta^{13}C_{\text{SEED}}$ 204 refer to the  $\delta^{13}C$  of the atmospheric CO<sub>2</sub> and  $\delta^{13}C$  of the plant, respectively. In C3 plants, 205 carbon isotopic composition is determined by the diffusive discrimination of <sup>13</sup>C in air 206 through the stomata (4.4‰), the net discrimination caused by carboxylation through the 207

- RuBisco enzymatic activity (29 ‰) and by the ratio of intercellular (ci) to ambient (ca) leaf
  partial pressures of CO<sub>2</sub> (Farquhar et al., 1989; Maxwell et al., 2018).
- 210 Charred seed  $\Delta^{13}C$  were compared with the reference threshold  $\Delta^{13}C$  values that
- 211 differentiate between plant growth under well-watered and drier conditions. We used the
- reference threshold  $\Delta^{13}C$  values of 17.0 to 18.5 % for moderately watered barley and 16.0 to
- 213 17.0 for moderately watered wheat (Araus et al., 1997; Wallace et al., 2013).
- Using the  $\Delta^{13}C_{SEED-CO2}$ , we assessed the water use efficiency (WUEi expressed in µmol CO<sub>2</sub> mol -1 H2O) as leaf net photosynthesis (A) is related to the leaf conductance of the
- 216 water vapor (gH<sub>2</sub>O) as described in Du et al., (2021): WUEi =  $(b-\Delta^{13}C_{\text{SEED-CO2}})/(1.6*(b-a))$ ,
- where a is 4.4‰ and b is 27‰. We also evaluated the water input during cereal filling
- 218 (expressed in mm) using the model described for wheat (*Triticum aestivum*) and barley
- 219 (Hordeum vulgare) in the South-West Mediterranean region (Araus et al., 1997; Ferrio et al.,
- 220 2004, 2005; Speciale et al., 2020).

# 222 **Results**

### 223 Seed remains

Of the 26 available samples, 21 were fully sorted, identified and quantified; the remaining six samples were surveyed, i.e., their taxonomic diversity was recorded and their abundance

- assessed. We studied a total of 7545 carpological remains preserved by carbonization, of
- which were identified 7473 (see Appendix 1 for raw data).
- The plant taxonomic spectrum is made up of 60 taxa, classified into five categories: 228 cereals, legumes, technical/textile plants, fruit trees and wild plants. Cereals formed the most 229 abundant category of cultivated plants, with 2050 remains (27.4% of all the identified 230 remains) and also the second most frequent in the samples (present in 20 samples out of 26) 231 (Fig. 3). We recorded at least 6 cereals: hulled barley (Hordeum vulgare), naked wheat 232 (Triticum aestivum/turgidum), millet (Panicum miliaceum), oat (Avena sp.), a possible hulled 233 wheat (Triticum type monococcum/dicoccum/spelta) and potentially rye (cf. Secale). Among 234 the chaff remains, the presence of some well-preserved rachis suggests the presence of both 235 hexaploid and tetraploid wheats. Fruit trees were the most abundant cultivated plants, with 236 237 843 remains (11.3% of the identified remains, present in 21 samples out of 26) (Fig. 3). We
- recorded 11 taxa: olive (*Olea europaea*), fig (*Ficus carica*), grapevine (*Vitis vinifera*), walnut
- 239 (Juglans regia), date palm (Phoenix dactylifera), almond (Prunus dulcis), peach (Prunus
- 240 *persica*), pomegranate (*Punica granatum*), blackberry (*Rubus fruticosus*), raspberry (*Rubus*

- 241 *idaeus*) and jujube (Ziziphus sp.). Most of these remains were food residues (seeds or pits
- 242 without flesh). Pulses and technical/textile plants were fairly rare (Fig. 3). Pulses were only
- recorded by 25 remains (0.3% of total remains, present in seven samples), and their bad state
- of preservation did not allow them to be identified beyond the family, although a possible
- 245 Lathyrus might have been present. Flax (Linum usitatissimum) was recorded by four seeds
- (0.1% of remains) in 4 samples, but was observed in two of the surveyed samples. Finally,
- wild plants were recorded by 4552 remains (60.9% of the total remains, present in 16
- samples), corresponding to 40 taxa, 13 of which were identified to species. Most of these wild
- 249 plants came from a single sample (SUQ2363-north, fifteenth-sixteenth centuries).

#### 255 Charcoal remains

Of all the available samples, eight yielded sufficient charcoal fragments to complete the 256 257 anthracological study. We studies a total of 1363 charcoal fragments, of which we identified 1301 at the family, genius or species level (see Appendix 2 for raw data). At least 17 different 258 taxa were identified, with the anthracological spectrum dominated by olive (Olea europaea), 259 which represented 36.5% of the studied charcoals, followed by evergreen oak (potentially 260 holm oak, *Quercus ilex* subsp. rotundifolia, established in this region), which accounts for 261 14.7% of the anthracological spectrum, and arear tree with 7.9% (Tetraclinis articulata). 262 Although junipers and the arear tree are very similar in anatomy, the latter was identified by 263 the presence of warts on its tracheids walls (Schweingruber, 1990: 145) (Fig. 4). 264 Approximately 9.8% of the fragments correspond to wadi edge species, i.e. 5.4% grass-type 265 monocotyledons, 4.3% poplar/willow (Populus/Salix) and 0.1% tamarisk (Tamarix). The 266 267 identification of ash (5.6%) is difficult to attribute ecologically, as there are two types of ash in this part of Morocco: Fraxinus angustifolia, which is a riparian/wadi edge species, and 268 Fraxinus dimorpha, which is an endemic forest species found in association with Quercus ilex 269 on the High Atlas slopes. Fruit trees make up around 13.8% of the corpus, i.e., 7% Rosaceae 270 maloideae, 2.1% pomegranate (Punica granatum), 1.8% Rosaceae prunoideae, 1.3% fig 271 (Ficus carica) and 1% grapevine (Vitis vinifera). Among the prunoideae charcoals identified, 272 there is a diversity that is not due to intraspecific anatomical variation. On the tangential 273 274 longitudinal plane, some rays are one to three series while others have seven-eight series (Appendix 2); the latter can be attributed to the *Prunus armeniaca/dulcis/persica* group, *i.e.*, 275 almond, apricot and peach. Next, 0.4% of pistachio trees (Pistacia lentiscus) and 0.7% of 276 potential pistachio trees (Anacardiaceae/cf. Pistacia) and finally, 0.3% of filaria/ buckthorn 277 (Phillyrea/Rhamnus), 0.2% of acacia/fig tree (Acacia/Ficus) and 0.1% for the following taxa: 278 strawberry tree (Arbutus), Cistaceae/Ericaceae, rockrose (Cistus) and jujube (Ziziphus). The 279 results for the SU that yielded the greatest number of identifiable charcoals were represented 280 in diagrammatic form (Fig. 5), showing the relative proportions of taxa exploited over time. 281

#### 295 Charred seeds isotopic compositions

The carbon, nitrogen and sulfur isotopic ratios of the studied taxa (*Hordeum vulgare, Triticum aestivum/turgidum*) for the period spanning the eleventh-twelfth through the seventeenthtwentieth centuries are presented in Appendix 3, as well as the details of the mean and standard deviation per periods. Over the 40 charred seeds selected for isotopic analyses, three of them did not provide enough gas for their isotopic analysis (below the detection limit of the mass spectrometer) and were not useful. Hence, we obtained 20 and 17 carbon isotopic records of barley and naked wheat, respectively.

Naked wheat samples had  $\delta^{15}N$  (n= 16) and  $\delta^{13}C$  values (n=17) ranging from 3.3 to 8.9 ‰ (mean value 6.0 ± 2.0 ‰), and from -23.6 to -21.1 ‰ (mean value -22.6 ± 0.7 ‰) respectively, and  $\delta^{34}S$  (n = 9) ranging from 2.0 ‰ to 17.8 ‰ (mean value 10.8 ± 7.0 ‰). The mean values of C, N and S contents of the charred naked wheat seeds were on average 40.7 ± 12.3 %, 2.5 ± 1.0 % and 0.2 ± 0.1 % respectively. Hulled barley samples had  $\delta^{15}N$  (n = 19)

values ranging from 2.3 to 9.0 % (mean value 5.6  $\pm$  1.9%) and  $\delta^{13}$ C (n = 20) values ranging 308 from -24.9 to -21.6 % (mean value -23.3  $\pm$  0.8 %), and  $\delta^{34}$ S (n = 10) ranging from - 1.1 to 309 19.5 % (mean value  $12.5 \pm 7.9$  %). The mean values of C, N and S contents of the charred 310 hulled barley seeds were on average  $43.1 \pm 10.2$  %,  $1.8 \pm 0.5$  % and  $0.2 \pm 0.1$  % respectively. 311 312 For the entire period, the WUEi, expressed in µmol CO<sub>2</sub> mol<sup>-1</sup> H<sub>2</sub>O, calculated for 313 barley and naked wheat ranged between 62.2 and 88.4 (75.3  $\pm$  6.9  $\mu$ mol CO<sub>2</sub> mol<sup>-1</sup> H<sub>2</sub>O, n= 314 20) and between 73.8 and 94.0 ( $80.9 \pm 6.0 \mu mol CO_2 mol^{-1} H_2O$ , n= 17), respectively. Water 315 input during barley and wheat cereal filling ranged between 39.7 and 368.7 mm (144.1  $\pm$  81.5 316 mm, n=20) and from 38.4 to 163.4 mm (102.8  $\pm$  40.2 mm, n=17) respectively. 317 318 Carbon and nitrogen contents of the naked wheat charred seeds showed an increase 319 320 between the eleventh-twelfth through the seventeenth-twentieth centuries. The same trend was observed for hulled barley, although the N content increase over time seems to be less 321

important (Fig. 6). C/N ratios ranged from 17 to 31 (24  $\pm$  4) for barley and from 10 and 25 (18  $\pm$  4) for naked wheat (Fig. 6).

For each period, mean  $\delta^{13}$ C values of naked wheat were always higher (-22.7 % to -328 22.5 ‰) compared to hulled barley (-23.7 ‰ to -23.0 ‰), and showed smaller variations 329 between the three periods. On the contrary, naked wheat mean  $\delta^{15}$ N values showed higher 330 variations from 5.4 ‰ (eleventh-twelfth centuries) to 8.0 ‰ (seventeenth-twentieth centuries 331 17<sup>th</sup>-20<sup>th</sup> c.) compared to hulled barley (5.4 ‰ during the fourteenth -sixteenth centuries to 6.1 332 ‰ for the seventeenth-twentieth centuries). For both naked wheat and hulled barley,  $\delta^{34}$ S 333 showed two groups of values (below 7 ‰ and above 15 ‰, Appendix 3, Fig. 7) during the 334 first period, but not during the two following periods, exhibiting only  $\delta^{34}$ S values higher than 335 15 %. The lowest reconstructed precipitation rate during cereal filling derived from the 336 nitrogen isotopes were calculated for both naked wheat and hulled barley for the 17<sup>th</sup>-20<sup>th</sup> c. 337  $(53 \pm 22 \text{ mm and } 92 \pm 13 \text{ mm respectively})$ , while the highest precipitation rate was found 338

- during the eleventh-twelfth centuries both for naked wheat  $(133 \pm 74 \text{ mm})$  and hulled barley
- 340 ( $128 \pm 81$  mm), although the latter was very close to the mean value calculated for the
- 341 fourteenth -sixteenth centuries (Appendix 3). The higher calculated annual precipitation using
- the  $\Delta^{13}C$  of hulled barley were observed during the fourteenth -sixteenth centuries (190 ± 102
- mm or  $142 \pm 52$  mm if we remove the two outliers JR 61 and JR 62 samples) and the lowest
- during the eleventh-twelfth centuries ( $109 \pm 45$ mm).

We did not find isotopic differences between the different studied periods for naked wheat (Kruskal Wallis tests,  $\delta^{13}$ C : chi-squared = 1.2476, p-value = 0.583,  $\delta^{15}$ N : chi-squared = 2.4835, p-value = 0.345,  $\delta^{34}$ S : chi-squared = 2.2044, p-value = 0.413) and hulled barley (Kruskal Wallis tests,  $\delta^{13}$ C : chi-squared = 2.7036, p-value = 0.26,  $\delta^{15}$ N : chi-squared = 1.0665, p-value = 0.616,  $\delta^{34}$ S : chi-squared = 2.2182, p-value = 0.437).

# 355 Discussion

To gain a detailed understanding of changes in the wooded and agricultural landscapes of the 356 357 Haouz plain over the last millennium, we decided to structure the discussion chronologically, by cross-referencing the archaeobotanical and isotopic data available for each period. We 358 discuss the isotopic values of the first period (eleventh-twelfth centuries) in detail compared 359 to the other periods, as it presents the higher number of samples. It also seemed important to 360 detail for this first period our interpretations of the  $\delta^{15}N$ ,  $\delta^{34}S$  and  $\delta^{13}C$  in terms of the 361 presence/absence of manure, the homogeneity/heterogeneity of the terroirs and the availability 362 of water, allowing us to get straight to the point for the following periods. 363 364

# 365 The golden age of Aghmat (eleventh-twelfth centuries)

Founded around the tenth century, Aghmat underwent rapid development during the eleventh-366 twelfth centuries, experiencing strong economic growth. Samples from this period provide the 367 earliest known archaeological evidence of the plant landscapes and productions of this region. 368 At that time, the inhabitants of the site collected wood on the shaded slopes of the High Atlas 369 (Tetraclinis articulata, Quercus coccifera/ilex, Fraxinus) and on the Ourika riverbanks 370 (Populus/Salix, Monocotyledon) (Fig. 5). These woods account for half of the fuel, the other 371 half being made up of a wide variety of fruit trees (Vitis vinifera, Ficus, Punica granatum, 372 373 Olea europaea, Rosaceae prunoideae, R. maloideae). In textual sources, the recurrent description of abundant gardens, both on the outskirts of the city and within the city, 374 underlines the importance of local horticulture and arboriculture (Al-Bakrî, 1911; Al-Idrîsî, 375 1866). We can assume that the abundance of pruning waste generated by urban arboriculture 376 meant that this wood was regularly available and reused as domestic fuel. Seed remains also 377 378 confirm local consumption of these fruits, with figs and grapes being the most prevalent, as well as the production of olive oil. The latter is thought to have been small-scale, and intended 379 380 for domestic consumption, given the absence of large production structures (olive presses). Other consumed plant species include hulled barley, naked wheat, large-seeded legumes, and 381 flax, in other words a typical agrohorticultural diversity for Morocco at that time (Ruas 2018). 382 The scarcity or absence of chaff and pod elements suggests that these were ready-to-eat 383 elements, and it remains to be seen whether they were locally grown or imported. 384

This question can be addressed to some extent with the  $\delta^{34}$ S of both barley and wheat, 385 showing two distinct groups of values for both cereals, with mean values of  $2.6 \pm 2.5\%$  (n=7) 386 and  $17.0 \pm 1.3\%$  (n=12) (Fig. 7). As sulfur is a crucial microelement for plant metabolism, 387 and as the main source for the plants is taken from the soil through the roots, with a limited 388 isotopic fractionation between soil S and seed S (1‰; Tcherkez & Tea, 2013), hence the  $\delta^{34}$ S 389 of Aghmat charred seeds may enhance the hypothesis of two distinct cultivation areas with 390 distinct soil  $\delta^{34}$ S. To our knowledge, no direct studies providing the  $\delta^{34}$ S of the soil in the very 391 specific area of Aghmat is available. However, in the Amensif ore deposit located in the 392 393 Haouz plain, at about 57 km SW of our study area, Jinari et al. (2023) identified two distinct groups of  $\delta^{34}$ S values, one centered around 6 ‰ and the other between 11 and 15‰. If we 394 take into account the concomitant  $\delta^{15}$ N values carried out on charred seed remains (Fig. 6), 395 we can suggest for this specific phase two to four different wheat and barley cultivated lands, 396 397 characterized by different manure managements.

398 Regarding cereal cultivation, for each suggested lands, the small difference between 399 values of  $\delta^{15}$ N of barley and wheat suggests that both crops were grown under the same

manuring conditions (Fraser et al., 2011). Both barley and wheat  $\delta^{15}$ N values reflect mixed 400 agricultural practices, likely with lands cultivated without manuring (<3%), and lands 401 managed with low (4 to 6 ‰) to high (>7‰) manuring intensity (Bogaard et al., 2013; Styring 402 et al., 2016). It is difficult to disentangle the multiple causes of the  $\delta^{15}$ N variations of both 403 cereal crops, and hence to explain precisely the farming conditions. The higher  $\delta^{15}N$  may be 404 explained by stall manure input (with and offset of about 4 % compared to unmanured crops; 405 Steele and Daniel, 1978), but also by soil types and environmental factors affecting soil 406 nitrogen isotopic composition, such as aridity and nitrogen loss (Fiorentino et al., 2014). 407 Using our  $\delta^{15}$ N barley values and the annual precipitation reconstructed following Hartman & 408 Danin, (2010) and Styring et al., (2016) methods, our data plot in the no/low to medium 409 manuring level bands and in the low precipitation level (50 to 300 mm). These reconstructed 410 low precipitations are in agreement with the anomalies of precipitation described by Till & 411 Guiot (1990), showing several drought years and generally dryer conditions for the eleventh-412 twelfth centuries, when the North Atlantic oscillation (NAO) is positive on the Mediterranean 413 414 Basin (before 1350 AD), as suggested by Esper et al. (2007), Trouet et al. (2009), and Wassenburg et al., (2013), enhancing the hypothesis of the aridity impact on the  $\delta^{15}$ N values. 415 These dryer conditions are also suggested by hulled barley  $\Delta^{13}C$  (Fig. 8). Five barley samples 416 417 were under hydric stress, against only one for naked wheat, suggesting that wheat is moderately to well-watered, likely through irrigation (Fig. 8). Including the sulfur isotopes 418 (Fig. 9), we identified four different groups of crops, cultivated in at least three different soils. 419 Barley cereal filling water input is on average 109±45 mm (Appendix 4, 5), close to the SE 420 Spain values described by Araus et al. (1997) for older chronologies. In fact, when we 421 compare the WUEi values with Mora-Gonzales (2017), we observe that most of the wheat and 422 barley are below the proposed theoretical level of hydric stress (85 µmol CO<sub>2</sub> mol-1 H<sub>2</sub>O, 423 Appendix 4). Even taking into account the limits for each species and the differences that 424 could be expected, irrigation appears as a likely solution adopted in most lands, with few 425 exceptions. However, the observed  $\delta^{15}N$  barley range might also suggest different winter and 426 spring crop varieties, associated to different agronomic practices of local farmers in diverse 427 428 environments of the Haouz plain, or reflect imported crops. 429

# 437 Aghmat's last centuries (thirteenth-fourteenth centuries)

After this golden age, the city persists for another two centuries before being impacted by the
wider economic crisis affecting Morocco during the fourteenth century, resulting in
abandonment by its elites. The two centuries leading up to this abandonment show subtle
differences from the previous phase in terms of supply strategies, particularly for fuel. Firstly,
we note changes in the relative importance of the various fruit taxa, with the disappearance of
grapevine and fig tree in the anthracological spectrum, while we observe a significant increase

in the Maloideae, from 10% to 21%, and the olive tree, from 5.8% to 12%. At the same time, 444 the proportion of riparian species increases (from 15.8 to 25%), while the proportion of oak 445 forest species remains stable, although with a significant increase in the proportion of araar 446 trees. These variations in fuel composition could be explained by a change in resources 447 availability: a reduction in the fruitwood resource could have led to more intensive 448 exploitation of certain nearby areas, in particular the Ourika riverbanks. The increase in the 449 proportion of Maloideae is difficult to interpret, as these may correspond to cultivated fruit 450 species (e.g. Malus, Pyrus) as well as hedge or forest edge species (e.g. Crataegus, Rosa). In 451 452 terms of consumed species, there is continuity, both in the exploited diversity and in the type of remains encountered, with the appearance of three new fruit trees: the almond (Prunus 453 dulcis), the date palm (Phoenix dactylifera) and the jujube (Ziziphus sp.). Although palm and 454 jujube trees were known in southern Morocco at this time, this is the first archaeobotanical 455 456 record of almond tree in the country (Ruas 2018). The local nature of the encountered fruit species is debatable; charcoal analysis confirms the presence of pomegranate, olive and 457 458 possibly apricot/almond/peach trees (Rosaceae prunoideae with large rays) in the local landscape. 459

460

The frequency of cereals in the samples indicates their central role in the diet of urban 461 populations during this period. The question remains as to whether they came from local or 462 imported sources. The narrow range of variations of the  $\delta^{34}$ S of hulled barley (16.7 to 18.3 ‰) 463 and naked wheat (from 15.3 to 16.9 %) contrasts with the previous period, highlighting that 464 crops were cultivated in the same region/land. These seeds were grown under no/low to 465 medium manure inputs, as shown with  $\delta^{15}$ N range values of both hulled barley (3.7 to 8.6 ‰) 466 and naked wheat (from 3.4 to 8.0 ‰). Generally, the conditions of crop cultivation seem 467 moderately-watered, as suggested by the  $\Delta^{13}$ C (16.5 % for wheat and 17.7 % for barley) and 468 WUEi with values below 85  $\mu$ mol CO<sub>2</sub> mol<sup>-1</sup> H<sub>2</sub>O (Appendix 4, 5). If we focus on barley 469 WUEi, it is likely that climate conditions were slightly wetter compared to the previous period 470 (71.8 and 78.2  $\mu$ mol CO<sub>2</sub> mol<sup>-1</sup> H<sub>2</sub>O, respectively) in agreement with the negative North 471 Atlantic Oscillation (NAO) phase with cooler and wetter conditions downwards from 1300 472 AD onwards (Esper et al., 2007; Trouet et al., 2009). 473

# 475 *Towards the ruralization of Aghmat (fifteenth-sixteenth centuries)*

476 Archaeological excavations in this phase indicate a clear ruralization of the town, reflected in

both material culture and architectural changes. For example, we identified in the palatial

complex of the site the construction of mud walls aimed at redefining the internal spaces. The 478 natural resources exploited during this period also bear witness to a radical change. As a 479 result, riparian vegetation has almost completely disappeared, with rare monocotyledons 480 being the last possible evidence of its existence. Regarding the exploitation of the oak forest, 481 Tetraclinis has disappeared, Fraxinus is still present, and Quercus has increased significantly, 482 rising from 2.1% in the 14<sup>th</sup> c. to 23% in the sixteenth century. But the most notable change 483 concerns fruit trees: only pomegranate and olive remain in the spectrum, the latter alone 484 485 accounting for 62% of the charcoal fragments studied for this phase. This sudden boom of olive proportions in the anthracological spectrum is remarkable, and the question arises as to 486 whether these results are a sign of the emergence of a specialized production area, the 487 economic scope of which remains to be defined (local, regional production?). The sudden 488 disappearance or decline of the riparian vegetation, Tetraclinis and Fraxinus seems more 489 490 difficult to explain: does it depend on climatic factors, leading to the instability of the Ourika riverbanks and to conditions unfavorable for some forest species, such as Tetraclinis and 491 492 Fraxinus? Or on the development of certain crops which have taken the place of said species, for example by dedicating the Ourika riverbanks to olive cultivation? Or to the rise of other 493 practices that our approach cannot highlight, such as pastoralism, some species, such as 494 Fraxinus, being particularly affected by grazing? The data needs to be amplified before a 495 more solid hypothesis can be proposed. 496

Changes are also observed in agrohorticultural production, although not in terms of the 497 consumed/exploited diversity, since the spectrum remains broadly the same, although two 498 new taxa appeared: peach (Prunus persica) and common millet (Panicum miliaceum). It is 499 interesting to note that, until now, only sites in the north of Morocco have yielded millet, the 500 main medieval site in the south, Îgîlîz, having yielded another Panicoideae, sorghum (Ruas 501 2018). Another striking difference with the previous phase is the discovery in one of the 502 houses of cereal threshing by-products, composed of cereals (oat, probably Avena fatua, and 503 barley), mixed with rachis (barley, naked wheat) and numerous seeds of wild plants, mainly 504 505 grasses (see Appendix 1). This sample is the first indisputable evidence of local cereal production and processing within the ruralized city. Most of the weeds encountered in this 506 sample are winter therophytes growing on dry, clayey soils (i.e. Anthemis cotula, Avena fatua, 507 Lolium temulentum, Medicago polymorpha, Sherardia arvensis), which is consistent with the 508 509 immediate surroundings of the site.

510

511 Aghmat becomes a village (seventeenth-twentieth centuries)

512 This phase is the least understood for the site, due to the scarcity of excavated contexts. From 513 an archaeobotanical point of view, only one sample was studied, which yielded both charcoal 514 and seeds; for this reason, the proposed results are exploratory and need to be strengthened. It 515 should be noted, however, that this is the only modern/contemporary archaeobotanical sample 516 studied in Morocco to date.

In terms of tree vegetation, the trends observed during the previous phase seem to be 517 strengthening, with the proportion of olive trees increasing still (91% of the identified 518 charcoal fragments), and forest species decreasing further (less than 1% oak). Some species 519 appear to make a tentative comeback, particularly the riverbank species, perhaps as a result of 520 different management of this area. For the time being, the Aghmat Ourika riverbanks have 521 been preserved, and tree vegetation is fully developing. As far as agriculture is concerned, the 522 diversity is similar to that identified in the previous phases (barley, naked wheat, fig, date, 523 grapevine, and flax), but the sample does not allow us to ascertain the local nature of these 524 crops, apart from the fig and pomegranate trees, identified by charcoal fragments. Regarding 525 526 agricultural practices derived from stable isotopes, the small number of samples available for this period does not permit strong conclusions. The very similar  $\delta^{34}$ S values for naked wheat 527 (16.2 ‰) and barley (16.1 ‰) suggest these two cereals were probably grown in the same 528 region or on land in close proximity, and likely cultivated with higher levels of manure inputs 529 compared to the previous periods, as shown by the  $\delta^{15}N$ , especially for wheat (8.0 ± 1.4 ‰) in 530 comparison with barley (6.1  $\pm$  0.5 ‰).  $\Delta^{13}C$ , WUEi and the water input for naked wheat and 531 hulled barley (Fig. 8, 9, Appendix 1, 4, 5, 6) suggest these crops were generally moderately 532 watered. The mean nitrogen and carbon contents of the wheat and barley crops are the highest 533 compared to the previous periods in agreement with the increase of manure inputs all along 534 the three studied periods. 535

## 537 Conclusion

Our interdisciplinary pilot study makes it possible to establish for the first time the agricultural and forestry dynamics over the last millennium in this region that seem related to changes that are essentially socio-economic in nature, but may also be environmental. Although the exploited species appear to have remained relatively stable, their relative importance and frequency suggest a change in practices, which can no doubt be linked to changes in economic priorities when the settlement's status changed at the end of the Middle Ages. Environmental conditions would have favored regional or even local farming that did not necessarily require large-scale irrigation, at least not for cereal growing, the questionremaining open for fruit growing.

These various results represent the completion of a first stage of work, which is now 547 being continued in the form of a doctoral thesis (Badri ongoing). One of the medium-term 548 objectives is to strengthen the archaeobotanical approach by analyzing over a hundred new 549 samples from different sectors and phases of the site. Isotopic analysis will be further 550 developed by creating a current local reference base, including both cereals and fruit trees 551 (grapevine, olive), as they are key elements of the local agricultural system over the last 552 553 millennium. In addition, two cutting-edge approaches will be carried out on the remains of fruit trees. Firstly, a geometric morphometry approach will be applied to the archaeological 554 grape seeds and olive stones (Terral et al., 2004, 2010), with the aim of shedding light on the 555 varieties used and how they may have changed over time. Lastly, a quantitative eco-556 557 anatomical approach will be applied to olive trees charcoals (Terral 2000), to highlight any irrigation of this species over time. 558
